The public hearing in respect of the above project was held on 29.07.2022 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Jadumani Mahala, OAS(SAG), Additional District Magistrate (Revenue), Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Pabitra Swain, Representative of the mine explained about the proposed project and briefed about the Pollution Control measures to be adopted in the mine.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

1. Sri Partha Sarathi Nayak, Samana

Sri Nayak urged that Sand mine should operate for the benefits of the locals.

2. Sri Surendra Kandi, Godma

Sri Kandi informed that he attended the previous Public Hearing conducted in the locality few days back. He drew attention of the District Administration that the beneficiaries of Indira Awas & Pradhanmantri Awas Yojana of neighbouring Jajpur District getting Sand @ Rs 800/- where as they are getting it @ Rs 2000/- to 25000/- per trip in spite of the availability of sand in their locality. He requested the District Administration to start the sand mines for the benefits of the local public. He hoped that Sri Chinmaya will take all cares for protection of Environment & urged that the revenue to be generated from this sand mine & other mines of the locality is for the development of Hatadihi block & for whole Keonjhar District. He again requested the District administration for early starting up of the sand mines for the benefits of the public.

3. Sri Gauranga Rana, Hatadihi

Sri Rana informed that Public are not getting sand at affordable rate. He further informed that beneficiaries under Pradhan mantri Awas yojana are getting Rs 1,30,000/- for their house wher as they are paying high rate for sand for which they could not able to complete the construction of their building. While appreciating the Leesee he expressed his strong belief that there will be development of Roads & locality & also the protection of the Environment if sand mine will be operated by Sri Chinmaya Nayak. He also hoped that general public will be benefitted by this mine & appealed for cooperation.

4. Sri Maheswar Sahoo, Dimiria

The Regional Officer, SPCB, Keonjhar read over the issues raised by the public in the hearing. Sri JairamParida, Business Head of the mine responded to the issues raised. Sri Jadumani Mahala OAS (S), ADM (Revenue) Keonjhar gave concluding remarks of the Hearing.
