PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF GADA BEGUNIAPADA SAND QUARRY OF SRI TAPAN KUMAR RAY OVER AN AREA OF 5.06 HECTARE IN VILLAGE BEGUNIAPADA HELD AT BEGUNIAPADA PLAY GROUND NEAR MARKET BUILDING UNDER DELANG TAHASIL OF PURI DISTRICT

The Public Hearing meeting in respect of environmental impact assessment of Gada Beguniapada (Daya River) Sand Quarry of Sri Tapan Kumar Ray over an area of 5.06 hectare in village Beguniapada was held on 10.6.2022 at 11.00 AM at Beguniapada play ground near market building under Delang tahasil of Puri district, Odisha with reference to:

- EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.
- Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III, Dated.09/06/2021

At the outset, Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Bhubaneswar Regional Office on behalf of State Pollution Control Board, Odisha welcomed the guests, dignitaries, public and other members present in the meeting. The meeting was presided over by the Additional District Magistrate, Puri on behalf the District Administration.

Dr. Sohan Giri, being the Representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing as has been cited in the EIA Notification, 2006 and interim operational guidelines till date, along with Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III Dated. 09/06/2021 and the modalities to be followed for conducting the public hearing meeting in respect to sand mine project proposed by Sri Tapan Kumar Ray.

Welcoming the public, the Regional Officer, State Pollution Control Board, Odisha, Bhubaneswar, highlighted about the aim and objective of the public hearing and invited the views, comments/opinions from the local public w.r.t the environmental clearance of the

project. Then the Regional Officer requested to Sri Dillip Kumar Mohapatra, OAS (SAG), Additional District Magistrate, Puri to preside over the public hearing meeting.

In his presentation Sri Dillip Kumar Mohapatra, OAS (SAG), Additional District Magistrate, Puri presided over the meeting, highlighted the purpose of the meeting and the procedure to be maintained by the gatherings till completion of the public hearing.

Then, the Regional Officer invited the project proponent to put forth the details of the proposed project i.e. areas to be mined out, mining procedure to be followed, environment impact, restoration, peripheral development to be taken up for the benefit of local public. According Sri Sudhir Kumar Barik of M/s. Kalyani Laboratory, Bhubaneswar spoke on behalf of the Project Proponent Sri Tapan Kumar Ray. The project proponent put forth/highlighted the gathering about the possible environmental impact over the said area during entire mining activity period. He explained about the various aspects to be covered up during of the operation of proposed project i.e. benefits to be provided to the local daily labourers, peripheral development activities to be taken up etc. He had also invited the opinion and objection of the public present in the public hearing and had sought their co-operation for smooth implementation of the project.

After the completion of deliberation, Dr. Sohan Giri requested the public present at the meeting of the area to put forth their views, comments, objections and opinions etc. about the commencement of the proposed sand mining project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sukanta Mohapatra, Gada Beguniapada:

Sri Mohapatra informed that he was granted a house under Indira Awas Yojana, but had spent all the money. So he cannot complete the plaster of my house as the sand cost is too high to purchase from far off place. Also he said that if the sand quarry is given permission to operate here, the villagers will get the sand in cheap rate and can be easily availability for which they can be able to complete their house construction work easily.

2. Mrs. Jyostna Rani Das, Gada Beguniapada:

Mrs. Das informed that she is a member of Siddha Vairabi Group and agrees with the speech of the project proponent and support the proposed sand mining project and told that the said sand mining quarry should be allowed to operate.

3. Mrs. Krushna Routray, Gada Beguniapada:

Mrs. Routray highlighted in favour of the proposed sand mine and told that if the sand mining will operate there will be overall development of their village conditions and the people will also get other benefits as well as they will be able to get the sand easily.

4. Mrs. Subasini Parida, Gada Beguniapada:

Mrs. Parida informed that all of the villagers are happy and during operation of the sand quarry, they will get much more benefits. So, they all have congregated here and they favour the operation of the proposed sand mining project and also in favour of the Public Hearing.

5. Mrs. Nirupama Mishra, Gada Beguniapada:

Mrs. Mishra informed that the local people will be benefited due to the operation of the sand quarry and on whole people can be able to get sand for their house construction work easily. She also said if Tapan Babu, the project proponent operates this sand quarry, they will be very happy.

6. Mrs. Manjulata Patra, Gada Beguniapada:

Mrs. Patra informed that, the benefits and work Sri Tapan Babu, the project proponent had done for them for which they are all happy. So many people will get benefits and also poor people will be benefited. She had also highlighted that, when they purchase sand from Cuttack for their construction work, they are facing many problems. If the proposed sand quarry will be in operation in their nearby area they will be able to construct their buildings and also fulfil other developmental works can be completed early. Finally she spoke in support of the public hearing and also supported the sand mining to operate.

7. Mrs. Kanaka Parida, Gada Beguniapada:

She informed that all the development works done by the project proponent proved to be beneficial for everybody. In future all people will get benefit after opening the sand quarry. It was also been decided by all mothers, sisters and also their villagers to allow the sand quarry to be operated very soon.

8. Mrs. Bharati Behera, Village Secretary (Dalua Nuapada):

She informed that all the development works done by the project proponent proved to be beneficial and had requested everybody to favour the proposed mining project.

9. Sri Rabi Narayan Jena, Gada Beguniapada:

He informed that he being a villager of Gadabeguniapada knows the problems of their village and spoke in favour of the sand quarry. After commencement of the sand quarry all the people will get benefit. Poor people will be able to maintain their family and they will be able to get other benefits through the operation of the sand quarry.

10. Sri Raghunath Menta, Gada Beguniapada:

He requested all the people present at the meeting to co-operate to the project proponent for opening of the sand quarry.

11. Sri Pradip Kumar Patra, Gada Beguniapada:

Sri Patra informed that the people feel that the Public Hearing which is being held today for the sand quarry has no problem with respect to environment. So he requested the Collector Sir for grant of the environmental clearance for which they will get benefits from the sand quarry.

12. Mrs. Malika Behera, Tangi Sahi, Dalua Nuapada:

She informed that the earlier speakers have already has given their views in favour of running of proposed sand mining in this area and the local village people will also be benefitted and their village condition will improve.

13. Mrs. Basanti Sahoo, Block Chairman, Delang:

At the outset Mrs. Sahoo welcomed the dais and the gathering. She informed that the proposed sand quarry is fit for mining and if the sand mining will continue to operate all the developmental work of their area will be possible. She also said that if the Sand Quarry operates, poor people will get their bread and butter and can complete the incomplete construction of the houses in their Block. Since, they bring the sand from distance place, they are facing many problems. She highlighted that most of the people of every Panchayat had told her that they always faces many problems for purchasing sand from far distance places. So as a public representative she requested that if this sand quarry operates here, the people of this area will get benefits from the sand quarry as well as their surrounding environment can be also be taken care. Finally she requested the ADM Sir to please accord necessary permission in order to open this sand quarry as soon as possible.



14. Sri Dushmanta Tarai, Vice Chairman, Panchayat Samiti, Delang

He informed that out of five years of auction of the quarry two years has already been passed and rest three years remains for quarry operation. That is why he favours the Public Hearing. If the sand quarry opens here the whole of Puri District will be benefited. Due to of existence of Jatani Block on one side, Delanga Block on the other side, Kanasa Block, Satyabadi, Khordha area will also get benefits from the Sand Quarry. The Government will generate revenue from this quarry. He favoured the project and from the commitment from of Sri Tapan Babu, project proponent and the speech of villagers, there is no problem for opening this sand quarry.

About Forty-eight (48) numbers of representation letters were received from the public which were mostly in favour of operation of the sand quarry.

Then Dr. Sohan Giri requested the Tahasildar & Block Development Officer, Delangt to put forth his comments with respect to the sand quarry. The Tahasildar Sri Dillip Kumar Sarangi in his reply informed the public that sand is a vital requirement for all construction work in their block and if the same will be available locally then they do not have to depend for sand from Cuttack and Bhubaneswar. People will get sand in a cheap rate. So he asked the people present in the meeting to cooperate with the proposal and conditions which has been cited in the environmental management plan and proposal submitted by the project proponent.

After all the speakers deliberated their respective opinion and suggestion, the Regional Officer, SPCB, Odisha, Bhubaneswar asked the project proponent to give relevant reply with regards to the opinion and view of the speakers.

Sri Sudhir Kumar Barik from M/s. Kalyani Laboratory, BBSR on behalf of the Project Proponent assured that all the developmental work along with other work cited in the Environment Management plan will be undertaken in their area and will be done with due consultation with the local elected representative of the area. Care will be taken for restoration of the environment and there will be no harm to the local environment during running period of the project.


