**PROCEEDINGS OF THE PUBLIC HEARING MEETING CONDUCTED ON 24.08.2022 AT 11.00 AM AT MAA HINGULA YATRA PADIA, MAUZA- PURUSOTTAMPUR UNDER BHUBAN TAHASIL IN DHENKANAL DISTRICT IN RESPECT OF ENVIRONMENTAL ASSESSMENT OF PROJECT PROPOSED BY SRI TRIPURARI SAHOO FOR PURUSOTTAMPUR RIVER SAND BED OVER AN AREA OF 5.058 HA. IN VILLAGE PURUSOTTAMPUR UNDER BHUBAN TAHASIL OF DHENKANAL DISTRICT.**

Public hearing in respect of Environmental Assessment of Project proposed by Sri Tripurari Sahoo for Purusottampur River Sand Bed over an area of 5.058 Ha. in village Purusottampur under Bhuban Tahasil of Dhenkanal District.

Sri Udaya Kumar Mohapatra, Additional District Magistrate (Revenue), Dhenkanal District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcome the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental Assessment of Project proposed by Sri Tripurari Sahoo for Purusottampur River Sand Bed over an area of 5.058 Ha. in village Purusottampur under BhubanTahasil of Dhenkanal District.

Sri Suklambar Patra, Consultant and on behalf of Lessee of Purusottampur Sand Quarry of Dhenkanal District on behalf of the proponent addressed the committee members and assembled public and gave a brief description about the proposed project. He also briefed about Purusottampur River Sand Bed over an area of 5.058 Ha.



	<p>sand is highly necessary for all Government construction projects under Pradhanmantri Abas Yojanas and Indira Abas Yojanas. Villagers should get sand properly with reasonable / fixed price in respect to the inhouse construction works. He requested to the lessee that during the sand mining activity they should follow adequate pollution measures like tarpaulin covering of vehicle, speed restriction while movement through loaded vehicle, proper dust suppression measures by water sprinkling. He expressed that the lessee should start its mining activity as soon as possible. If this sand mining projects, the local villagers can able to get sand with a reasonable price. He finally told that he has no objection for sand mining but during sand mining process they should give proper attention for protection of nearby Temple connecting road protection. He expressed his views in support of the proposed sand mining project.</p>
02	<p>Sri Satyananda Prusty, Bhuban village</p> <p>He welcomed the gathering of the public hearing and also welcomed the proposed sand mining project. He expressed his happiness towards Purusottampur Sand mining project. He expressed that the proposed sand mining project will lead to development in the area and also for locals. He urged to the District Administration that with the proposed sand mining project the lessee shall provide sand to the villagers either minimum reasonable price or free of cost. He urged that while plying of sand loaded vehicles through this village road, they should provide local employment opportunity and should adopt tarpaulin covering of vehicle, proper dust suppression measures by water sprinkling. The lessee should maintain village roads.</p>
03	<p>Sri Purna Chandra Sahoo, Bhuban village</p> <p>He expressed that Suleipal sand Quarry and Purusottampur Sand quarry are situated adjacent to each other. During past time due to sand mining activity the nearby forest nursery has affected and he requested that in future the concerned lessee should give proper attention towards protection of forest nursery in all respect. 
**Observation:**

## NOTICE

**CAD-1163:** It is brought to the notice of all concerned Sri Tripurapuri Sahoo has proposed to have Environmental Assessment for Purusottampur River Sand Bed over an area of 5.058 ha. in village Purusottampur under Bhuban tehsil of Dhenkanal District to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site / sites of displacement / sites likely to be affected.

For the above purpose, a person will only mean:

- A. Any person who is likely to be affected by the grant of Environmental Clearance.
- B. Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
- C. Any association of persons whether incorporated or likely to be affected by the project and / or functioning in the field of environment.
- D. Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted on 24-08-2022 at 11.00 A.M at Maa Hingula Yatra Padia, Mouza- Purusottampur (khata No.84/35, Plot No.2335 Area Ac 1.02, KISSAM-PAIA) in Dhenkanal district.
