

PROCEEDINGS OF THE PUBLIC HEARING MEETING CONDUCTED ON 05.08.2022 AT 11.00 AM AT BASULEI CHOUPADHI PALA MANDAP (PLOT NO. 2149, KHATA NO. 418) IN DHENKANAL DISTRICT IN RESPECT OF ENVIRONMENTAL ASSESSMENT OF PROJECT PROPOSED BY THE TAHASILDAR PARJANG FOR BASULEI SAND QUARRY OVER AN AREA OF 20.24 HA IN BASULEI VILLAGE UNDER PARJANG TAHASIL OF DHENKANAL DISTRICT.

Public hearing in respect of Environmental Assessment of Project proposed by the Tahasildar Parjang for Basulei Sand Quarry over an area of 20.24 Ha. in Basulei village under Parjang Tahasil of Dhenkanal District.

Sri Udaya Kumar Mohapatra, Additional District Magistrate (Revenue), Dhenkanal District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcome the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental Assessment of Project proposed by the Tahasildar Parjang for Basulei Sand Quarry over an area of 20.24 Ha. in Basulei village under Parjang Tahasil of Dhenkanal District.

Sri Santosh Kumar Sahoo, Consultant and on behalf of Lessee of Basulei Sand Quarry of Dhenkanal District on behalf of the proponent addressed the committee members



and assembled public and gave a brief description about the proposed project. He also briefed about Basulei sand quarry over ML area of 20.24 Ha. At Village Basulei under Parjang Tahasil of Dhenkanal District with the peripheral development work that had been taken up in this area, and made a presentation about the environmental management, pollution control measures, solid waste-management of the related project. The copy of the statement of the industry read out at public hearing proceedings is enclosed.

Regarding public hearing of Basulei sand quarry over ML area of 20.24 Ha. At Village Basulei under Parjang Tahasil of Dhenkanal District was publicized at one English Daily newspaper and one Odia daily newspaper before one month. It was also publicized at the office notice Board of Basulei Gram Panchayat office, Tahasil Office Parjang, Zilla Parisad Office Kamakhyanagar, Block Chairman Office, Parjang and local villages of Basulei, Kulei etc. Public hearing also publicized through loud speaker at the Basulei village area.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Regional Office, Angul & representative of State Pollution Control Board Odisha then invited the public to present their views about the proposed project on environmental consideration.

The views expressed by various speakers are as follows:

01	Sri Bijay Kumar Pradhan, Basulei village
	He mentioned that this is this village is having only single road which connects from NH to Basulei village and upto village Brahmani River sand mining area. This single road is being used by villagers, school children and movement of sand loaded and unloaded trucks. He mentioned that about 30000 villagers are completely using this single road and during plying of vehicles on this road causes dust pollution and water pollution. So, he urged that while plying of sand loaded vehicles through this village road adjacent to Rengali main canal, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by



	water sprinkling. The lessee should maintain village roads. Finally, he told that if the Lessee fulfil and maintain the Government guideline in respect of pollution control measures and other village demands then he will not have any objection on Basulei village sand mining project over Brahmani river.
02	Sri Sushil Kumar Jena, Basulei village
	He welcomed the gathering of the public hearing and also welcomed the proposed sand mining project. He expressed his happiness towards Basulei Sand mining project. He mentioned that this Basulei sand quarry has been operating by the villagers since long time but this is the first time Government took over this sand quarry and conducting public hearing first time by following all types of Government notified guidelines. He expressed that the proposed sand mining project will lead to development in the area and also for locals. He urged to the District Administration that with the proposed sand mining project the lessee shall provide sand to the villagers either minimum reasonable price or free of cost. He urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads.
03	Sri Nityananda Rout, Basulei village
	He expressed that most of the villagers are not aware about the public hearing of Basulei village sand quarry. So he urged to conduct the public hearing in another date.
04	Sri BayuriBandhu Rout, Basulei village
	He expressed that he is basically a Social worker. He mentioned that yesterday evening Basulei villagers could able to know about the public hearing of Basulei sand mining project over Brahmani river. He pointed out that the approach road which is being used by the villagers was earlier constructed by Irrigation Department over Rengali main canal and later this road handed over to RD and

	subsequently the road is being maintained by PWD. So this is the only single road which is being used by the entire surrounding villagers. So, he urged that the Lessee should use a separate road for movement of sand loaded and unloaded vehicles. Finally he submitted a representation before the panel members which is annexed separately.
05	Sri Dusmanta Bhutia, Basulei village
	He expressed that about 5 to 6 days back he could about to know about the public hearing of their village sand mining quarry. He mentioned that before starting operation of sand mining project the Lessee should have a proper discussion with the Basulei village Suraksha Committee about various demands. He told that this village sand mining quarry has been operating since 40 years by the villagers for their village developmental works. He expressed that the lessee should start its mining activity as soon as possible. He demanded that local employment opportunity, engagement of local tractors shall be considered for sand mining activity. So, he urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by water sprinkling.
06	Sri Dibya Ranjan Routray, Basulei village
	He mentioned that this Basulei sand quarry has been operating by the villagers since long time but this is the first time Government took over this sand quarry and conducting public hearing first time by following all types of Government notified guidelines. He expressed that opening of sand mine in this area & production will lead to more development of surrounding villages and more employment generation of the area. He mentioned that this is the only single road which is being used by villagers, school children and movement of sand loaded and unloaded trucks. So, he urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School

	timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads. He expressed his views in support of the proposed sand mining project.
07	<p>Sri Banambar Bhutia, Basulei village</p> <p>He welcomed the gathering of the public hearing and also welcomed the proposed sand mining project. He finally requested to the District Administration to give necessary permission as soon as possible. He urged to the District Administration that during sand mining activity the mine proponent should follow the guideline in all respect and to ensure that sand mining is done in environmentally sustainable and socially responsible manner. He urged that while plying of sand loaded vehicles through this village road, they should adopt tarpaulin covering of vehicle, speed restriction while movement of School children during School timing, proper dust suppression measures by water sprinkling. The lessee should maintain village roads. Expecting better employment opportunity and further development activities in the periphery, she made a strong opinion in favour of the proposed sand mining project and requested to the Administration to issue Environmental Clearance against the proposed project.</p>
08	<p>Smt. Asanti Rout, Basulei village</p> <p>She expressed due to acute scarcity of sand inhouse village construction works are facing so many difficulties. She pointed out that the approach road which is being used by the villagers is being maintained by local villagers. This is the only single road which is being used by the entire surrounding villagers. So, she urged that the Lessee should use a separate road for movement of sand loaded and unloaded vehicles. She expressed that opening of sand mine in this area & production will lead to more development of surrounding villages and more employment generation of the area. Expecting better employment opportunity and further development activities in the periphery, she supported the proposed sand mining project and requested to the Administration to issue Environmental Clearance against the proposed project.</p>

Observation:

Generation of local employment opportunity, repair and maintenance of village road, supply of sand to the locals with reasonable price and adequate air and water pollution control, repair and maintenance of village roads, speed restriction during school timings, tarpaulin coverage on trucks and afforestation etc. were the most important issues emerged during the discussion.



It is brought to the notice of all concerned that **The Tahsildar, Parjang** has proposed to have Environmental Assessment for **Basulei Sand Quarry over an area of 20.24 Ha. at village Basulei under Parjang tehsil of Dhenkanal District** to obtain Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

- D. Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted on **05.08.2022 at 11.00 A.M at Basulei Choupadhi Pala Mandapa, Mouza-Basulei (Khata No. 418, Plot No. 2149, Kissam-Gramya Rasta, Area - Ac.0.11 in Dhenkanal district.**
