PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF DELANG SAND QUARRY (TIGIRIA, VANSAR AND BASUMUNDAL) OF THE TAHASILDAR, DELANG OVER AN AREA OF 14.63 HECTARE AT MOUZA TIGIRIA, VANSAR AND BASUMUNDAL UNDER DELANG TAHASIL HELD AT COMMUNITY HALL OF MELANA PADIA NEAR VANSAR BALIGHAT AT VANSAR UNDER DELANG TAHASIL OF PURI DISTRICT

The Public Hearing meeting in respect of environmental impact assessment of Delang Sand Quarry (Tigiria, Vansar and Basumundal) of the Tahasildar, Delang over an area of 14.63 hectare at mouza Tigiria, Vansar and Basumundal under Delang Tahasil held on 24.6.2022 at 11.00 am at Community Hall of Melana Padia near Vansar Balighat at Vansar under Delang Tahasil of Puri district, Odisha with reference to:

- 1. EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.
- 3. Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III, Dated.09/06/2021

The Panel consists of the following members:

- 1. Sri Dillip Kumar Mohapatra, OAS (SAG), Additional District Magistrate, Puri.
- 2. Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Odisha, Bhubaneswar

At the outset, Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Bhubaneswar Regional Office on behalf of State Pollution Control Board, Odisha welcomed the guests, dignitaries, public and other members present in the meeting. The meeting was presided over by the Additional District Magistrate, Puri on behalf the District Administration.

Dr. Sohan Giri, being the Representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing as has been cited in the EIA Notification, 2006 and interim operational guidelines till date, along with Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III Dated. 09/06/2021 and the modalities to be followed for conducting the public hearing meeting in respect to sand mine project proposed by Tahasildar, Delang.

Welcoming the public, the Regional Officer, State Pollution Control Board, Odisha, Bhubaneswar, highlighted about the aim and objective of the public hearing and invited the

views, comments/opinions from the local public w.r.t the environmental clearance of the project. Then the Regional Officer requested to Sri Dillip Kumar Mohapatra, OAS (SAG), Additional District Magistrate, Puri to preside over the public hearing meeting.

In his presentation Sri Dillip Kumar Mohapatra, OAS (SAG), Additional District Magistrate, Puri presided over the meeting, highlighted the purpose of the meeting and the procedure to be maintained by the gatherings till completion of the public hearing.

Then, the Regional Officer invited the project proponent to put forth the details of the proposed project i.e. areas to be mined out, mining procedure to be followed, environment impact, restoration, peripheral development to be taken up for the benefit of local public. The project proponent put forth/highlighted the gathering about the possible environmental impact over the said area during entire mining activity period. He explained about the various aspects to be covered up during of the operation of proposed project i.e. benefits to be provided to the local daily labourers, peripheral development activities to be taken up etc. He had also invited the opinion and objection of the public present in the public hearing and had sought their co-operation for smooth implementation of the project.

After the completion of deliberation, Dr. Sohan Giri requested the public present at the meeting of the area to put forth their views, comments, objections and opinions etc. about the commencement of the proposed sand mining project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sri Raghunath Das, Ex- Panchayat Samiti Member of Village Vansar:

Sri Das had supported the proposed sand mining project and highlighted that due to heavy deposition of sand in the river bed the lift irrigation points are not working properly, so after excavation of the sand from these above lease area the irrigation facilities can be provided the nearby agricultural fields which will benefit the farmers.

2. Manoj Pradhan, Tarada Village:

Mr. Pradhan highlighted that due to less excavation and heavy deposition of sand in the river bed the lift irrigation points are not working. So he suggested that in the condition if more sand excavation will be done then irrigation facilities can be provided to the irrigation land.

3. Mrs. Minakhi Pradhan, Tangi Vansar:

Mrs. Pradhan highlighted that if the sand excavation will be done then the flood water during monsoon will remain within the river bed and the nearby agriculture land can be saved from inundation of flood water and spoke that the project shall be undertaken quickly and they support the project.

4. Sri Taleswar Das, Vansar:

Sri Das emphasized that during flood the lift irrigation points are not working properly. Lift Irrigation points being covered with sand. In spite of digging the nearby areas of lift irrigation points the stream of water is not flowing properly in the river bed for which there is great loss to the agriculture. So sand quarry source should be allowed and excavation be done as soon as possible.

5. Sri Mahadev Routray, Vansar:

Mr. Routray informed that the proposed three site project areas there is huge deposits of sand. Due to in sufficient flow of river water the waste water of Gangua nallah is creating the river bed water pollution. So the source of sand mines should be operated.

6. Jasu Krishna Das, Vansar:

Sri Das had told that due to heavy deposit of sand within river bed the flood water is causing inundation in the river embankment during monsoon. So that lift irrigation points are not working properly, the agricultural practices are being hampered and damage. So the sand bed should be allowed to be operated.

7. Mrs. Reena Rani Routray, Vansar:

She highlighted that due to heavy deposit of soil the river water is not flowing properly for which the cultivated paddy fields are being damaged. So the sand mining should be operated without delay.

Then Dr. Sohan Giri requested the Tahasildar & Block Development Officer, Delang to put forth his comments with respect to the sand quarry. The Tahasildar, Sri Dillip Kumar Sarangi in his reply informed emphasized that during mining period attention will be given to environment protection in the nearby areas, rules/guideline will be followed during transportation of sand from river bed, green belt coverage will be done at the

nearby barren areas. Side by side developmental work will be taken up by the lessee at the nearby areas during the mining period.

After all the speakers deliberated their respective opinion and suggestion, the Regional Officer, SPCB, Odisha, Bhubaneswar asked the project proponent to give relevant reply with regards to the opinion and view of the speakers.

The lessee put forth his views before the public present in the Public Hearing that during the period of operation of the sand quarry the principle and guideline of the Government will be followed. Indira Awas beneficiaries will get the sand in cheap rate and local people should extend their hand and co-operate during that mining period.

At last the Regional Officer, SPCB, requested the chair to put forth the final comments and remarks about the public hearing before concluding the programme. Sri Dillip Kumar Mohapatra, Additional District Magistrate, Puri finally gave the concluding remarks and informed the gathering that the EIA & EMP have been done as per the direction and guideline of Ministry of Forest, Environment and Climate Change Department, Govt. of India. Accordingly all the guideline will be followed during transportation of sand by the vehicles from the sources, public hearing meeting has been recorded and will be sent to the government for taking final decision and gave vote of thanks to everybody for successful completion of the programme.

The public hearing meeting was concluded accordingly and the whole proceedings have been video recorded.
