PROCEEDINGS OF THE PUBLIC HEARING FOR GRANT OF ENVIRONMENTAL CLEARANCE FOR THE PROPOSED JUMKA PATHIRIPOSHI PAHAR IRON ORE BLOCK OF M/S. RUNGTA MINES LTD. FOR PRODUCTION OF 3.35 MTPA OF IRON ORE WITH TOTAL EXCAVATION — 3.98 MTPA (ROM IRON ORE: 3.35 MTPA + OVERBURDEN 0.63 MTPA) ALONG WITH 3X250 TPH MOBILE CRUSHING PLANT & 6X300 TPH MOBILE SCREENING PLANTS OVER THE MINE LEASE HOLD AREA OF 158.509 HA, AT: BATAGAON, & KENSARA VILLAGES UNDER LAHUNIPADA TAHASIL OF SUNDARGARH DISTRICT HELD ON DTD. 03.09.2022, AT 10.30 A.M. AT THE FOOTBALL PLAY GROUND AT: KENSARA VILLAGE OF BHUTUDA G.P. IN THE DISTRICT OF SUNDARGARH.

The public hearing of M/s. Rungta Mines Ltd. for grant of Environmental Clearance for the proposed Jumka Pathiriposhi Pahar Iron Ore Block for production of 3.35 MTPA of iron ore with total excavation — 3.98 MTPA (ROM Iron Ore: 3.35 MTPA + Overburden 0.63 MTPA) along with 3X250TPH Mobile Crushing Plant & 6X300TPH Mobile Screening Plants over the mine lease hold area of 158.509 Ha was held on dtd. 03.09.2022 at 10.30 A.M. at the football playground at Kensara village of Bhutuda G.P. in the district of Sundargarh. Out of total lease area of 158.509 ha, 147.803 ha is located in Sundergarh District and rest is in Keonjhar District. Sri Shiba Toppo, Additional District Magistrate, Sundargarh supervised and presided over the Public Hearing Process. Dr. Binod Bihari Dash, Senior Environmental Scientist and Regional Officer, State Pollution Control Board, Odisha, Rourkela delivered welcome address, organized and conducted the public hearing meeting in association with District Administration. During the course of Public Hearing, the guidelines for Covid-19 have been duly followed.

The Public Hearing in respect of the above proposed Jumka Pathiriposhi Pahar Iron Ore Block stated as per the schedule and the venue decided by the District Magistrate in accordance with the EIA Notification S.O.1533 (E) dated 14.09.2006 and subsequent amendment therein. The State Pollution Control Board, Odisha, Bhubaneswar had advertised in newspaper in Odia daily– Sambad on dtd. 30.07.2022 and in English daily- The Times of India on dtd. 31.07.2022. The Public Hearing meeting with regards to date, place and time was announced in public address system apart from its publication in local dailies. The attendance sheet of the public attended the public hearing is annexed as Annexure – I. Around 150 persons

had attended the public hearing meeting where as 60 persons had delivered their views whose list is annexed as Annexure II.

At the outset, Dr. Binod Bihari Dash, Regional Officer, State Pollution Control Board, Odisha, Rourkela welcomed the panel members and the public presented in the meeting. He briefly described the objectives and procedure followed for conducting the Public Hearing as per the EIA Notification S.O.1533 (E) dated 14.09.2006 of Ministry of Environment, Forest & Climate Change (MoEF & CC), Govt. of India. He also explained about the importance of such hearing for the proposed Jumka Pathiriposhi Pahar Iron Ore Block of M/s. Rungta Mines Ltd. over an area of 158.509 ha. for production of 3.35 MTPA of iron ore with total excavation – 3.98 MTPA (ROM Iron Ore: 3.34 MTPA + Overburden 0.63 MTPA) along with 3X250TPH Mobile Crushing Plant & 6X300TPH Mobile Screening Plants for grant of Environmental Clearance and also invited views, comments, objections & opinions of the public which are necessary while considering the environmental clearance of the project and he also told that those who want to give their written statement about the proposed projects, they can do so during the public hearing process. He requested Additional District Magistrate, Sundargarh to preside over the meeting.

Welcoming the public, the panel members, Press Media, Police Officers and the assembled public in the meeting, Sri Shiba Toppo, Additional District Magistrate, Sundargarh, briefly explained the about the purpose of the public hearing about the proposed Jumka Pathiriposhi Pahar Iron Ore Block of M/s. Rungta Mines Ltd., At: Kensara & Batagaon villages under Lahunipada Tahasil of Sundargarh District. He also described the importance of environmental impact studies carried out for the proposed Iron Ore Block and the views, comments, objections and opinions of the public are necessary while considering the Environmental Clearance of the project. He told that the project proponent will present the summary of environmental impact studies for the proposed project for the knowledge of the Public. He invited the villagers to present their views, opinions & objections about the proposed project on environmental consideration. He also told that the public can also submit written representations. The proceeding along with video recording of the meeting will be forwarded to the Government for further decision making process for grant of

Environmental Clearance. He requested the Regional Officer, SPCB, Odisha, Rourkela to carry out further proceeding of the meeting.

Regional Officer, SPCB, Odisha, Rourkela asked the representative of Project Proponent of M/s. Rungta Mines Ltd., to make a brief presentation before the public gathered in the meeting about the details of environmental impact assessment report of the proposed project in a simple summarized manner for better understanding of the Public.

On behalf of the Project Proponent, Shri Dillip Kumar Parida, Senior General Manager (Mining), M/s. Rungta Mines Ltd. welcomed the panel members, public and all other participants and gave a brief description about the Jumka Pathiriposhi Pahar Iron Ore Block of M/s. Rungta Mines Ltd. He expressed the details of proposed project which are as follows:

- The virgin iron ore block of Jumka Pathiriposhi Pahar Iron Ore Block located at Villages, Kensara and Batagaon has been awarded to M/s. Rungta Mines Limited as the highest bidder in the auction process conducted by the Government of Odisha. The Government of Odisha has issued Letter of Intent (LOI) for this Jumka Pathiriposhi Pahar Iron Ore Block vide letter no. 8716/SM dated 28.10.2021. The proposed mine measuring 158.509 hectares will be leased for a period of 50 years from the date of execution of the lease.
- The new proposed mine located in Tehsil Lahunipada, District, Sundargarh has proposed an annual production of 3.35 million tonnes of iron ore with a total mining capacity of 3.98 MTPA (including 0.63 million tonnes of Overburden) and will use mobile crossing plants and mobile screening plants for the same.
- Ministry of Environment Forests & Climate Change, Government of India has issued TOR for preparation of EIA/EMP report of the project vide their letter No. IA-J-11015/2/2022-IA-II(NCM) dated 18.02.2022. In this context, M/s. Min Mec Consultancy Pvt. Ltd. has been appointed for preparation of EIA/EMP report. The Indian Bureau of Mines has approved the proposed mining plan for preparation of 3.35 million tonnes of Iron Ore per annum vide letter No.MP/A/18-ORI-BHU/2021-22, dated 24.11.2021.

- Various programs for environmental management and development will be adopted if the proposed mine becomes operational. The emission noise and vibration will be controlled by plate tripod and control valve. Water will be sprinkled by tanks on Haul Road. Coir matting, plantation and grass seeding will be done for proper management of the dump. Retaining was, garland drain and settling tank will be provided at the lower part of the dump. Extensive plantation of trees will be done in other vacant areas of the proposed mine, green belt area.
- Remedial measures will be regularly tested and displayed for public viewing through electronic boards. Extensive planting of trees around mine lease will minimize sound wave penetration. Mine operations and tailings will be treated as per regulations by regulatory agencies.
- Air quality in this area is within acceptable limits and even if there is slight increase after commencement of mining activities, it will be kept within the permissible limits by proper management by the company. Other environmental management plans will be done as per the environmental impact assessment and environmental management plan of the appointed M/s. Min Mac Consultancy Pvt. Ltd.
- In this project, the local people will be given jobs directly and indirectly based on their merit. Provision will be made for free health care, ambulance and medicines, etc. For the improvement of education, construction of school houses, provision of toilets, etc., improvement of rural roads, development of sports and culture, and various programs will be introduced for the development of livelihood and animal resources. Programs will be made for social development along with education, health, and livelihood.

Then the Regional Officer, SPCB, Rourkela invited the public to register their names to put forth their views, suggestion, comments and objections on matters relating to environmental aspects of the project. Then the public deliberated on various issues one by one which are as follows

1. Sri Tura Dehury, Village Kemsera, Ward Member:

He expressed his support to the upcoming project and said that work will be done by cooperation of villagers of Batagaon & Kemsera.

2. Sri Rabindra Kumar Mishra, Village Tensa (BJD Secretary):

He demanded that, no disturbance should be made to natural nallah or river, plantation and ensure its survival, Local eligible candidate should appointed as teacher, Health care facility with ambulance Direct or indirect employment to local people as per their skill and qualification, Uneducated people should be given employment as per requirement, He appreciated the company for its earlier developmental works. He requested the gathering to extend support to the project. Finally he expressed his support in favour of the project.

3. Sri Desha Dehury, Village Kensara:

He demanded to provide employment to people of Batagaon & Kensera on priority basis. He assured that the company will run in cooperation with villagers of Batagaon & Kensera and requested the company to develop education & health facility in these villages.

4. Sri Suka Dehury, Village Batagaon:

First of all, he supported the project. He requested the company and the Govt. that mining activities should not affect the tribal people of the area and the river, nallah & forest are to be conserved. His other demands are employment to the local people as per their eligibility, educational qualification. He requested the company to take up developmental activities in cooperation with the village committee.

5. Sri Dasarath Dehury, Village Batagaon:

He requested the company to develop school, arrange school teacher, development of village road, provision of ambulance, drinking water facility, to develop a check dam to restrict flow of silt containing water to the village. Plant more trees then the number of trees to be felled, Provision of electricity to the village, provide employment to the local people in cooperation with village committee & adoption of Batagaon & Kensera village by the company. Finally he extended his support in favour of the project.



6. Sri Saheb Dehury, Village Kensera:

All the developmental work should be done in cooperation with the village committee & provision of employment to the local people on priority basis and provision of health and education facility.

7. Sri Rajan Dehury, Village Kensera:

He demanded that, all the developmental activities should be done in cooperation with the village committee first & employment to local people.

8. Sri Dukhu Dehury, Village Kensera:

He demanded that all the developmental work of the company should be done in cooperation with the village committee.

9. Sri Sushil Topno, Village Kensera:

He demanded employment for local people and support to SHG after commencement of mining operation.

10. Sri Siba Dehury, Village Kensera:

He expressed his support in favour of the project and requested the company to give employment to generation to come.

11. Sri Madhu Dehury, Village Batagaun:

He demanded to provide RoR in villages Batagaon & Kemsera since they have been living in this area for generations. He also demanded Control of silt containing water and fly rocks from mining so that it would not affect his village and provide employment to the adjoining villagers also. He finally extended his support to the project.

12. Sri Bagun Gagrai, Village Sasikala (M.P. Representative):

He expressed his happiness that the mines will be operational in their area and told that the local people will get educational facility and people of Bhutuda panchayat will be given employment by the company.

13. Sri Pradeep Dehury, Village Batagaon:

He expressed his dissatisfaction that his village has not been included under Swachha Bharat Abhijan and digital India Scheme. He told that they have been dependent on natural resources & forest produce for their livelihood, medicinal plant for health ailments, & should be given RoR. He demanded educational facility and all the developmental work should be done in

cooperation with and the company should run in a semi mechanized mode. He finally expressed his support in favour of the project.

14. Sri Bishaam Topno, Village Kensara:

He expressed his support in favour of the project.

15. Sri Sahu Dehury, Village Kensara:

He demanded to provide employment to local people on priority basis & pension to disabled old aged person of his village development of road.

16. Sri Ramay Horo, Village Sarkunda:

He firstly expressed his support in favour of the project on the fact that the mine will generate overall development of the Bhutuda Panchayat in particular and the State in general. He then requested the company to fulfill the basic necessity of the people like education by opening a school, health by provide an ambulance and a hospital, roads for transportation & provision of electricity & drinking water.

17. Sri Barik Dehury, Village Batagaon:

He requested the Govt. to include his village in Swacha Bharat Abhijan and Digital Odisha Scheme and requested the company to take up village development activity first. He raised his concern that they may be deprived of the natural resources and forest produce. He also demanded the action plan made in the palli sabha should be fulfilled and all developmental work should be done in cooperation with the village committee. He finally expressed his support in favour of the project,

18. Sri Dayoul Munda, Village Kensara:

He finally expressed his support in favour of the project & welcomed public hearing.

19. Sri Patoas Kachhap, Village Barsuan:

He first expressed his satisfaction about the past work of the company in developmental activities at Koira. He requested the company to give employment, and requested the District Administration to provide PDC rice at the village door step & engage local people on priority basis in cooperation with the village committee. He requested the company to facilitate some manual work. He then expressed his support to the project.

20. Sri Raya Dehury, Village Kensara:

He initially said that, they will be deprived of the medicinal plants & requested the company to give employment to local people on priority basis. He expressed that his village has many problem such as health, school and roads and requested the company should pay attention to these.

23. Smt. Sumitra Dehury, Village Kensara:

She requested the company that everybody should get a chance to work in the company for example if mother in law is not capable her daughter in law should get a chance. She finally expressed her support in favour of the project.

24. Sri Subhankar Biswas, Village Sarkunda:

He initially praised the company for its earlier developmental work & expressed her expectation that the company should continue the same in Bhutuda panchayat also. He demanded a dispensary in the village and finally expressed his wholehearted support in favour of the company.

25. Sri Prakash Dehury, Village Batagaon:

Firstly he expressed his support in favour of the project. He demanded a school bus and give priority to education.

26. Smt. Pramila Dehury, Village Kensara:

She demanded that all the developmental activities should be done in cooperation with the village committee & provision of a school & teacher and a hospital for her village.

27. Smt. Swapna Dahury, Village Kensara:

She demanded that, all the developmental activities should be done in cooperation with the villagers of Batagaon & Kensara. She finally expressed her support in favour of the project.

She expressed her expectation that the local people will get employment & their siblings will get good education. She finally expressed her support in favour of the project.

30. Smt. Sumitra Dehury, Village Kensara:

She requested all the developmental activities should be done with the cooperation with village committee.

31. Smt. Anita Kumbhar, Village Damalu:

She expressed her wholehearted support to the project.

32. Smt. Lilima Nag, Village Sasikala:

She expressed her wholehearted support to the project.

33. Smt Sabita Dehury, Village Batagaon:

She demanded an ambulance, support to the SHG Groups & provision of school teachers in Kensara & Batagaon village & livelihood project like chicken firming, goat farming etc. She finally expressed her support to the project.

34. Smt. Basanti Munda, Village Bhutuda, Sarpanch:

She first appreciated the company for its earlier developmental work. She expected that the company will facilitate education, health, road, electricity, drinking water, employment in her panchayat. She requested the company work for wildlife conservation, plantation of fruit bearing and medicinal plants outside ML area, 4G network and pension to old age people & adoption of Batagaon & Kensara village, priority to the villagers for developmental work. She finally expressed her support in favour of the project.

35. Sri Kasi Dehury, Village Kensara:

She told that they have been dependent on forest produce for their livelihood and requested the company to extend help to their SSG.

36. Smt. Kamali Dehury, Village Kensara:

She expressed her support. All the developmental work should be done in cooperation with village committee.

37. Smt Beronika Munda, Village Ranta:

She demanded priority in employment to Batagaon & Kensara villagers, Provision of ambulance, school & drinking water facility. She added that the financial status of the local people will improve after commencement of mining activity. She finally expressed her support in favour of the project.

38. Smt. Kasturi Dehury, Village Batagaon:

She requested the company to arrange for a DAV School or arrange free education, till permanent drinking water supply not provided, drinking water to be provided by water tanker. Till permanent electricity is not provided provision of DG set should be made. Concreting of village rood & adoption of Batagaon village. She finally expressed her support in favour of the project.

39. Smt. Pahantri Dehury, Village Kensara:

She told that, since they are dependent on forest produce, the company should help them in future.

40. Sri Budhu Dehury, Village Kensara:

He expressed his support for the project.

41. Sri Ramesh Pradhan, Village Batagaon:

He requested the company to contribute towards expenses of various rituals of the village & declare two days as holidays for each festival. He added that the company should be operated in semi mechanized mode.

42. Sri Gaipai Surin, Village Sarkunda:

He expressed his support for the project.

43. Sri Ganesh Patra, Village Lasi Sarkunda:

He appreciated the company for its earlier developmental work in other area & is optimistic that same kind of work will be done on the peripheral villages of the mine. Finally he expressed his support in favour of the project.

44. Sri. Faguna Dehuary, Village Batgaon:

He demanded that there should not be any hutting within the lease area and dust emission from the mine should be efficiently controlled.

45. Sri Ratha Dehury, Village Batagaon:

He expressed his full support in favour of the project.

46. Sri Shabar Giri, Village Batagaon:

He demanded that, the resolution and action plan passed in the Gram Sabha will be implemented within five years & finally expressed his support in favour of the project.

47. Sri Joseph Lomga, Village Ranta Ex Sarapancha:

He expressed his happiness that the project would give employment to the local people as per their eligibility who were otherwise remained unemployed throughout. He requested the company to provide educational facility, medical in Bhutuda panchayat, 4G tower & educational development in the area. He finally expressed his support in favour of the project.

48. Bishnu Charan Patra, Village Lasi Sarkunda:

He welcomed the Project as mining is the only source of livelihood in the area as the area is devoid of agricultural activities. He requested the company to implement the commitments made in the palli sabha and requested the district administration to improve the road condition from Bhutuda to Batagaon & Kensara. He finally expressed her wholehearted support in favour of the project.

49. Sri Laxman Mahakud, Village Dengula:

He welcomed the project and requested the company to provide employment to the local people, develop education, health, drinking water & transportation facilities in the area. He finally extended his support in favour of the project.

50. Sri Rama Naik, City Rourkela:

He requested the company to conduct door to door survey of villages (Batagaon & Kensara) and find out the problems in each household and take-up developmental program accordingly. He demanded more plantation than the number of trees to be felled. He then demanded school teachers for the school and finally extended his support in favour of the project.

51. Sri Pradumna Tripathy, City Bonai Secretary Biju Srama Samiti:

He expressed his happiness that, numbers of employment will be generated by opening of the mine and the various connecting industries in the state. He requested the administration to facilitate educated youth to take up vocational education in various technical institutions nearby and then employ them in the mine. The state exchequer will get a sizable fund from the different mines of the area. He requested environmental protection by the mines & requested the CSR department of the mines to mingle with the villagers with their problems and solutions. He finally extended his support in favour of the project.

52. Smt. Gayatri Dehury, Village Kensara:

She told that they were dependent on forest produce and agriculture and uncertain about its continuity and requested the company to provide work to them.

53. Sri Gambhari Dehury, Village Kensara:

She expressed that all the activities should be done in cooperation with the village committee & support to SHG group.

54. Sri Madhusudon Nayak, Village Sasikala (Ex Sarpanch):

He first appreciated the company's previous developmental work and said that the company was doing good work without association with any village committee so the villagers should support opening of the mine without any interferences of any committee. He expressed that healthcare facility should be given priority and requested participatory environmental protection by the villagers and by the company.

55. Sri Ranjit Kisan, City Bonai:

He first appreciated the company's previous developmental work and requested to provide basic amenities such as food cloth and shelter. He requested the gatherings to support the proposed project.

56. Sri Sudarmini Pradhan, Bonai:

He said that he is optimistic about the fact that the company will develop educational facility road, health, ambulance & school bus and requested the

company to fulfill the demands made by the previous speakers. He asked the gatherings to support the proposed project.

57. Sri Prasana Kumar Nayak, Barsuan:

He stated that the project area is a tribal dominated area and after long waiting there will be influx of development for the tribal people. He requested the company to develop educational facility, healthcare facility by providing one ambulance, employment & transportation facility by giving priority to three villages of Batagaon, Kensera, and Kadakal & supported the views of previous speakers on participatory environment management. He requested the company to conserve water resources of the area. He requested the administration to take up developmental activities in Buutuda panchayat from the DMF fund also. He finally extended his support in favour of the project.

58. Smt. Julian Kandir, Lahunipada:

She expressed that the demands of the previous speakers would be fulfilled & categorically requested the company to arrange for an ambulance & for a PDC teacher.

59. Sri Santanu Kerketta, Randa:

He first expressed that the company should act in reducing the pollution level such as silt laden surface runoff from the mine, control of fugitive dust, plant more trees then it is felled. He requested the company to make provision of manual labor and provide vocational education to the youth so that they would be eligible to work in the company in future. He told that the development of the area should be done by the CSR team as well as the DMF fund of Govt. He requested the company to make provision for old age pension, widow pension & girls education. Finally he requested the company to extend their support to reduce malnutrition in children. He finally extended his support in favour of the project.

60. Sri Abhishek Patra, Bhutuda:

He stated that the company will definitely provide the basic amenities as demanded by previous speakers and categorically requested the company to work in the direction of prevention of drug addiction.

Basis

During the public hearing, all have been given an opportunity to express their views freely on the proposed project. The video recording of the entire proceedings of the public hearing was done and is annexed herewith. About 16 nos.of written representations were received which are enclosed as Annexure III and 60 nos. of persons had delivered their views. After the deliberations were made by the public, Regional Officer, State Pollution Control Board, Odisha, Rourkela summarized on the issues raised by the public and invited the project proponent to submit their response & commitments on the issues raised by the public. The summary of the views and opinions of the public and the commitments made by the project proponent are annexed in Odia language and English language as Annexure A & B respectively which were read before the audience in Odia language in public hearing meeting. Finally the meeting ended with vote of thanks to the chair, public and other participants.
