PROCEEDINGS OF THE PUBLIC HEARING HELD ON 07.09.2022 (AT 10.30 AM) AT GROUND NEAR BIJU PATTANAYAK SMRUTI BIDYAPITHA, PATENIGAON WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR MUNDILO-PATENIGAON DEVI RIVER SAND QUARRY OVERAN 6.42HA. AREA (TOTAL CLUSTER AREA-27.263 HA.) IN VILLAGE MUNDILO-PATENIGAON UNDER JAGATSINGHPUR TAHASIL OF JAGATSINGHPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by Sri Sushil Kumar Mohanty for Devi River Sand Quarry over an area of 06.42 Ha. (Total cluster area is 27.263 Ha.) Under Jagatsinghpur Tahasil of Jagatsinghpur district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

The Panel consisted of the following members:

2. Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, Odisha

Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur, supervised & presided over the public hearing process which was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Paradeep, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by Sri Sushil Kumar Mohanty.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Shri Deba Prasad Choudhry of P & M Solution, Noida (Consultant) addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management,

pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. **Ms. Jyotsnamayee Parida, Sarpanch Patenigaon G.P:**

She supported operation of the sand quarry and told that people will be benefitted from this project and availability of sand in the area will be easier.

2. **Ms. Rajashree Mohanty, Panchyat Samiti Member, Patenigaon:**

She supported operation of the sand quarry and told that people will be benefitted from this project .

3. **Rabinarayan Bhoi, Patenigaon:**

Supporting the project he told that during transportation there should be tarpaulin covering on sand loaded vehicles to prevent the sand dust being air borne.

4. **Shri Bijay Kumar Bhoi, Patenigaon:**

Supporting the project he told that people will be benefitted if the sand mine operates.

5. **Shri Manoranjan Sahoo, Patenigaon:**

While supporting the proposed project, he requested for covering of sand loaded vehicles by tarpaulin during transportation and plying of heavy vehicles used in the mining operation and transportation at a regulated and slower speed.

6. **Shri Dambarudhar Das, Urali:**

He supported the project and told that people will be benefitted from this project.

7. **Shri Bibhuti Bhusan Jha, Urali:**

He supported the project and told that people will be benefitted from this sand quarry operation project and availability of sand in the area will be easier.

8. **Shri Suryamani Jena, Patenigaon:**

Supporting the sand mining project, he told that people will be benefitted from this project.

9. **Shri Sudhir Rout, Patenigaon:**

Supporting the project, he emphasized on covering of sand loaded vehicles by tarpaulin during transportation and loading of sand in those vehicles as per load bearing capacity of the road. Rendering his support for the project he said that general public should not be harmed due to the project activities.

10. **Shri Surendra Swain, Tarada:**

While supporting the proposed project he told that people will be benefitted and there will be development in the Gram Panchayat. He mentioned some significant points that should be taken care off. The points included repair of damaged road due to transporting vehicles, covering of sand loaded vehicles during transportation, prevention of road accident due to spillage of sand from overloaded vehicles. He also stated that care should be taken for protection of river embankment and plying of transportation vehicles in a regulated speed within permissible limit.

11. **Shri Ashok Kumar Sahoo Nakulanga:**

He said that sand is required for local people. Operation of sand mine should be in such a manner that rich, poor and all segment of people of the society will be benefitted with appropriate price of sand.

12. **Shri Ananda Kumar Jena, Biana:**

He said that people will be benefitted from the project and requested for covering of sand loaded transportation vehicles by tarpaulin and water sprinkling on transport roads.

13. **Shri Binod Kumar Mohanty, Nakulanga:**

He supported the project and said that there will be no air pollution if sand loaded vehicles get covered with tarpaulin.

The Panel did not receive any written representations of the local people demanding different facilities in the locality during the hearing.

Observation:


The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur ratified the minutes of meetings with the views and demands of public. She extended her vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.


