PROCEEDINGS OF THE PUBLIC HEARING HELD ON 16.09.2022 (AT 10.30 AM) AT DHANA KHALA NEAR PANCHYATRAJ HIGH SCHOOL, ERADA WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR ERADA DEVI RIVER SAND QUARRY OVER ML AREA OF 6.070 HA. OVER PLOT NO. 969(P) IN VILLAGE ERADA UNDER NAUGAON TAHASIL OF JAGATSINGHPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by Tahasildar Naugaon for Erada Devi River Sand Quarry over an area of 06.070 Ha. over plot no.969(P) under Naugaon Tahasil of Jagatsinghpur district was held on scheduled date and time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

The Panel consisted of the following members:

Shri Sachidananda Sahoo, Additional District Magistrate, Jagatsinghpur, supervised & presided over the public hearing process which was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Paradeep, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by the Tahasildar Naugaon.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be under taken for better awareness of the public. On behalf of the Project Proponent, Shri Goutam Sahoo (Consultant) from M/s VVN Technology Pvt. Ltd., Hyderabad addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. **ShriPradeepta Kumar Swain, Erada:**

He said that Erada village under Galadari GP is remotely located at the south of Devi River. After many persuasions the bridge was constructed between connecting Pahanga and Erada. There are five sand mines at the close proximity of these area for which road have been damaged due to transportation of heavy vehicles. He said that he is not opposing the sand quarry, rather demanded for better approach roads to the village. Showing his concern for the damaged road conditions he said that operation of sand quarry and thereby movement of vehicles will cause problem for movement of public. Supporting the sand mine project conditionally he demanded for better standard road of approximately 4.5 KM at both sides of Debidola bridge in Galadari G.P and good approach road to village Erada.

2. **Sri Dilip Kumar Nayak, Sarpanch, Galadari G.P:**

While supporting the sand mine project, he raised his concern about apprehended road accident due to plying of heavy vehicles in the damaged road and demanded repair of damaged roads mentioned by previous speaker Shri Pradeepta Kumar Swain.

3. **Shri Laxmidhar Bastia, Erada:**

Though he supported the project, he questioned about the benefit gained by Erada People due to operation of multiple number of sand quarry in the periphery, which contribute towards revenue of state to a significant extent. He requested for concreting of Pahanga-Tihidi Road.

4. **Shri Pravat Kumar Swain, Erada:**

He supported the public hearing process and the proposed project. He agreed with the previous speaker in context with damaged road condition, repair and construction of road. He emphasized that Govt. should focus on Galadari G.P as a significant extent of state revenue is generated from this area. He questioned that who will ensure activities for environmental management and expenditure towards it as per Environmental Management Plan like plantation, water sprinkling etc. Supporting the project he primarily demanded for repair of road, water sprinkling, plantation at nearby area.

5. **Shri Dambarudhar Bastia, Erada:**

He supported the project and said that there will not be black marketing of sand anymore and there will be available of sand at cheaper price. He questioned about utilization of CSR fund of last five years, planning of expenditure of CSR fund allocated. He also questioned about steps taken for abatement of environmental pollution and requested for plantation through village club.

The Panel did not receive any written representations of the local people demanding different facilities in the locality during the hearing.

Observation:

The overall opinion of the public about the proposed project was supportive. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep and representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Shri Sachidananda Sahoo, Additional District Magistrate, Jagatsinghpur ratified the minutes of meetings with the views and demands of public. He extended his vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.
