PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR KHARIDA SAND BED OF SRI KIRAN KUMAR PANDA OVER THE MINING LEASE AREA OF 5.261 HA FOR PRODUCTION OF ORDINARY SAND: 15,501 CUM/ANNUM AT KHARIDA VILLAGE, HINJILICUT TAHASIL OF DISTRICT GANJAM, HELD ON 09.09.2022 AT 11.00 AM OVER PLOT NO. 4728, KHATA NO. 555, AT- DEBASTALI, SRI MAA KUREISUNI THAKURANI HATA IN VILLAGE KHARIDA UNDER HINJILICUT TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Sri Kiran Kumar Panda has proposed to have Environmental Impact Assessment for Kharida Sand Bed over mining lease area of 5.261 ha. for production of Ordinary Sand @ 15,501 cum/Annum in Kharida village, Hinjilicut Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Samaja" dated 05.08.2022 and an English Daily "The Times of India" dated 05.08.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Kharida Gram Panchayat, Ralaba Gram Panchayat, Sikiri Gram Panchayat, Executive Officer, Hinjilicut Municipality and the Block Development Office, Hinjilicut, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Sri Kiran Kumar Panda, Project Proponent of Kharida Sand Bed to brief about the project.

Sri Kiran Kumar Panda, Project Proponent of Kharida Sand Bed, presented the salient features of the proposed Kharida Sand Bed, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Addl. The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S, Addl. District Magistrate (Rev), Ganjam with the views and concerns of the deliberators. 
