7020, KHATA NO. 1690 WHICH IS ADJACENT TO GRAM PANCHAYAT OFFICE,
JAKARA UNDER POLASARA TAHASIL OF GANJAM DISTRICT**


At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Sri Sarathi Swain has proposed to have Environmental Impact Assessment for mining lease area of 13.594 ha. for production of Construction Stone @ 3240 cum/Annum at Jakara village, Polasara Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily “The Sambad” dated 05.08.2022 and an English Daily “The Times of India” dated 05.08.2022 regarding the venue, date and time of the public hearing along with the places of availability of Executive Summaries (Odia & English) of Environmental Impact Assessment (EIA) report in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Jakara Gram Panchayat, Kalamba Gram Panchayat and Block Development Office, Polasara in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S. to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponent of M/s. Jakara Stone Quarry to brief about the project.

Sri Sarathi Swain, Project Proponent of M/s. Jakara Stone Quarry presented the salient features of the proposed project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 50 persons were present in the public hearing meeting and among them only 43 nos. of persons signed in the attendance sheet. 13 persons signed for oral deliberation sheet and expressed their views. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri Kailash Chandra Nahak, At/PO- Jakara, Polasara

He demanded that drilling, blasting and transportation should not be carried out during night hours. All the mining activities including transportation shall only be carried out during day hours.

2. Sri Minaketan Pradhan, At- Kalamba, Polasara

He stated that operation of this stone quarry will lead to easy availability of construction materials and this will also create employment opportunity.

3. Sri Rabi Narayan Sahu, At- Khanduru, Polasara

He stated that due to operation of this stone quarry local poor villagers will get employment opportunity.

4. Sri Kalu Charan Pradhan, At- Kalamba, Polasara

He stated that since last 38 years local villagers were getting livelihood from this stone quarry and he is hopeful that the present lessee will also engage them during operation of this quarry.

5. Rashmita Nayak, At- Jakara, Polasara

She stated that the quarry operation shall only be carried out during day hours and requested for local employment.

6. Subasini Sahu, At- Jakara, Polasara

She has no objection for operation of this quarry. However, she requested to undertake control blasting to avoid damages of nearby houses.

7. Sri Prahallad Sahu, At-Kalamba, Polasara.


He stated that due to non-operation of this quarry local development works were getting delayed and he further added that after operation of this quarry local people will be benefited.

8. Sri Narayan Pradhan, At-Kalamba, Polasara.

He stated that inhabitants of Jakara and Kalamba Panchayat will be benefited by operation of this quarry. He further requested for local employment.

9. Sri Rabindra Nath Barik, At- Jakara, Polasara

He stated that the lessee shall undertake development work at Jakara and Kalamba G.P., dust pollution shall be controlled and local employment shall be on top priority.

10. Sri Srikant Mohanty, At-Jakara, Polasara

He stated that the lessee shall operate this quarry by abiding Government Rules and local vehicles shall be engaged in mining work.

11. Papini Jena, At-Nuasahi, Jakara, Polasara

She stated that the lessee shall operate this quarry by abiding Government Rules without any difficulty of local villagers and undertake local development works.

12. Sri Gajendra Swain, At-Jakara, Polasara

He welcomed this proposal for overall development. He further requested to undertake mining by concurrent back filling of mined out area with over burden along with plantation over it for sustainable mining.

13. Sri Nabaghana Pradhan, At-Jakara, Polasara


He stated that steps taken by the Government for operation of this quarry is praiseworthy as this will prohibit illegal mining. Further he requested to undertake plantation for environment protection, local employment and local development.

Further the Addl. District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Jakara Stone Quarry to address the issues raised by the local public. Sri Sarathi Swain, Project Proponent addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S. Addl. District Magistrate, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.



NOTICE

It is brought to the notice of all concerned that Sri Sarathi Swain has proposed to have Environmental Assessment for Jakar Stone Quarry over an area of 13.594 ha. at village Jakar under Polasara Tehsil of Ganjam District to obtain Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.

For the above purpose, a person will only mean:

- Any person who is likely to be affected by the grant of Environmental Clearance.
- Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
