

PROCEEDINGS OF THE PUBLIC HEARING OF PARSURAMPUR DECORATIVE STONE MINES OF SRI K. SAPTAGIRI FOR PRODUCTION OF 24,992 CUM / ANNUM OF ROCK (6,248 CUM/ANNUM OF MARKETABLE ROCK DECORATIVE STONE & 18,744 CUM/ANNUM OF WASTE) OVER AN AREA OF 10.513 HA IN VILLAGE PARSURAMPUR, PARALAKHEMUNDI TAHASIL IN THE DISTRICT OF GAJAPATI HELD ON 18.10.2022 AT 11.00 A.M. IN THE COMMUNITY HALL OF PUDUNI NEAR PARSURAMPUR VILLAGE OF PARALAKHEMUNDI TAHASIL OF GAJAPATI DISTRICT

The public hearing in respect of the above project was held on 18.10.2022 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in Parsurampur village of Paralakhemundi area of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Sri Hemendra Nath Nayak, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Pradeep Kumar Nayak, OAS (S), Additional District Magistrate (Revenue), Gajapati highlighted on importance of such hearing & presided over the public hearing.

Project Consultant of Parsurampur Decorative Stone Mines of Sri K. Saptagiri has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

1. Sri S. Lingaraju (Village- Puduni)

Sri Lingaraju told that "The project proponent should be informed villagers about the facilities to be provided to the villagers who are affected by the quarry operation. Which type of employment will be provided by the project proponent to the villagers residing near by the quarry".

2. Sri Dharma Rao Sabar, (vill- Parsurampur)

Sri Sabar told that "We are glad that Govt. Officers and Sarpanch have to come to our village. I want to say something about our villagers, actually our village is known as by two name those are Parsurampur and Dr. Banjari. We are living by cultivating, tur dal, cashew, arhar dal and vegetables. The Sarpanch informed us that Govt. is going to mining of this mountain. We the villagers expect some facilities like employment, we residence, do not have house patta also. So these should be provided. We belong to poor uneducated Scheduled Tribe people. We villagers want to read but we don't have residence certificate as well as caste certificate".

3. Sri Chitti Sabar (Village- Dr. Banjari)

Sri Sabar told that "We are facing problem to avail Govt. facilities because our village is known by two names i.e. Dr. Banjari under parsurampur mouza, The project proponent assured that development works will be done for the village. Now we want to know from the project proponent



that what type of facilities will be provided? Construction of our village road could not be possible because it is known as Parsurampur instead of Dr. Banjari. We iterate, that our village should be known by one name instead of two. We are facing problems for higher studies due to lack of residence as well as caste certificate. We want that our village should be shown in revenue map. We want assurance from project proponent that our village will be protected during mining of this mountain. We want employment in this mining project”.

4. Sri Jema Sabar (Vill- Parsurampur)

Sri Sabar told that “The project proponent has got order from Central Govt. so also State Govt. for mining this mountain. The villagers want to know whether this quarry will develop the village or destroy. We are cultivating cashew, tur dal and moong dal which are exported to nearby cities and we are living with this. By mining this quarry these cultivation will be destroyed. The villagers are demanding agriculture field to cultivate these crops. Due to mining of this quarry they want to know that where their domestic animals to go for grazing. Our children are facing problems for an emission into school and colleges due to lack of residence and caste certificate. This village is located near the District Head Quarter but we do not have proper road facilities. We want rehabilitation. Mining should be done after providing all facilities”.

5. Sri K. Suryom (Village- Dr.Banjari)


Sri Suryom told that “Most of the children of our village, can not read after 10th class. They should be given employment in this mining project. Water sprinkling should be done near mining area and so also the transportation road”.





5	Road maintenance & development	Maintenance of the road will be done with providing a fund for maintenance and repair.
6	Providing security personnel in the mines	During transportation of rocks some local youths will be deployed for security purpose to avoid accidents
7	Provision of medical facilities	Health camps will be done and free medicines will be supplied to the villagers.
8	Provision of an embankment between the village and the mine	We will construct a barrier by soil in between the village and the mountain which is to be excavated.

10	Development of a volley-ball court	We will develop a volley-ball court in the field exiting near the Parsurampur Village.
11	facilitating the children for higher studies	We will facilitate the children of the village for higher studies in consultation with villagers.
12	Development of a community hall	The exiting community hall is not sufficient for the villagers, if land will be provided then we will construct and maintain a well developing community hall.
