PROCEEDINGS OF THE PUBLIC HEARING FOR GREENFIELD PROJECT OF M/S UTKAL ENVIROCARE FOR INSTALLATION OF COMMON BIO-MEDICAL WASTE TREATMENT FACILITY AT KHATA NO. 81/17, PLOT NO. 15 IN VILLAGE BALIBAD UNDER SORO TAHASIL OF BALASORE DISTRICT HELD ON 12.10.2022 AT 10.30 A.M. IN NUAPUR-DAHIPUR MELAN PODIA UNDER SORO TAHASIL, DISTBALASORE

The public hearing in respect of the above project was held on 12.10.2022 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The awareness with regard to date, place and time of public hearing was done to the people of surrounding villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er M. M. Murmu, Regional Officer, State Pollution Control Board, Odisha, Balasore welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Nilu Mohapatra, OAS (S), Additional District Magistrate, Balasore highlighted importance of such hearing & presided over the public hearing.

Sri Sandeep Kumar Bera, Manager of M/S Utkal Envirocare explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Balasore.

1. Sri Biswaranjan Jena, Manatri, Soro

Sri Jena enquired about the organiser of the meeting and about the project. He also questioned on decision taken for the project, smell generation, local employment opportunity and adoption of technology and processing of Bio-medical wastes or any other wastes. The query of Sri Jena was also replied by the chairperson & Regional Officer.

2. Sri Narendra Kumar Biswal, Sarpanch, Kesharipur GP

Sri Biswal requested to explain the reason of conducting such meeting. He expressed that, people have misconception on this project. He intended to know about the distance criteria for the project as villages are near to the project site and requested to take action for any problems caused by the project.

3. Smt. Atasi Mahapatra, Champu, Soro

Smt. Mahapatra argued that, awareness to the public was not done for conducting such Public hearing. She expressed that, she has taken own attempt to aware the people regarding the project. She also expressed that, Methane gas may be generated due to reprocessing of Bio-medical wastes and regarding this the project

proponent has suppressed. She has no objection for the project, if Methane gas is not generated, because proponent has 5 acre of land and can construct boundary wall around the unit.

Participants also apprehended on emission of Methane gas and doubt cleared by the Chairperson and Project proponent.

4. Sri Narendra Malik, Dahipur, Soro

Sri Malik expressed that, they are living near the project site and protested the project.

5. Sri Muralidhar Behera, Balibad, Soro

Sri Behera expressed that, they are not aware about the project. He suggested for consultation of local people for the project as they have residential houses near to the project site. He also apprehended about the channel for discharge of wastewater from the project.

6. Sri Kamalakar Giri, Nuapur, Soro

Sri Giri expressed that, his house is at about 205 meter away from the proposed Biomedical processing unit. He suggested establishing the project near the hill and not near the human habitation.

7. Sri Sanjay Kumar Rout, Manatri, Soro

Sri Rout enquired about the incoming of Wastes for treatment at the project site and sought reply in this regard. Lastly, he welcomed the project.

Again Sri Biswaranjan Jena explained about the chemical formula of Methane responding the speech of previous participants. He also explained about the Problem in the Prawn processing unit due to gas leakage and clarified that, problem on emission of Methane gas from this project is separate matter. He further, given the example of projects implemented for Swachha Bharat Mission, even in near the Sea beach and human settlement, the project areas are neat and clean. Further, he requested to clarify the Policy of Project and suggested for installation of better technology, So, that they will accept the project.

8. Miss Bandita Panda, Manatri, Soro

Miss Panda requested the participants to come forward and say something without uttering loud voice from the backside. She requested the participants to understand about the project. She also told that, Pollution Control Board has some criteria to establish the Project and if required, they may restrict it.

Again Smt. Atasi Mahapatra told that, people of Manatri Panchayat are simple and poor and they have small patch of land along the road side. She requested to explain the people, about the project and said that, they are not interested to protest from the beginning. She further told that, they have small patch of land and have human habitation. So, she protests the project as her house is not more 500 meter away from the project site and lands of people are also adjacent to the human habitation.

9. Sri Dillip Kumar Pradhan, Dahipur, Soro.

Sri Pradhan told about the scarcity of drinking water and available below 95 ft to 100 ft from the surface.

10. Sri Kiran Kumar Panda, Manateri, Soro

Sri Panda expressed that; manure can be produced from the Bio-medical wastes as others are doing from the other Solid wastes by composting. Further, he gave the example of distance criteria for poultry farm and supported the project, if it is fulfilling the criteria.

11. Sri Prabhakar Behera, Manatri, Soro

Sri Behera expressed such type of projects have been set up in different areas, although the human habitation is matter of concern. He also supported the project with opinion that, the proper management shall be taken by the project proponent without affecting local people and adopting the system recommended by the Government.

12. Sri Janmejay Behera, Manatri, Soro

Sri Behera expressed his happiness on providing the job opportunity for the unskilled locals. He told that, local educated youths are going to Surat and Gujarat in search of jobs, but he prefers to do the job in local if available. Further, he gave the example of waste reprocessing unit at the Acharya Vihar and Rasulgarh of Bhubaneswar where human habitations, Educational institutions and commercial shops are very near and opined that, Govt. may allow this project as per the schedule and rules as prescribed for the other project.

Again, Miss Bandita Panda informed that, Bio-medical Waste Treatment Plant can be established in industrial area and other area at 500 meter away from human habitation as per Central Pollution Control Board norms. Further, she expressed that; unit can be set up by way of taking precaution and convincing the Government near the human habitation area.

13. Smt. Rashmita Malik, Dahipur, Soro

Smt Malik informed that, they protest the project because; it is near to the human settlement.

The videography of Smt Malik was disrupted due to disturbance caused by the public.

14. Smt. Jamuna Malik, Dahipur, Soro

Smt. Mallik protested the project and requested, the project should be away from the human habitation.

The videography of Smt. Malik was disrupted due to disturbance caused by the public.

15. Sri Satyananda Behera, Manatri, Soro

Sri Sahu expressed that, people need water, Air and food for survival, but being deteriorated. He further told that, people cutting down the trees, but the project has proposed to plant in 33% of areas. He also added, air pollution caused by burning of straw after harvesting of Paddy even also Odisha not only Punjab and Haryana and environment deteriorated. He reiterated, Methane gas may be generated from the project. He further, expressed that, some people will get directly and indirectly employment and supported the project.

16. Sri Sudam Samal, Manatri, Soro

Sri Samal hoped that, local people will get employment in the project. He suggested for installation of High technology devices to control the gas emission for which it will be good for the project and public.

17. Sri Nityananda Behera, Manatri, Soro

Sri Behera expressed his experience in controlling of Gas in Ispat alloys Plant. He also informed about welfare steps taken by the unit for the locals. Further, he informed that, reutilization of wastage can be used for beneficial purpose. He opined that, Project may be set up as per the Government norms.

18. Sri Bhanu Malik, Balibad, Soro

Sri Malik expressed that, they do not want any engagement as commitment made by the project. He protested the project.

The videography of Sri Malik disrupted due to disturbance caused by the public.

19. Sri Padmalochan Behera, Manatri, Soro

Sri Behera explained about the meaning of recycling. He further explained on development of medical science which leads to nationalization in future. He is hopeful on benefit of some people in future due to establishment of Bio-medical waste treatment Plant. He suggested that, officials of the Pollution control Board should confirm to the public regarding no adverse impact by the project on the eommon people, treatment of effluent and its reutilization without discharging to

outside, reprocessing of gas emission by adopting modern technology. Lastly, he welcomed the project to be established.

20. Sri Susanta Malik, Manatri, Soro

Sri Malik informed that, the decision for project should be done by involving all the members of three Gram Panchayats.

The videography of Sri Malik was disrupted due to disturbance of participated public.

21. Sri Ashish Kumar Rout, Manatri, Soro

Sri Rout informed that, he always welcomes the industry and does not protest it, which is going to be established. He also told that, if there is no affect on the people, then they have no problem. He stressed on establishment of the project in scientific way, without considering benefit of individual or influence of the people. He placed the condition that, the project may come without affecting their human habitation.

22. Sri Rajesh Mahapatra, Manatri, Soro

Sri Mahapatra asked about the areas of collection of the Bio-medical wastes and its time period for storage. He also apprehended on generation of Methane gas from the storage of Bio-medical wastes. He again enquired on numbers of Machines to be installed, functionary and its ability, period of operation and maintenance. He again informed that, gas may be generated from the storage of wastes and queried for its management. He further opined that, the Plant should be established in vacant areas, away from the human habitation, so that during failure of machine, it can be managed. But, he welcomed the type of project.

23. Sri Anam Behera, Manatri, Soro

Sri Behera told that, expert may decide for the project and he does not like to say anything. He further opined that, what will be better for the local people that should be done.

The videography of Sri Behera was disrupted due to disturbance created by the participants.

24. Smt. Lipa Malik, Dahipur, Soro

Smt. Malik informed that, their small children are bathing in the nearby water body, which will be polluted by the project. So, she objected proposed project.

The videography of Smt Malik was disrupted due to disturbance created by the participants.

25. Sri Kamalakanta Palei, Manatri, Soro

Sri Palei is hopeful that, definitely some will get employment by this project and project proponent will also be benefited. He suggested that, to avoid friction among the neighbour, project proponent may go for other project such as Educational Institution, BPO and Knowledge Transfer Centre etc. where income level is more than this project. He further agreed that, he is not aware about ill effect on health by this project. So, he advised the project proponent to change the project instead of taking risk and blessed for his progress to bring the proud in locality.

Sri Nilu Mohapatra, OAS (S), ADM, Balasore requested the project proponent to redress the issues raised by the public in the hearing and Sri Sandeep Kumar Bera, Manager of M/S Utkal Envirocare responded to the issues raised for the such public hearing.

Sri Nilu Mahapatra, OAS (S), ADM, Balasore has given concluding remarks on the hearing and elaborated the process to be followed for submission of the proceeding to the SEIAA, Bhubaneswar for further action. He extended thanks to the public participated in the hearing and for offering their views, suggestions and objections.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure-I & II respectively, list of the oral deliberators and participants in the hearing is annexed as Annexure-III & IV respectively. The videography of proceedings are recorded and submitted as DVD (Two numbers).

The public hearing ended with thanks to the chair.
