PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR CHADHIAPADA SAND QUARRY OVER THE MINING LEASE AREA OF 5.090 HA FOR PRODUCTION OF ORDINARY SAND: 5,200 CUM/ANNUM AT CHADHIAPADA VILLAGE, CHIKITI TAHASIL OF DISTRICT GANJAM, HELD ON 20.10.2022 AT 11.00 AM OVER PLOT NO. 994/1743, KHATA NO. 629, AT- ADJACENT TO MULTI PURPOSE CYCLONE CENTRE IN VILLAGE CHADHIAPADA UNDER CHIKITI TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Tahasildar, Chikiti has proposed to have Environmental Impact Assessment for Chadhiapada Sand Quarry over mining lease area of 5.090 ha. for production of Ordinary Sand @ 5,200 cum/Annum in Chadhiapada village, Chikiti Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Samaja" dated 15.09.2022 and an English Daily "The Times of India" dated 15.09.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC). Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Nuapada Gram Panchayat, Chandapur Gram Panchayat and the Block Development Office, Chikiti, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponent of Chadhiapada Sand Quarry to brief about the project.

The Tahasildar, Chikiti, presented the salient features of the proposed Chadhiapada Sand Quarry, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The popular

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 40 persons were present in the public hearing meeting, only 27 nos. of persons signed in the attendance sheet, out of which 03 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

#### The statements recorded are as follows:

#### 1. Sri B. Krishnamurty, At- Nuapada, Chikiti

### He demanded the followings:

- a) Demarcation of Mining lease area:
- b) Manual Mining method only without use of any machineries such as JCB etc.
- c) Heavy vehicles such as Hywa should not be used for transportation of sand as this will lead to damage of rural roads constructed by Government. Transportation shall only be allowed by tractors.
- d) The District Administration and project proponent should commit before the public that mechanize mining and transportation through heavy vehicles shall not be allowed.
- e) After Titli Cyclone, there is scarcity of sand in the locality due to wash out of river bed by the flood. Therefore, sand shall be made available to the local public in priority basis.
- f) He apprehended that due to mining there may be depletion of water level which may lead to drinking water problem in the locality.
- g) Sand Bed used for crematorium by local people shall be excluded from the lease area or mining shall be prohibited in that area.

### 2. Sri Basant Kumar Sahu, At-Deuliapada, Chikiti

He supported views expressed by previous speaker and also demanded for demarcation of mining lease area, permanent employment to the local public, sand shall be available to nearby villagers on priority basis for construction of houses, transportation of mineral shall not be allowed by heavy vehicles etc. Further, he added that the Administration should develop a dedicated crematorium for local people and take steps for local employment to avoid migration of labors to outside.

### 3. Sri B. Sanmuk Rao, Sarapanch, Nuapada, Chikiti

#### He demanded the followings:

- a) The lessee shall appraised air pollution and other problems to be faced by the local public due to mining.
- b) Demarcation of Mining lease area.
- c) Manual Mining method only without use of any machineries such as JCB etc to create employment opportunity for labours.
- d) Heavy vehicles such as Hywa should not be used for transportation of sand. Transportation shall only be allowed by tractors.
- e) Sand Bed used for crematorium by local people shall be excluded from the lease area or mining shall be prohibited in that area. Administration should construct a dedicated crematorium for local people.

The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S, Addl. District Magistrate (Rev), Ganjam with the views and concerns of the deliberators.
