Sri Santosh Kumar Pradhan, Additional District Magistrate (Revenue), Angul District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcome the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental Assessment for Chandrabil Sand Quarry and Kamarei Sand Quarry (Two Quarries Under Cluster) over ML Area of 06.75 Ha. (2.10 Ha + 4.65 Ha) In Chandrabil and Kamarei Villages under Kaniha Tahasil of Angul District.

Sri Suklambar Patra, Environmental Engineer Consultant of Atmos Sustainable Solutions Pvt. Ltd. and on behalf of Lessee of Chandrabil Sand Quarry and Kamarei Sand Quarry of Angul District on behalf of the proponent addressed the committee members and assembled public and gave a brief description about the proposed project. He also briefed about Chandrabil Sand Quarry and Kamarei Sand Quarry (Two Quarries Under Cluster) over ML Area of 06.75 Ha. (2.10 Ha + 4.65 Ha) In Chandrabil and Kamarei Villages under Kaniha Tahasil of Angul District with the peripheral development work that had been taken up in this area, and made a presentation about the environmental management, pollution control measures, solid waste-management of the related project. The copy of the statement of the sand quarry read out at public hearing proceedings is enclosed.

Regarding public hearing of Chandrabil Sand Quarry and Kamarei Sand Quarry (Two Quarries Under Cluster) over ML Area of 06.75 Ha. (2.10 Ha + 4.65 Ha) In Chandrabil and Kamarei Villages Under Kaniha Tahasil of Angul District was publicized at one English Daily newspaper and one Odia daily newspaper before one month. It was also publicized at the office notice Board of Sanatribida Gram Panchayat Office and Kamarei Gram Panchayat Office, Tahasil Office Kaniha, Jilla Parisad Office Angul, Block Chairman Office, Kaniha and local villages of Chandrabil, Kamarei etc. Public hearing also publicized through loud speaker at the Chandrabil and Kamarei village area.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Regional Office, Angul & representative of State Pollution Control Board Odisha then invited the public to present their views about the proposed project on environmental consideration.

The views expressed by various speakers are as follows:

01 | Sri Charan Pradhan, Kamarei village

He expressed that due to the operation of sand quarry there should be no impact on the environment. Vehicular movements should be prohibited during school opening and closing times. There shall be adequate air pollution control. He said that village road should be well maintained and repaired by the lessee. Finally he expressed his opinion in favor of the project.

02 | Sri Tankadhara Sethi, Chandrabil village

He expressed his happiness about the sand mining project and he supported the sand mining project. Without elaborating anything in detail he supported the project.

03 Sri Dukhabandhu Behera, Chandrabil village

He welcomed the Officers and gathering of the public hearing. He urged to the District Magistrate about the problems the villagers are facing due to construction of Samal Barrage and how Sergi and Singda nalas are affecting their crop lands. About 100 acres of low lands are getting affected due to water logging up to 3 ft. in crop lands in rainy seasons due to construction of Samal Barrage. He expressed, due to lifting of sand from sand quarry the flow direction of the river may change which may create unpredictable situations in the village. He said that about 60 to 70 acres of land becomes barren land and could not able to cultivate properly. At the north direction of village this two nala flowing and for which during monsoon sand along with silt deposited and villagers used to cultivate their crops. If this sand mining starts this process of cultivation will affect. He also expressed they do not have belief on Government officials and their development aspects. From NTPC Kaniha to Godibandha road is very bad condition. The villagers do not have advanced vehicle to ply over bad condition road. The villagers are deprived of developments. Low lying crop lands of the area as in Pala, Tanta, Tila Tilei regions will be damaged due to earlier operation of sand quarry in the provided area. He requested to the village Secretary to speak few lines about the proposed sand mining project. He submitted a written representation before the panel member is enclosed separately.

04 | Sri Tikan Kumar Behera, Chandrabil village

He expressed that notice regarding Public Hearing was circulated in Panchayat Office and was also publicized through Loud speakers in this two village, but no information was provided to village President, village Secretary and village Committee of the village. He expressed the same as expressed by Sri Dukhabandhu and also he requested personally and also on behalf of the village not to permit operation of sand quarry in the village. He also demanded compensation for the 100 acre of land covered by sand due to construction of Samal Barrage. He described about the hasty road conditions due to movement of heavy coal loaded vehicles. He opposed the establishment of sand quarry in their area.

Repair and maintenance of village road, flow of stream may effect crop production, CSR issues and NTPC Kaniha to Godibandha bad road condition etc. were the most important issues emerged during the discussion.

He then delivered vote of thanks to the public for extending cooperation in smooth conducting of the public hearing proceedings.

SCHOOL OF CHANDRBIL, KANHIA TAHASIL OF ANGUL DISTRICT IN RESPECT OF ENVIRONMENTAL ASSESSMENT FOR CHANDRABIL SAND QUARRY AND KAMAREI SAND QUARRY (TWO QUARRIES UNDER CLUSTER) OVER ML AREA OF 06.75 HA. (2.10 HA + 4.65 HA) IN CHANDRABIL AND KAMAREI VILLAGES UNDER KANIHA TAHASIL OF ANGUL DISTRICT.

ISSUES RAISED BY PUBLIC

The issues raised at the public hearing meeting are mainly two fold. These are issues concerning to pollution due to proposed sand mining activity and its mitigation and issues relating to development of the area i. e, peripheral development.

The issues are

- 1. Air Pollution control measures
- Roads damage due to movement of sand loaded vehicles.
- 3. Protection of flow of water in Sergi and Singda nalas.
- School children and villagers are not walk properly on road when movement of vehicles.

COMMENT OF APPLICANT

Sri Paramananda Sahoo, on behalf of Lessee of Chandrabil and Kamarei Sand Quarry of Angul District was present at the public hearing gave his comments to certain demands raised by public as follows.

- Dust suppression and water pollution control management practices will be complied as per norms of the State Government and as per the provision of Environment Protection Act.
- To keep the village road in good condition, infrastructure facilities will be provided by the District Administration. During sand mining Government guideline will be followed properly.
- He ensured that during the course of sand mining flow pattern of two streams and crop production will not disturb.
- He ensured that speed restriction will be maintained during plying of vehicles during school timings and within village road area.
