

PROCEEDINGS OF THE PUBLIC HEARING OF PURUTIGUDA SAND QUARRY FOR EXPLOITATION OF RIVER SAND PRODUCTION OF 50,000 CUM / ANNUM OVER AN AREA OF 5.539 HA FROM BANSHADHARA RIVER BANK, BEARING KHATA NO. 522, PLOT NO. 1285 IN THE VILLAGE PURUTIGUDA, KASHINAGAR TAHASIL IN THE DISTRICT OF GAJAPATI HELD ON 09.11.2022 AT 11.00 A.M. IN THE GRAM PANCHAYAT OFFICE, KHANDAVA UNDER KASHINAGAR TAHSILOF GAJAPATI DISTRICT

The public hearing in respect of the above project was held on 09.11.2022 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in Purutiguda village, Khandava Gram panchayat under Kashinagar Tahsil area of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Sri Hemendra Nath Nayak, SES-cum-Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Pradeep Kumar Nayak, OAS (S), Additional District Magistrate (Revenue), Gajapati highlighted on importance of such hearing & presided over the public hearing.

Sri Rakesh Roshan Ganthayat, Project consultant of Purutiguda Sand Quarry has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

1. Sri R Janaki Rao, Purutiguda

Sri Rao welcomed the dias and the public. He introduced himself as a villager of Purutiguda. He told that the authority came to their village for the purpose of public hearing of Purutiguda Sand Bed. He questioned the authority about the quantum of sand exploited earlier from the river bed in terms of sand bed width and depth. He also spoke about the past incident of death of a boy in the river for which they had also made FIR in the Police Station. He expressed his displeasure on an IAS authority named Mahapatra Sir for not intimating about the incident to them as well as for no action in the matter. He demanded for proper demarcation of the leased-out sand bed area as well as providing security personnel to prevent unauthorized entry to avoid any untoward accident. He asked the authority to come forward for a discussion on the sand mining issues with them in their village and only after that they will consider about the operationalisation of sand bed.



2. Sri Andu Gouda, Purutiguda

Sri Gouda introduced himself as a villager of Purutiguda and told that due to sand bed mining activity through the use of machine, they will face a lot of noise problems in the night sleeping hour. He asked the authority for cooperation in the matter to sort out the noise issues.

3. Sri R Satish, Purutiguda (Naik Sarpanch)


Sri Satish welcomed the public & the dias. He introduced himself as the Naik Sarpanch of the GP. He described about the various schemes of the Government w.r.t. increase in revenue of the district as well as the state. He stressed upon the responsibility that lies on the part of lessee to strictly follow the guidelines as prescribed by the Government for sand mining.



Sl. No.	Issues raised by the public in Hearing Meeting	Response of the Project Proponent
01	Sand mining from the river bed	Sand mining from the river bed will be done as per the Government Guideline.
02	Safety & security in the lease area to avoid accidents	Local youths will be engaged as security personnel in the sand mine to prevent any unauthorized entry to the lease area to avoid any type of accident.
03	Transportation of sand	Transportation of sand will be done through the tarpaulin covered vehicle.
04	Control of noise during sand mining and sand transportation	Transportation vehicles will be ensured to have silencers to control noise. Further, to avoid any nuisance due to noise, sand transportation will be only carried out during day time within 6PM.
05	Dust suppression measure	Dust suppression along the transportation road will be done by mobile water tanker.
06	Protection of Environment	Sand mining will be done in such a way that it will not affect the environment.
07	Utilization of DMF Fund for Peripheral development of the village	DMF fund will be utilized for Peripheral development of the village as per Government Guideline.
08	Road Development	Overloading of vehicles will be avoided to prevent damage of road and any rut & porthole in the road will be repaired on priority basis.
09	Plantation	Plantation will be done as per the scheme of mining plan.
