Shri Bhaskar Raito, OAS (S), Additional District Magistrate, Nabarangpur presided over and supervised the public hearing. He briefed about the importance of such hearing and invited the project proponent to highlight on the proposed project.

Project Consultant Sri Jagabandhu Bisoi, Consultant, Kalyani Laboratory (P) Ltd on behalf of M/s Karlichuan Decorative stone Mine has explained about the proposed project and briefed about the Environment Management Plan and socio-economic development of proposed plan.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Koraput.

## 1. Sri Jagannath Santa, Karlichuan

He had requested for a detail explanation from the project proponent.

Sri Ramanath Santa welcomed the project being hopeful that the local youth would get job opportunities in the mining project.

The Regional Officer, SPCB, Koraput read over the issues raised by the public in the hearing and on behalf of Project Proponent. Sri. Jagabandhu Bisoi, Consultant, Kalyani Laboratory (P) Ltd responded to the issues raised for mining project. His detail explanation during public hearing are enclosed in Annexure-I and II.

Shri Bhaskar Raito, OAS (S), Additional District Magistrate, Nabarangpur has given concluding remarks on the hearing and elaborated the process to be followed for submission of the proceeding to the SEIAA, Bhubaneswar for further action. He extended thanks to the public participated in the hearing and for offering their views and suggestions.
