

**PROCEEDINGS OF THE PUBLIC HEARING HELD ON 23.11.2022 AT LAND IN FRONT OF DEVI BRICK KILN, TARAJANGA WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR KILIPAL MAHANADI RIVER SAND QUARRY OVER AN AREA OF 5.26 HA. BEARING KHATA NO. 298, PLOT NO. 954 IN VILLAGE KILIPAL UNDER TIRTOL TAHASIL OF JAGATSINGHPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE.**

The public hearing in respect of the project proposed by Sri Saroj Kumar Mohanty for Mahanadi River Sand Quarry over an area of 5.26 Ha. Under Tirtol Tahasil of Jagatsinghpur district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

**The Panel consisted of the following members:**

Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur, supervised & presided over the public hearing process which was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Paradeep, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by Sri Saroj Kumar Mohanty.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Shri Goutam Sahoo of M/s Green Circle, INC, Vadodra (Consultant) addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep requested the public to give their views, comments, objections and opinions on the proposed project.

**The views expressed by various speakers on the proposed project are as follows:**

**1. Sri Narahari Mishra, Tarajanga, Tirtol:**

He supported the proposed operation of the sand quarry and told that people will be benefitted from this project and availability of sand in the area will be easier. He expressed his gratitude to the district administration for declaring kilipal sand quarry as a sairat source. Besides requesting lessee to provide sand to local people at a concessional price he also requested to carry out mining activity by taking care of environment.

**2. Sri Rajesh Kumar Sahoo, Bofapur:**

Though he did not oppose operation of sand quarry he highlighted the issue of air borne sand dust affecting nearby agricultural land during transportation of sand.

**3. Sri Biranchi Narayan Malla, Pubapada:**

Though he registered to deliberate, later refused to say anything.

**4. Shri Jiten Pal, Tentulia:**

Supporting the proposed sand quarry project he told that people will be benefitted with easy availability of sand in their area.

**5. Shri Dhananjay Prusty, Bofapur:**

While supporting the proposed project, he requested for availability of sand for local people at a concessional price, protection of agricultural land from air borne sand dust by covering of sand loaded vehicles during transportation and taking necessary steps for protection of river embankment.

**6. Shri Ashish Kumar Rout, Kilipal:**

Emphasizing on necessity of sand he requested lessee to take care of nearby agricultural fields preventing sand dust to be air borne while transportation.

**7. Shri Trilochansethy, Bafapur:**

He expressed his discontent towards hamper of agricultural activities nearer to sand mining. He also emphasized on protection of river embankment and requested to lessee to take care of farmers of the agricultural fields nearer to the sand quarry for prevention of air borne sand dust to their fields. He requested for provision of water sprinkling on haul roads to prevent air pollution due to transportation of sand. He also requested lessee to provide sand to local people at a concessional price.

#### 8. **Shri Pabitra Kumar Swain, Panchai:**

Supporting the sand mining project, he highlighted the issues like protection of river embankment, provision of water sprinkling on haul roads and thereby protecting near by agricultural lands from sand dust, protection of river embankment. He also highlighted the issue of noise pollution due to transporting vehicles and requested lessee to provide sand to local people at a concessional price.

The Panel received one (01) no. of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.


#### **Observation:**


The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Smt. Chinmayee Biswal, Addl. District Magistrate, and Jagatsinghpur ratified the minutes of meetings with the views and demands of public. She extended her vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.



**NOTICE**

It is brought to the notice of all concerned that Sri Saroj Kumar Mohanty has proposed to have Environmental Assessment for Kilipal Mahanadi Sand Quarry over an area of 5.26 ha bearing Khata No.298, Plot No.954 in village Kilipal under Tirtol tehsil of Jagatsinghpur district to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site / sites of displacement / sites likely to be affected.

For the above purpose, a person will only mean:

- A. Any person who is likely to be affected by the grant of Environmental Clearance.
- B. Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
- C. Any association of persons whether incorporated or likely to be affected by the project and / or functioning in the field of environment.
- D. Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted 23-11-2022 at 10.30 A.M. at the Ground in-front of Devi Brick Kiln at Tarajanga under Tirtol tehsil of Jagatsinghpur district.
