LAND IN KHATA NO. 326, PLOT NOS. 561 & 1018, UNDER KUKUDAKHANDI TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Tahasildar, Kukudakhandi has proposed to have Environmental Impact Assessment for mining lease area of 11.139 ha. for production of Construction Stone @ 37,364 cum/Annum at Kusumi & Mahuda villages, Kukudakhandi Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Prameya" dated 19.10.2022 and an English Daily "The Times of India" dated 19.10.2022 regarding the venue, date and time of the public hearing along with the places of availability of Executive Summaries (Odia & English) of Environmental Impact Assessment (EIA) report in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Chandpur Gram Panchayat, Mahuda Gram Panchayat, Lathi Gram Panchayat, Baghalati Gram Panchayat and Block Development Office, Kukudakhandi in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance and requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. Then he asked the Project Proponents of M/s. Kusumi & Mahuda Stone Quarries to brief about the project.

The Tahasildar. Kukudakhandi presented the salient features of the proposed project, the present status of the environmental conditions, and possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

The Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 60 persons were present in the public hearing meeting and among them only 47 nos. of persons signed in the attendance sheet. 04 persons signed for oral deliberation sheet and expressed their views. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.


