PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR BADAMADHAPUR SAND QUARRY OVER THE MINING LEASE AREA OF 6.070 HA BEARING KHATA NO. 1399, PLOT NO. 909/7520 FOR PRODUCTION OF ORDINARY SAND: 21,850 CUM/ANNUM AT BADAMADHAPUR VILLAGÉ, CHATRAPUR TAHASIL OF DISTRICT GANJAM, HELD ON 11.11.2022 AT 11.00 AM AT MOUZA BADAMADHAPUR (OVER THE GOVT LAND IN KHATA NO. 1397, PLOT NO. 10 WHICH IS ADJACENT TO KALI THAKURANI TEMPLE) UNDER CHATRAPUR TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Tahasildar, Chatrapur has proposed to have Environmental Impact Assessment for Badamadhapur Sand Quarry over mining lease area of 6.070 ha. for production of Ordinary Sand @ 21,850 cum/Annum in Badamadhapur village, Chatrapur Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Sambada" dated 02.10.2022 and an English Daily "The Times of India" dated 02.10.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (<a href="https://www.ospcboard.org">www.ospcboard.org</a>).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Potalampur Gram Panchayat, Karapada Gram Panchayat and the Block Development Office, Chatrapur, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked Project Proponent to brief about the project.

Sri Deba Choudhury, representative of project proponent has presented the salient features of the proposed Badamadhapur Sand Quarry, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

Tilhair

The Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 60 persons were present in the public hearing meeting, only 47 nos. of persons signed in the attendance sheet, out of which 05 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

#### The statements recorded are as follows:

### 1. Sri Maheswar Pradhan, At-Badamadhapur, Chatrapur

He has highlighted/ demanded the followings:

- a) He was grateful for conducting public hearing regarding environment impact assessment due to sand quarry.
- b) Speed of sand transporting vehicles shall be controlled in market area and road passing adjacent to schools.
- c) Air pollution due to transportation is impacting vegetation. Therefore, water sprinkling should be carried out on transportation roads.

### 2. Sri S. Kishore Chandra Reddy, At-Badamadhapur, Chatrapur

He has highlighted/ demanded the followings:

- a) Transportation vehicle's speed should be controlled.
- b) Traffic personnel should be appointed in order to check traffic during rush time.
- c) Plantation should be undertaken around river bank as well as along road.

### 3. Sri Ajit Swain, At-Badamadhapur, Chatrapur

He has highlighted/ demanded the followings:

- a) 2 % of profit margin from the mining should be invested in development of the locality.
- b) Health facility
- c) Local employment.
- d) Plantation.
- e) Social activity/ local development.
- f) Vehicular speed should be controlled during commuting time of the school children. It would be better to prohibit transportation during that time.

### 4. Sri R. Iginesh, At-Badamadhapur, Chatrapur.

He has highlighted/ demanded the followings:

- a) Pointed out the importance of sand mining for construction works.
- b) Plantation, mainly fruit bearing plants along the transportation roads.

### 5. Sri Siba Sankar Sethi, At – Badamadhapur, Chatrapur.

He has highlighted/demanded the followings:

- a) Dust pollution from the frequent movement of transportation vehicles. Destroy of vegetation.
- b) Speed of transportation vehicle should be controlled around school area. It would be better to prohibit transportation during commuting time of the school children.

Further the Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Badamadhapur Sand Quarry to address the issues raised by the local public. Sri Biswajit Patro, Representative of Badamadhapur Sand Quarry addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by the Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.
