PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR LAXMIPUR SAND QUARRY OVER THE MINING LEASE AREA OF 5.244 HA FOR PRODUCTION OF ORDINARY SAND: 11,000 CUM/ANNUM AT LAXMIPUR VILLAGE, DHARAKOTE TAHASIL OF DISTRICT GANJAM, HELD ON 24.11.2022 AT 11.00 AM OVER THE VACANT GOVT LAND IN KHATA NO. 191, PLOT NO. 172 OF LAXMIPUR MOUZA, DHARAKOTE TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Tahasildar, Dharakote has proposed to have Environmental Impact Assessment for Laxmipur Sand Quarry over mining lease area of 5.244 ha. for production of Ordinary Sand @ 11,000 cum/Annum in Laxmipur village, Dharakote Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Sambad" dated 19.10.2022 and an English Daily "The New Indian Express" dated 19.10.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, Chatrapur, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur and Department of Forest, Environment & Climate Change Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Dhougaon Gram Panchayat, Damadarapalli Gram Panchayat, Mundamarei Gram Panchayat, Saradhapur Gram Panchayat and the Block Development Office, Dharakote, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked Project Proponent to brief about the project.

Smt. Jyotsnarani Pradhan, representative of project proponent presented the salient features of the proposed Laxmipur Sand Quarry, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 50 persons were present in the public hearing meeting, only 34 nos. of persons signed in the attendance sheet, out of which 03 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri. Sisira Kumar Raj, Village- Saradhapur, Dharakote

He has highlighted/ demanded the followings:

- a) He stated that deposit of sand is renewable and it is also required for construction works. He supports sand mining as there will be benefits for local people from this.
- b) This will increases Government revenue and will create employment opportunities for local people which will improve financial condition of the villagers.
- c) Plantation.
- d) Drinking water facility, irrigation facility, health facility etc.
- e) Air pollution and impact on local environment due to transportation. Therefore, water sprinkling shall be carried out at transportation roads.
- f) Sand shall be in wet condition and vehicles shall be covered with tarpaulin during transportation to avoid dust generation.
- g) Lessee shall not excavate sand from low-lying area and these patches should be filled up with soil after mining.

2. Sri Satrughana Gouda, Village- Laxmipur, Dharakote

He has highlighted/ demanded the followings:

- a) Delighted and obliged to be a part of public hearing being conducted for environment impact assessment of sand mining.
- b) People will get employment opportunity from sand mining, their livelihood will increase and they will also get financial benefits as informed in this meeting. However, he requests to explain how people will be benefited.
- c) Transportation vehicles are affecting roads as these roads are not meant for heavy vehicles. Therefore roads shall be maintained regularly. Load bearing capacity of these roads shall be enhanced or heavy vehicles shall be prohibited.
- d) Water sprinkling for control of dust pollution.
- e) Plantation along both sides of the road and environment protection.
- f) Health benefits.

3. Sri Dillip Kumar Jena, Sarpanch, Saradhapur G.P., Dharakote

He has highlighted/ demanded the followings:

- a) Supports this project.
- b) Overloading of sand shall be avoided during transportation.
- c) Tarpaulin covers during transporting.
- d) Sand shall be made available for local construction works.
- e) Regular road maintenance.

Further the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Laxmipur Sand Quarry to address the issues raised by the local public. Sri Biswajit Patro, representative of Laxmipur Sand Quarry addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.
