**PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR AMBAPUA SAND QUARRY OVER THE MINING LEASE AREA OF 6.377 HA BEARING KHATA NO. 694, PLOT NOS. 01, 71, 71/2179 & 1289 FOR PRODUCTION OF ORDINARY SAND: 1,810 CUM/ANNUM AT AMBAPUA VILLAGE, BELLAGUNTHA TAHASIL OF DISTRICT GANJAM, HELD ON 30.11.2022 AT 11.00 AM OVER THE GOVT LAND IN KHATA NO. 696, PLOT NO. 375/2256 WHICH IS NEAR TO GRAM PANCHAYAT OFFICE AMBAPUA UNDER BELLAGUNTHA TAHASIL OF GANJAM DISTRICT**

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Sri Sunil Kumar Mohanty has proposed to have Environmental Impact Assessment for Ambapua Sand Quarry Mining project over mining lease area of 6.377 ha. for production of Ordinary Sand @ 1,810 cum/Annum in Ambapua village, Bellaguntha Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily “The Dharitri” dated 29.10.2022 and an English Daily “The Times of India” dated 29.10.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur and Department of Forest, Environment & Climate Change Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar ([www.ospcboard.org](http://www.ospcboard.org)).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Motabadi Gram Panchayat, Udhura Gram Panchayat, Adheigam, Executive Officer, Bellaguntha NAC and the Block Development Office, Bellaguntha in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked Project Proponent to brief about the project.

Sri Sunil Kumar Mohanty, project proponent presented the salient features of the proposed Ambapua Sand Quarry Mining Project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.



The Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 60 persons were present in the public hearing meeting, only 51 nos. of persons signed in the attendance sheet, out of which 06 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

- b) Plantation.
- c) Tarpaulin covers of transporting vehicles.
- d) Govt. should regulate the cost of sand.

**3. Sri Sankar Narayan Behera, Village- Chadhiapalli**

He has highlighted/ demanded the followings:

- a) Supports this mining project for easy availability of sand for various construction works.
- b) Development of temple.

**4. Sri Sanjaya Kumar Patra, Village- Chadhiapalli**

He has highlighted/ demanded the followings:

- a) Supports this mining project for easy availability of sand for various construction works.
- b) Price of sand and royalty shall be decreased.
- c) Development of Lord Shiva temple.
- d) Mining of sand shall not be allowed within 100 meters from bridge.

**5. Sri Basudev Swain, Village- Ambapua**

He has highlighted/ demanded the followings:

- a) Supports this mining project.
- b) District Administration shall reduce royalty and price of sand.
- c) Development of Lord Shiva temple.



## 6. Sri Jitendra Pradhan, Village- Ambapua

He has highlighted/ demanded the followings:

- a) Supports this mining project for easy availability of sand at cheaper price for various construction works.
- b) Plantation.
- c) Control pollution.
- d) Maintenance of roads.

Further the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Ambapua Sand Quarry Mining Project to address the issues raised by the local public. Sri Sunil Kumar Mohanty, project proponent addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.




