



PROCEEDINGS OF THE PUBLIC HEARING FOR GRANT OF ENVIRONMENTAL CLEARANCE FOR THE PROPOSED TUMKELA SAND QUARRY OVER AN AREA OF 6.475 HA. AT KHATA NO- 02, PLOT NO- 312/339/P IN VILLAGE TUMKELA UNDER ROURKELA TEHSIL IN THE DISTRICT OF SUNDARGARH DISTRICT HELD ON 14.11.2022, AT 11 AM, AT SECTOR- 16, PH COLONY GROUND, ROURKELA, UNDER ROURKELA TAHASIL OF SUNDARGARH DISTRICT.

The public hearing for grant of Environmental Clearance for the proposed Tumkela sand quarry over an area of 6.475 HA at Khata No. 02, Plot No. 312/339/P in village Tumkela under Rourkela Tehsil was held on dtd. 14.11.2022, at 11 am, at Sector- 16, PH colony ground, Rourkela, in the District of Sundargarh. Sri Abhimanyu Majhi, Sub Divisional Magistrate, Panposh supervised and presided over the public hearing process. Er. Ramani Ranjan Das, Deputy Environmental Engineer, State Pollution Control Board, Odisha, Regional Office, Rourkela delivered welcome address, organized and conducted the public hearing meeting in association with district administration.

The Public Hearing in respect of the above proposed Tumkela Sand quarry held as per the schedule and the venue decided by the District Magistrate in accordance with the EIA Notification S.O.1533 (E) dated 14.09.2006 and subsequent amendment therein. The State Pollution Control Board, Odisha, Bhubaneswar had advertised in newspaper in Odia daily Sambad on dtd 12.10.2022 and English daily The New Indian Express on dtd 12.10.2022. The Public Hearing meeting with regards to date, place and time was also announced in public address system apart from its publication in local dailies. The attendance sheet of the public attended the public hearing is annexed as Annexure – I. around 35 nos. of persons had attended the public hearing meeting where as 8 persons had delivered their views whose list is annexed as Annexure II.

At the outset, Er. Ramani Ranjan Das, Deputy Environmental Engineer, State Pollution Control Board, Odisha, Regional Office, Rourkela welcomed all present in the meeting. He briefly described the objectives and procedure followed for conducting the Public Hearing as per the EIA Notification S.O.1533 (E) dated 14.09.2006 of Ministry of Environment, Forest & Climate Change (MoEF & CC), Govt. of India. He also explained about the importance of such hearing for the proposed Tumkela sand quarry over an area of 6.475 Ha in village Tumkela for grant of Environmental Clearance and also invited views, comments, objections & opinions of the public which are necessary while considering the environmental clearance of the project and he also told that those who want to give their written statement about the proposed projects, they can do so

during the public hearing process. He requested Sub-Divisional Magistrate, Panposh to preside over the meeting.


Welcoming the public, the officials, Press Media, Police Officers and the assembled public in the meeting, Sri Abhimanyu Majhi, Sub Divisional Magistrate, Panposh briefly explained about the purpose of the public hearing about the proposed Tumkela Sand quarry, At: Tumkela Village under Rourkela Tahsil of Sundargarh District. He also described the importance of environmental impact studies carried out for the proposed Sand quarry and the views, comments, objections and opinions of the public are necessary while considering the Environmental Clearance of the project. He told that the project proponent will present the summary of environmental impact studies for the proposed project for the knowledge of the Public. He invited the villagers to present their views, opinions & objections about the proposed project on environmental consideration. He also told that the public can also submit written representations. The proceeding along with video recording of the meeting will be forwarded to the Government for further decision-making process for grant of Environmental Clearance. He requested the Deputy Environmental Engineer, SPCB, Odisha, Rourkela to carry out further proceeding of the meeting.

Er. Ramani Ranjan Das, DEE, SPCB, Odisha, Rourkela requested the representative of Project Proponent to make a brief presentation before the public gathered in the meeting about the details of environmental impact assessment report of the proposed project in a simple summarized manner for better understanding of the Public.

On behalf of the Project Proponent, Sri Saswat Kumar Singh, Manager of the Lease holder welcomed the panel members, public and all other participants and gave a brief description about Tumkela Sand quarry. He expressed the details of proposed project which are as follows:

- The Tumkela Sand quarry located at village Tumkela has been awarded to Smt. Rajashree Behera. The proposed quarry measuring 4.475 Ha will be leased for a period of 5 Years from the date of execution of lease. The new proposed quarry is located in Rourkela tahsil in the District of Sundargarh has proposed an annual production of 8142 cubic meter.
- Various programs for environmental management and development will be adopted if the proposed quarry becomes operational. Extraction will be done from Sand bed leaving safety zone from bank. Ground water table will be kept safe from penetration. Activities that release fine sediments to the river will be minimized. Mitigation measures will be adopted to minimize disturbance during transportation & handling of minerals. Restoration plan during the closure of mine at the onset of monsoon seasons will be established. Air quality in this area is within

acceptable limits and even if there is slight increase after commencement of quarry activities, it will be kept within the permissible limits by proper management by the company. Other environmental management plans will be done as per the environmental impact assessment and environmental management plan of the appointed M/s. Atmos Sustainable Solution Pvt. Ltd.

Er. Ramani Ranjan Das, DEE, SPCB, Rourkela then invited the public to register their names to put forth their views, suggestion, comments and objections on matters relating to environmental aspects of the project. Then the public deliberated on various issues one by one which are as follows;

1. Sri Binod Kumar, Sector -16, Rourkela

Sri Kumar greeted & welcomed the panel members, gathered public and all other participants to the meeting. He stated that no announcement was made to aware about the public hearing programme. They came to know about the programme from their own source. He wanted to boycott the meeting and requested the Sub Collector to reschedule the meeting and relocate it near to the sand quarry in Tumkela village.

In reply Sub-Collector, Panposh made it clear that the schedule of this programme is published in the local daily much before.

2. Smt Jasbinder Kaur, Sector-16, Rourkela

Smt Kaur stated that she is staying near the Sand Quarry. Sand quarry is in the Tumkela, but the venue of meeting is PH Colony. Roads are getting damaged due to excessive plying of vehicle. They are not informed about the schedule of the meeting. So she demanded to cancel the meeting and reschedule it.

3. Smt Basanti Khadia, Tumkela, Rourkela

Smt Khadia demanded to reschedule and relocate the meeting.

4. Sri Surendra Das, Sec- 16, A-Block, Rourkela


Sri Das demanded to the competent authority for the repairing of damaged road.

8. Smt Shanti Minz, Khadia Basti, Sector- 16, Rourkela


Smt Minz greeted & welcomed the panel members, gathered public and all other participants to the meeting. She demanded to cover the trolley of the lorry while transporting sand.

1	Issues related to Air Pollution and Mitigation measures.	Quarry activities like loading and movement of other transport vehicles used in mining will generate dust. The mineral will be transported by road through covered tarpaulin trucks/tippers to reduce the fugitive emission.
2	Issues related to Water Pollution.	Quarry activities will be carried out only in the dry part of the Koel River.
3.	Issues related to Land Environment	The quarry activities will be carried out only in non-monsoon seasons only. The excavated area will get replenish gradually during monsoon.
4.	Issues related to Noise Pollution	The vehicle will be maintained in good running condition so that noise will be reduced to minimum possible level.
B. Socio-economic Issues		
1	Issues related to Employment	Sand quarry will provide employment to local people whenever there is requirement of manpower.
