The Public Hearing meeting was presided over by the Additional District Magistrate, Cuttack. Debajani Praharaj.

Rashmita Priyadarshini, the Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained that the views, comments, objections and opinions of the public are taken into account while considering the environmental clearance of the project. She informed that the date, time and venue for conducting this public hearing was duly advertised in Odia daily newspaper "The Dharitri" on 26.11.2022 and in English daily newspaper "The New Indian Express" on 26.11.2022 for intimation to the public about this public hearing meeting. On behalf of the project proponent, Sri Chintamani Samal addressed the panel members and the assembled public. He made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

He raised his concern that due to sand lifting the river bank is getting damaged and it is a threat for their village. He said there is no need of sand quarry in this area.

# 3. Sri Sanatan Choudhury, Tunapur:

He said opinions of all villagers are same. He said due to lifting of sand ditches are formed for which the dykes are not safe during flood. He stated if there was proposal for operation of the sand mine then why plantation was not done initially and how environment will be protected. After sand mining who knows plantation will be done or not. He said everything will be recorded in the file only. So, they do not want the sand mine to be operated.

Total 03 Nos. of people had registered their names to express their views, comments etc. and deliberated their views accordingly. About 14 nos. of people were attended the public hearing meeting and signed the attendance sheet.

After all the speakers completed giving their respective opinion and suggestion, the Regional Officer, Cuttack asked the project proponent to give relevant reply if any to the issues raised during the meeting. On behalf of the project proponent Sri Chintamani Samal replied that they are agree with the suggestion of the public and they will deposit the fund to
