

PROCEEDINGS OF THE PUBLIC HEARING MEETING OF M/S. TUTUSINGHA SAND QUARRY OVER AN AREA OF 0.220 Ha (UNDER CLUSTER TOTAL LEASE 5.463 HA) IN VILLAGE TUTUSINGHA UNDER BOUDH TAHASIL OF BOUDH DISTRICT HELD ON DT. 15.02.2023 AT 11.00 A.M AT-TUTUSINGHA VILLAGE IN BOUDH DISTRICT.

Smt. Babitarani Dalabehera, OAS (S), Additional District Magistrate (Revenue), Boudh presided over the meeting along with along with Er.(Mrs.) Babita Singh, Regional Officer, State Pollution Control Board, Odisha, Balangir.

At the outset, Er.(Mrs.) Babita Singh, Regional Officer, State Pollution Control Board, Balangir welcomed all the public present in the meeting. She briefly described the objective of the public hearing conducted as per the provisions of EIA Notification No. S.O. 1533(E) of Dt.14th September 2006 of the Ministry of Environment and Forests & Climate Change (MoEF& CC), Government of India. She also informed that the date, time and venue for conducting the public hearing meeting of the project proposed by M/s. Tutusingha Sand Quarry, At-Tutusingha Village of Boudh district on 15.02.2023 At:11.00 A.M was duly advertised in Odia daily "**Sakala**", **dtd.12.01.2023** and English daily "**The Times of India**" **dtd.12.01.2023** (Paper clipping are enclosed as **Annexure-I**) following due procedure. The venue, date and timing of the Public hearing meeting of the said sand quarry was extensively propagated in all affected and nearby villages. The executive summary of the project both in Oriya & English were displayed in public at the meeting venue and also distributed among the persons during the meeting. The executive summary also is available in the website of State pollution Control Board, Bhubaneswar (www.ospcboard.org).

The Addl. District Magistrate has also briefed about the proposed project and requested the public who were present during the public hearing meeting to express their opinions and views on the proposed project. She also requested the representative of the proposed project to highlight about their project before the public.

On behalf of the M/s. Tutusingha Sand Quarry SriSatya Narayan Pradhan, Lessee briefly explained about the proposed project as described below:

1. It was informed that the total proposed project area is about 0.220 Ha (Under Cluster Total Lease 5.463 Ha) of land comprising of Khata No. 518, Plot No. 01. It has been projected that the total production by these quarries will be around 3045 cum. The cost of the proposed project is Rs.30.00 lakh.

2. The depth of the sand quarry is maximum 1 meter. Approximately 5 KLD water will require for dust suppression measures in the mine. The Project Proponent proposed to spend Rs 2,12500/- for CSR activities in the nearby villages and also spend Rs.4.20 lakh towards environment protection in the affected areas. The total expenses towards environment protection and CSR activities in the nearby area will be borne by the Lease holder.
3. The sand quarry authority has proposed for regular water sprinkling on the main roads in the area to prevent air pollution and also proposed to widely plantation in the mining area to reduce the amount of airborne dust. The loaded trucks will be covered by Tarpaulin to prevent air pollution in the mining area.
4. The mining process includes manual opencast mining.
5. The mines authority proposed to monitor Air, Water and noise quality in the mining area at least twice in a year and submit the report to concerned authorities.

About 50 participants have attended the public hearing meeting and out of them 28 participants have put their signature in the attendance sheet whose list is annexed as **Annexure-II**. 9 persons have registered their name to deliver their views during public hearing and list is annexed as **Annexure-III**. No written statement has been received during Public Hearing.

Statements of the public participated in the deliberation during public hearing meeting are as follows;

Sl. No.	Name of the Participants and their deliberation on the proposed project.
1.	<u>Sri Manash Kumar Purohit:</u> He welcomed the proposed project and stated that there is scarcity of sand in the locality and facing problems during construction works. So he requested to run the project as early as possible. Also asked the project authority to give a reasonable rate on purchase of sand to the local people.
2.	<u>Sri Ramesh Chandra Sahu:</u> He welcomed the project and requested to start the quarry at the earliest. Once the quarry starts they can construct <i>Indira Avas</i> in the area.

3.	<u>Sri Pramod Kumar Pradhan:</u> He welcomed the proposed project and told that due to unavailability of sand they are purchasing at a higher rate. He also requested the project proponent to give a reasonable rate on purchase of sand to the local people.
4.	<u>Sri Uma Shankar Mishra:</u> He welcomed the proposed project and asked to run the quarry very soon. Also asked the project authority to give a reasonable rate on purchase of sand to the local people.
5.	<u>Sri Suramani Pradhan:</u> He welcomed the proposed project.
6.	<u>Sri Kiroti Mallik:</u> He welcomed the proposed project. He asked the project authority to give special attention on environment and to develop the nearby playground.
7.	<u>Kuna Naik:</u> He welcomed the project. He asked the project proponent to take safety measures while plying loaded vehicles. Due to plying of vehicles sand are accumulated on the road due to which the two wheel riders facing problems. So the road should be cleaned on regular basis.
8.	<u>Sri Pratap Kishor Bhanja:</u> He welcomed the project. As there is no sand quarry nearby they are bringing sand from distance place. So the quarry should run as early as possible.
9.	<u>Sri Kishor Chandra Pradhan:</u> He welcomed the project and requested the Govt. Authority to handover the royalty matter to the local GP.

Summary of the points raised by the participants in the public hearing are being read out by the Sub-Collector, Boudh and same in English and Odiya (vernacular language) is enclosed as **Annexure-IV (A & B)**.

After the completion of the deliberation process the Addl. District Magistrate invited the representatives of M/s. Tutusingha Sand Quarry also give a brief note on the issues related to the demand and grievances of the participants raised in the public hearing meeting.

On behalf of the project proponent, Sri Satya Narayan Pradhan, Lessee has responded on the issues raised by the participants during public hearing. Same in English and Odiya (vernacular language) are also given in **Annexure-V (A & B)**. The video recording of the entire proceeding of the public hearing is enclosed as Pen Drive.

After the above-mentioned deliberation, the Addl. District Magistrate has announced the completion of public hearing over the proposed project and the Regional Officer has proposed the vote of thanks to the Chair as well as to the Participants present during the public hearing.

The meeting ended with vote of thanks to the Chair.

It is brought to the notice of all concerned that Sri Satyanarayan Pradhan has proposed to have Environmental Assessment for Tutusinga Sand Quarry (Under Cluster total lease area 5.463 Ha.) over an area of 0.202ha. bearing Khata No.518 Plot No. 01 in village Tutusinga under Boudh tehsil of Boudh district to obtain Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.
