

PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR GIRISOLA STONE QUARRY- I OVER THE MINING LEASE AREA OF 20.510 HA BEARING PLOT NOS. 1, 2, 3, 4 UNDER KHATA NO. 897, MOUZA GIRISOLA FOR PRODUCTION OF ORDINARY STONE: 5600 CUM/ANNUM IN CHIKITI TAHASIL OF DISTRICT GANJAM, HELD ON 15.03.2023 AT 11.00 AM OVER GOVT. LAND HAVING PLOT NOS. 660 & 796 , IN MOUZA JAGANNATHPUR UNDER CHIKITI TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that the Tahasildar, Chikiti has proposed to have Environmental Impact Assessment for Girisola Stone Quarry- I over mining lease area of 20.510 ha. bearing Plot Nos. 1, 2, 3, 4 under Khata No. 897, Mouza- Girisola for production of Ordinary Stone @ 5600 cum/Annum under Chikiti Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily “The Dharitri” dated 08.02.2023 and an English Daily “The Times of India” dated 08.02.2023 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC). Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospeboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Govindanagar Gram Panchayat, Girisola Gram Panchayat, and the Block Development Office, Chikiti, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance and requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector cum Sub Divisional Magistrate, Berhampur to kindly preside and supervise in the public hearing.

The Sub-Collector cum Sub Divisional Magistrate, Berhampur, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. Then he asked Project Proponent to brief about the project.

Sri Simanchala Patro, successful bidder presented the salient features of the proposed Girisola Stone Quarry- I, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Sub-Collector cum Sub Divisional Magistrate, Berhampur, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 45 persons were present in the public hearing meeting, only 33 nos. of persons signed in the attendance sheet, out of which 06 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri M S V Subbaraju, At/PO- Jagannathpur, Ganjam

He is satisfied with the pollution preventive measures proposed by the lessee and highlighted the followings:

- a) Effect of blasting and dust pollution should be minimized.
- b) The landless labourers of Jagannathpur and Erendra villages shall be given priority in employment during operation of this quarry.
- c) The local people will get stone chips, stone dust etc. at a cheaper price after the operationalization of the proposed quarry.

2. Sri Krushna Chandra Sahu, Sarpanch, Govindanagar Gram Panchayat

He has highlighted followings:

- a) Proposed mining activity will lead to development of the locality.
- b) Employment opportunities will be generated for the local people.
- c) Ordinary stone will be available at a cheaper price for construction purpose.

3. Sri Srikanta Patra, At/PO- Erendra, Ganjam

He has highlighted /demanded the followings:

- a) Industrialization leads to development.
- b) The lessee shall operate this quarry with environment protection, plantation and proper dust suppression measures.
- c) Employment opportunities for the migrant laboureres and local people.
- d) Availability of raw materials for construction of roads and buildings easily at affordable prices.
- e) Extensive plantation in the nearby areas.

4. Smt. Beni Pradhan, At/PO- Jagannathpur, Ganjam.

She stated that the poor villagers will get employment during operation of this quarry therefore they have no objection for the proposed mining.

5. Smt. Jhilli Pradhan, At/PO- Jagannathpur, Ganjam

She supports the proposed mining activity. She further stated that they will get employment opportunity due to operation of this quarry; however the quarry should operate without hampering anybody.

6. Krushna Chandra Pradhan, At/PO- Jagannathpur, Ganjam

He questioned to the Authorities that who will be held responsible if the assurance made by the lessee will not be fulfilled and to whom they will approach for redressal of their grievances.





It is brought to the notice of all concerned that The Tahsildar, Chikiti has proposed to have Environmental Assessment, Girisola Stone Quarry Forver an area of 20.510 Ha. In Village Girisola under Chikiti Tahsil of Ganjam district to obtain Environmental Clearance from State Environmental Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.
