The Panel consisted of the following members:

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Anand Exports.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public

gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Biswa Ranjan Puhan, Representative of the plant addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mishra, ADM, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Smt Manasi Dalai (Sarpanch, Pingal G.P)

She greeted everyone and expressed her support towards the proposed expansion project of M/s Anand Exports.

2. SmtSatyabhama Chakra (Mahila President, Pingal)

She greeted everyone and she expressed gratitude to M/s Anand Exports for provided job to the locals. She hoped that another plant, similar to M/s Anand Exports, would establish in this area and offer jobs for locals. And lastly she requested the Plant authority to look upon the surrounding environment.

3. Sri Smruti Ranjan Jena (Sarapanch, Pankapal G.P)

Welcoming everyone and he stated Mr.JitendraMohapatra, the MD of M/s. Anand Exports, as someone he knew from being a good social worker. He provided assistance to any Pankapal or Pingal panchayat villagers who requested support. Then he added that while they will get opportunities, benefits, and everything else if the plant came, it must operate in accordance with all rules and laws including pollution and the use of ground water and referring the plant M/s. Misrilall Mines Pvt. Ltd. As it's not doing so, but he believes M/s. Anand Export will do.

4. Sri Ajay Kumar Bindhani (Vice Chairman, Danagadi Block)

Greeting everyone he supported the project. He requested Mr.Jitendra Mohapatra (MD) to consider the issue of pollution and local employement.

5. Smt Nirupama Behera (Samiti Sabhya Pingal G.P)

She greeted everyone and expressed her support towards the proposed expansion public hearing of M/s Anand Exports as because it will help in reducing unemployment and enhance development activities in this area. If the plant comes, people will work here, People from this area used to leave their homes and children in search of employment outside of the state.

6. Sri Sarat Bal (Nimapalli G.P)

He thanked everyone and expressed his views toward the plant that the plant is old one and the plant owner is of well-known and no locals ever complained against him & they are supporting their growth and requested for providing local employment and environment. He often gave funds to support local festivals and the work of gods and goddesses.

7. Sri Jayanta Mohanty (Kaitha G.P)

He greeted everyone and expressed his support towards the proposed expansion project of M/s Anand Exports. And requested to provide local employment.

8. Sri AlokBal (Nimapalli G.P)

He greeted everyone and mentioned about a prior public hearing held by M/s. Misrilall Mines Pvt. Ltd. In contrast, everyone is supporting M/s Anand Exports at this public hearing because of the company's MD, Mr. Jitendra Mohapatra, who supervised their employee and interacted with the community. Villages like Nimapalli and Balana may experience pollutants; therefore, they should implement the necessary pollution control measures.

9. Sri Gagan Behera (Golagaon G.P)

He claimed that while they weren't opposing to the unit, he wanted the surrounding communities to gain something beneficial from it. He suggested that in the beginning, those who lose their land to the company should be given job in the plant next to it the peole from nearby area should get job. He expressed his concern for the water crisis of Golagaon village, and stated that 70% of residents had already died as a result of a nearby plant drawing ground water and asked them to use river water instead og ground water. In a public hearing, he acknowledged the company's MD, Mr. Jitendra Mohapatra, for supporting the Plant and helping people and requested to provide locals with jobs and access to water.

10. Sri Bulu Yadav (Pingal G.P)

He greeted the panel, gathering & media. He suggested that water can be taken from the Bramhani River through IDCO instead of the underground source. He then discussed the environmental issues and raised that 670 elephants had died in the past seven years as a result of not being able to obtain their primary food sources, the Banyan and Aswatha trees, so requested to plant Banyan tree. Requested to make three water treatment plants in the villages of Golagaon, Pingal, and Nimapalli and stated for the NCAP programme project, saying that if project performed in this area, local jobs would be available. He told about the pollution that how the cows were unable to graze in the ground. He was informed by the authorities of M/s Anand Exports that Neem trees will be planted from the pingal to the

bangalachhaka as well as Banyan and Aswatha trees within the plant's area and he finally expressed his support for the expansion project of M/s Anand Exports .

11. Sri Pradeep Biswal (Manoharpur G.P)

He expressed his support for M/s Anand Exports' proposed expansion project since it would create job opportunities.

12. Sri Satyabrata Das (Pankapal G.P)

He greeted everyone expressed his support for M/s Anand Exports' proposed expansion project. He asked about what they had done for the tribes that inhabited this area, and asked the Plant's authority to take steps for the good of the tribe's inhabitants.

13. Sri Dillip Ku. Samal (Manoharpur, Pankapal G.P)

He greeted everyone and appreciated the previous speaker for their support of the plant and its ensuing development. He asked the authority to take necessary action in accordance with the production capacity and the molasses to be taken into consideration for storage because the planned briquetting plant used to be a high polluting industry. Only the employees and others nearby will remain safe if the entire operation goes effective. He related the construction of briquettes with furnace erection, thus he suggested the authority to give proper briquette construction priority. He advises the authority to plant 33% of the plantation and requires effective monitoring. He recommended that the authority consider the possibility of using water from a river or canal for plant operations.

14. Sri Pandu singh Khuntia (SarapanchChandia G.P)

He expressed his support from all his villagers for M/s Anand Exports' proposed expansion project and asked to take into consideration the problems related with pollution, peripheral development, and local employment.

15. Sri Budhiram Jarika (SamitiSabhya Chandia G.P)

He greeted everyone and expressed his support for M/s Anand Exports' proposed expansion project.

16. Sri Pradeep Kumar Behera (Chandia G.P)

He greeted everyone and expressed his support for M/s Anand Exports' proposed expansion project because they were very familiar with this plant, they used to perform many social work and help those in need and

requested to consider the plantation, local employment, water quality, pollution and safety of the environment.

17. Sri Trilochan Behera (Chandia G.P)

He greeted everyone. He was concerned about the local employment, plantations, service for cows i.e. cow health camp.

18. Sri Sudam Ch. Nayan (Golagaon G.P)

He expressed his support for proposed expansion of M/s Anand Exports.

19. Sri Pandu Hembram (ChandiaG.P)

He greeted everyone and expressed his support for M/s Anand Exports' proposed expansion project. However, it was required that commitments being verbal or written and to be carried out in reality. He requested for 100% employment in the affected villages, such as Chandia, Pankapal, or Pingal Panchayat in order to show his gratitude.

20. Sri Lalatendu Sahoo (Nilamanideipur G.P)

He greeted the panel, gathering & media and expressed his support for proposed expansion project. He asked the plant's management to hire locals with comparing level of education, support local development and stop the pollution of the air and water. And it was requested that the majority workers /labour class should be hired locally.

21. Sri Madhabananda Behera (Golagaon G.P)

He welcomed the panel, gathering & gave his hundred percent support to the public hearing of M/s Anand Exports. He told that company should focus on Land losers, Plantations, Pollution, Peripherial development. He told that employment & contractual works should be given to land losers.

22. Sri Janmejaya Balasamanta (Nimapalli G.P)

He welcomed the panel, gathering & told that earlier M/s Anand Exports has done many developmental works for local people & now the plant will expand with more capacity. Four numbers 4 MVA Furance, Four numbers 9 MVA Furance, briquetting plant & metal recovery plant will be installed in the proposed expansion. He told that priority should be given to design of plant & proper de-dusting as well as gas cleaning plant for effective pollution control. He told that Nimapalli, Golagaon & Baghabali village will be more affected for the plant. He requested the plant authority to give priority to these three villages as peoples from these three villages will be directly affected by pollution. He told that Nimapalli village is highly neglected village in Kalinganagar area. Only few peoples from Nimapalli villages got employment opportunity. He told that land acquisition has started from their village for Misrilall & Anand Export plant. But Misrilall

plant did not give employment opportunity to villagers of Nimapalli. He requested the plant authority of M/s Anand Exports not to repeat the same with the villagers of Nimapalli & Golagaon as these villages are very nearer to the plant. He told that 300 to 400 numbers of employment will be generated and local people should be given priority so that they will employment opportunity near their home. He gave thanks to all the people present in the public hearing for their support.

23. Sri Ajay Ku. Rout (Pingal G.P)

He welcomed the panel & gathering and requested the plant authority to give priority on water & air pollution, Plantation, Permanent employment to opportunity for unemployed youth of nearby villages. They want the plant should develop in future.

24. Sri Pramod Barik (Nimapalli G.P)

He gave his full support for the plant expansion.

25. Sri Tapan Rout (Pingal G.P)

He & their periphery peoples are happy for expansion of the Beneficiation plant. He gave his full support to the proposed expansion and requested the plant authority give priority to local people's problem & their solution, contractual works & plantation in local villages.

26. Sri Dabur Angrai (Gobarghati)

He gave his full support to the public hearing and told about employment, periphery development, pollution free environment in local villages. He told that they are not opposing the industry but they are against rehabilitation. He told that there will be no rehabilitation in the proposed expansion of M/s Anand export & told that plant should come.

27. Smt Laxmi Balmeik (Baghabahali G.P)

She told that poor people should get benefit from the plant.

28. Sri Parshuram Bindhani (Baghabahali G.P)

He welcomed the panel, gathering & told that earlier local people are going to outside for employment. As the plants are coming, local people from Baghmari village will get employment opportunity near their home & people becomes happy.

29. Sri Debi Prasanna Mohanty (Pingal G.P)

He told that plants are not giving importance to environment which he had told in earlier public hearing of TATA & Misrilall. Priority is not given to local people. He requested ADM to consider the above matter and requested for

plantation in local villages & local employment. He gave his support to the proposed plant.

30. Sri Hemanta Muduli (Nimapalli G.P)

He welcomed the panel and told that they have some issues which should be resolved such as drinking water facility, plantation. He gave his support to the proposed expansion subjected to permanent employment opportunity to villagers of Nimapali, Golagaon & Pankapal.

31. Sri Ramakanta Rout (Pingal G.P)

He gave his support to the proposed plant and requested to give employment opportunity to the villagers of Pingal G.P. He also told that importance should be given to peripheral plantation & pollution issues.

32. Sri Nanda Barik (Pingal G.P)

He told that nobody told against the plant authority as well as local people's representative but he raised question about the Indira Abash have not been provided to them.

33. Sri Bipin Nayak (Golagaon G.P)

He told that plant should come so that unemployment problem would be solved.

The Panel has received 14 numbers of written representations during the hearing. Santosh Kumar Mishra, Additional District Magistrate, Kalinga Nagar asked the project proponent to present their comments to the people with respect to the demands raised by the public in the public hearing meeting. Sri AbhisekRatha, Project Director of M/s Anand Exports made the commitment on the issues raised by the public. The statements of issues and concern of the public with comments of the applicant prepared in English & Odia language are annexed separately. The meeting was ended with tanks to the chair.

Local Employment water harvesting structure over an area of 8 Acre land inside the plant premises and water requirement for plant operation is met from the rain water harvesting structure. Ground water is only used for drinking purpose. He ensured that they will adopt zero liquid discharge and gave assurance that neither waste water nor treated water will be discharged to outside the plant boundaries. Till date they have planted 8000 numbers of trees and in future they will achieve the 33% of plant cover with the supervision of local DFO.

They will implement the world's best technology in order to minimise the pollution. He told that they will adopt bag filter as gas cleaning plant in furnace and in Briquette plant. Stack height will be followed as 35ft. He told that water sprinkling has been done on a regular basis in the existing plant, and in the future they will increase the frequency for the expansion project. Molasses will be stored in closed tank.

He told that their plant is a labor-based plant & ensured that local people from nearby five to seven villages will be given importance. They have prioritised local employment in the past and will continue the same in future. Local villagers from the village Golagaon, Nimapalli, Koitha, Pingal, Nadiabhanga and Kabatabandha are still working in the plant. They will give employment to the local tribal people based on their educational qualification & as per the plant requirement.

He told that they have a cow shed inside the plant premises where they are farming a total 15 numbers of cows with their calves and they are regularly feeding organic foods to the cattle. In near future they will provide a regular health camp.


