**PROCEEDING OF THE PUBLIC HEARING FOR THE PROPOSED PROJECT OF M/S SHREE RADHARAMAN STONE CRUSHER PVT LTD FOR GRANT OF ENVIRONMENTAL CLEARANCE FOR BASENPALI STONE QUARRY OVER AN AREA OF 5.56 HA IN VILLAGE BASENPALI, TEHSIL LAKHANPUR OF JHARSUGUDA DISTRICT HELD AT VILLAGE BASENPALI, TEHSIL LAKHANPUR OF JHARSUGUDA DISTRICT ON DTD.05.07.2023 AT 11.00 AM.**

The public hearing of the proposed Basenpali Stone Quarry of M/s Shree Radharaman Stone Crusher Pvt Ltd for grant of Environmental Clearance for production of building stone over an area of 5.56 Ha in village Basenpali, Tehsil Lakhanpur of Jharsuguda district was held on Dtd.05.07.2023 at 11.00 am at village Basenpali, Tehsil Lakhanpur in the district of Jharsuguda.

Shri Lankeswar Amat, OAS(S), Additional District Magistrate (Revenue), Jharsuguda supervised and presided over the Public Hearing Process, assisted by Er. Hiranya Kumar Nayak, Regional Officer, State Pollution Control Board, Jharsuguda & representative of State Pollution Control Board, Odisha. The State Pollution Control Board, Odisha, Bhubaneswar had advertised in newspaper in Odia daily – Prameya on 03.06.2023 and in English daily-The Times of India on 03.06.2023. The Public Hearing in respect of the above project stated as per the schedule and the venue decided by the District Magistrate & Collector in accordance with the EIA Notification S.O.1533(E), dated 14.09.2006. The attendance sheet of the panel members present in the public hearing is annexed as **Annexure – I**. Around 119 persons had attended the public hearing meeting and the attendance sheet of the public participants attended the public hearing is annexed as **Annexure-II**.

At the outset, Er. Hiranya Kumar Nayak, Regional Officer, SPCB welcomed the panel member and the public presented in the meeting. He briefly described the objectives and procedure followed for conducting the Public Hearing as per the EIA Notification S.O.1533(E), dated 14.09.2006 of Ministry of Environment, Forest & Climate Change (MoEF&CC), Govt. of India. He requested Additional District Magistrate, Jharsuguda to preside over the meeting.

Welcoming the panel members and the assembled public in the meeting, Shri Lankeswar Amat, ADM, Revenue, Jharsuguda, explained the objective of the proposed Basenpali Stone Quarry. He asked the Project Proponent to make a brief presentation before the public gathered in the meeting about the proposed Basenpali Stone Quarry.

Lankeswar Amat

On behalf of the Project Proponent, Sri Ramesh Kumar Mohanty of Basenpali Stone Quarry welcomed the public and all other participants. He informed that the Project Proponent has applied to the Government for the approval of the proposed stone quarry and the meeting is being conducted for the public views to process the application for Environmental Clearance. He invited the representative of the Kalyani Laboratory Consultancy to give a brief description of the proposed quarry to the public. Sri Jagabandhu Bisoi, presented the brief of proposed project in Odia language which are as follows:-

- As per Ministry of Environment, Forest and Climate Change, Govt. of India, EIA notification (2006) and subsequent amendments, Environmental Clearance is required for the proposed Basenpali Stone Quarry of M/s Shree Radharaman Stone Crusher Pvt Ltd having maximum annual mining capacity of 61,812 cubic meters of which 55631 cum/annum of building stone and 6,181 cubic meters/annum of waste stone will be produced over a lease area of 5.56 Ha at Basenpali village, Tahasil Lakhanpur in the district of Jharsuguda and public hearing is a part of the process. M/s Shree Radharaman Stone Crusher Pvt Lt has appointed M/s Kalyani Laboratories Pvt.Ltd to get Environment Clearance for Basenpali Stone Quarry and the EIA/EMP report has been prepared between October 2020 and December 2020. Mining plan of Basenpali Stone Quarry has been approved by Dy. Director of Geology, Sambalpur on dtd. 17.05.2018 and the mining lease area is featured in the Survey of India Toposheet No. F44R9/64O/9). Tahasildar, Lakhanpur has given letter to Shree Radharaman Stone Crusher Pvt Lt vide letter no 162, dtd:-08.01.2018 to submit the required documents before starting the mining activity.
- As per the estimation, the geological reserve for stone is 976557 cum and mineable reserve is 596203 cum. Within five years, a total of 307530 cum of stone will be excavated, of which 276777 cum will be building stone and 30753 cum will be waste. The total amount excavated stone will be used for road and house construction. Excavation of stone quarry will be carried out by semi-mechanized method of mining and will be handled using jack hammers and excavators. Short hole blasting method will be carried out. Local people will have the opportunity to work on the proposed project based on their merit. There will be direct employment opportunities for 12 people and indirect employment opportunities for approximately 100 people.
- The baseline study was conducted within 10 km radius of the project site. Monitoring of ambient air, water, noise, soil etc was conducted at 06 different locations, and samples

Retaining wall and Check-dams will be constructed along the garland drain to arrest the solid wastes. Rain water harvesting structure will be constructed and the stored water will be used during mining activity.

- As per mine rules and regulations, the health of the mine workers will be taken care properly. According to the Government of India notification dated 30.9.2020, the lessee will bear all the costs for the development of the surrounding area and environment. In addition, the lessee will incur the expenses mentioned below: -

1. Plantation will be done at both side of the road connecting from village to the main road (2.5 km) amounting to Rs. 2 lakhs.
2. Periodical health check-ups for the local people amounting to Rs. 2.50 lakhs.
3. 08 nos of street light will be provided for Basenpali Village amounting to Rs. 1.50 lakhs.
4. Repairing of local roads amounting to Rs.1.50 lakhs.
5. Construction of rainwater harvesting structure at the local school amounting to Rs. 1.00 lakhs.

Therefore, the total expenses incurred will be amounting to Rs 8.50 lakhs.

- For the implementation of the environmental management plan and social development of the village, a committee will be formed consisting of local representatives and Gram Panchayat. This committee will regularly review the improvement works for the overall development of the area and will be responsible for the social and economic growth of the area.

Then Shri Lankeswar Amat, Additional District Magistrate, Jharsuguda, invited the public to present their views on the proposed quarry in a peaceful manner. Thereafter, the public deliberated on the various issues one by one. During public hearing, everyone had the opportunity to freely express their opinions on the proposed project. About 17 people expressed their views, the attendance sheet of the public participants who delivered their views is annexed as **Annexure-III**. The statement of public participated in the deliberation is annexed as **Annexure-IV**. After the deliberations were made by the public, Regional Officer, State Pollution Control Board, Jharsuguda invited the project proponent to offer the views on the issues raised by the public. The summary of the views and opinions of the public and the commitments made by the project proponent are annexed in English and Odia language as






