

PROCEEDINGS OF THE PUBLIC HEARING FOR GRANT OF ENVIRONMENTAL CLEARANCE FOR THE PROPOSED JAMUNANAKI SAND QUARRY-II OF SRI SHANKAR PUJHARI OVER AN AREA OF 6.515 HA. (COMING UNDER CLUSTER WITH TOTAL LEASE AREA 13.394 HA.) BEARING KHATA NO. 75, PLOT NO. 405/1 & 405/415/P IN VILLAGE JAMUNANAKI UNDER KUARAMUNDA TEHSIL OF SUNDARGARH DISTRICT HELD ON DATED 22-06-2023 AT 10:00AM AT COMMUNITY CENTER, VILLAGE JAMUNANAKI, TEHSIL-KUARAMUNDA, IN THE DISTRICT OF SUNDARGARH

The public hearing for grant of Environmental Clearance for the proposed Jamunanaki Sand Quarry-II over an area of 6.515Ha. (Coming under cluster with total lease area 13.394 Ha.) bearing Khata no. 75, Plot no. 405/1 & 405/415/P in the village Jamunanaki under Kuaramunda Tehsil of Sundargarh District held on dated 22-06-2023 at 10:00AM at Community Centre, Jamunanaki village of Kuaramunda Tehsil of Sundargarh District. Sri Abhimanyu Majhi, Sub-Collector, Panposh, supervised and presided over the public hearing process. Dr. Anup kumar Mallick, Senior Environmental Scientist and Regional Officer, State Pollution Control Board, Odisha, Rourkela delivered welcome address, organized and conducted the public hearing meeting in association with the District Administration.

The Public Hearing in respect of the above proposed Jamunanaki Sand Quarry-II was held as per the schedule and the venue decided by the District Administration in accordance with the EIA Notification S.O.1533 (E) dated 14.09.2006 and subsequent amendment therein. State Pollution Control Board, Odisha, Bhubaneswar had advertised in the newspaper in Odia daily-Prameya on dtd 18.05.2023 and in English daily- The Times of India on dtd. 18.05.2023 regarding an announcement of public hearing venue, date and timing. The Public Hearing meeting with regards to date, place and time was announced in public address system apart from its publication in local dailies. The Attendance sheet of the public attended the public hearing is annexed as **Annexure – I**. Around 58 Nos. of persons had attended the public hearing meeting whereas 10Nos. persons had delivered their views whose list is annexed as Annexure II.


At the outset, Dr. Anup Kumar Mallick, Senior Environmental Scientist, Regional Officer, State Pollution Control Board, Odisha, Rourkela welcomed the Official members and the public presented in the meeting. He briefly described the objectives and procedure followed for conducting the Public Hearing as per the EIA Notification S.O.1533 (E) dated

14.09.2006 of Ministry of Environment, Forest & Climate Change (MoEF&CC), Govt. of India. He also explained about the importance of such public hearing for the proposed Jamunanaki Sand Quarry-II over an area of 6.515Ha.(Coming under cluster with total lease area 13.394 Ha.)for grant of Environmental Clearance. He invited views, comments, objections & opinions of the public which are necessary while considering the Environmental Clearance of the project and he also told that those who want to give their written statement about the proposed projects, they can do so during the public hearing process. He requested Sub-Collector, Panposh to preside over the meeting.

Welcoming the public, the official members, Press Media, Police Officers and the assembled public in the meeting, Sri Abhimanyu Majhi, Sub-Collector, Panposh, briefly explained about the purpose of the public hearing of the proposed Jamunanaki Sand Quarry-II over an area of 6.515ha. (Coming under cluster with total lease area 13.394 Ha.) bearing Khata no. 75, Plot no. 405/1 & 405/415/P in the village Jamunanaki under Kuaramunda Tehsil of Sundargarh District. He also described the importance of environmental impact studies carried out for the proposed Sand Bed and the views, comments, objections and opinions of the public which are necessary while considering the Environmental Clearance of the project. He said that the project proponent will present the summary of Environmental impact studies for the proposed project for the knowledge of the Public. He invited the villagers to present their views, opinions & objections about the proposed project on Environmental consideration. He also told that the public can also submit written representations. The proceeding along with video recording of the meeting will be forwarded to the Government for further decision-making process for grant of Environmental Clearance. He requested the Regional Officer, SPCB, Odisha, Rourkela to carry out further proceeding of the meeting.

Regional Officer, S.P.C.B., Odisha, Rourkela requested the Project Proponent of proposed Jamunanaki Sand Quarry-II to make a brief presentation before the public gathered in the meeting about the details of Environmental Impact Assessment report of the proposed project in a simple summarized manner for better understanding of the Public.

On behalf of the Project Proponent, Sri Subham Ranhan Mahanta, M/s. P & M Solution welcomed the official members, public and all other participants and gave a brief description about Jamunanaki Sand Quarry-II. He presented the salient features of the proposed Sand Quarry which are as follows:

- The Jamunanaki Sand Quarry-II is located at Khata No.75, Plot No.405/1 & 405/415/P, Village- Jamunanaki, Tehsil- Kuaramunda, District- Sundergarh, State- Odisha over an area of 6.515 ha.
- TOR has been granted by SEIAA -Odisha prescribed the Reference No.4569/SEIAA dtd.19.05.2022.
- As per the EIA notification 2006 and its subsequent amendment, proposed project fall in category B1.
- He presented the possible impact on the environment due to Sand excavation and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.
- The proposed mining activities of loading and movement of the transport vehicles used in mining will generate dust. Hence adequate water sprinkling will be carried out at the mine site. The mineral will be transported by road through covered tarpaulin trucks/ tippers to reduce the fugitive emission.
- No mining activities shall be carried out during the monsoon season as it will create ecological imbalance. Mining will be carried out only in the dry part of the Koel River
- The systematic and scientific removal of sand will be carried out to minimize bed degradation. The slit and clay generated as waste will be used for plantation or filling up low lying area.
- The transporting vehicles will be maintained in good condition to minimize the effect of noise.
- Health facilities will be provided to the workers and surrounding people in the impact area to reduce health impacts.

Then Regional Officer, S.P.C.B., Rourkela thereafter invited the public to enter their names to put forth their views, suggestion, comments and objections on matters relating to the environmental aspects of the project. Then the public deliberated on various issues one by one which are given as follows:

1. Sri Samim Khan, Village-Jamunanaki:

He greeted & welcomed the members, gathered public and all other participants in the meeting. He supported the proposed Sand Quarry. He stated that excavated sand should be provided to the villagers at cheaper rate.

2. Sri Hiralal Chaurasia, Village-Jamunanaki:

He greeted & welcomed the members, gathered public, electronics media and all other participants in the meeting. He supported the proposed Sand Quarry. He requested project proponent to do regular water sprinkling to suppress dust pollution. He also requested to take preventive measures for spillage of sand on the road by the transporting vehicles.

3. Sri Ram Singh, Village-Jamunanaki:

He greeted & welcomed the members, gathered public and all other participants in the meeting. He stated that supply of drinking water is still not available to villagers of Jamunanaki. He suggested to dig borewells for availability of drinking water. He expressed that approach roads connecting to Jamunanaki Sand Quarry are still earthen due to which they are facing problems during monsoon. He also insisted to mark an area for municipal solid waste dumping.

4. Sri Uttam Topno, Village-Jamunanaki:

He greeted & welcomed the members, gathered public and all other participants in the meeting. He supported the proposed Sand Quarry. He stated that how the villagers are facing problems by transporting sand from other areas as transporting charge costs more to them. He hoped that proposed sand quarry will provide at concessional rate to the villagers after functioning of the Quarry.

5. Sri Sabir Kangadi, Village-Jamunanaki:

He greeted & welcomed the members, gathered public, villagers and all other participants in the meeting. He insisted to sprinkle water regularly on the road during movement of vehicles. He demanded to take measures to reducedust pollution and to make the earthen road to concrete road.

6. Sri Subash Chandra Swain, Village-Jamunanaki:

He greeted & welcomed the members, gathered public, villagers and all other participants in the meeting. He insisted to sprinkle water regularly on the road during movement of vehicles. He requested the lessee to undertake plantation programme in the vacant area of mines to reduce the impact of rise in temperature in Summer. He supported the proposed Sand Quarry.

7. Sri Dilip Dumdung, Village-Jamunanaki:

He stated that sand to the villagers should be provided at a cheaper rate.

8. Smt. Satyabati Sandha, Village-Jamunanaki:

She greeted & welcomed the members, gathered public, villagers and all other participants in the meeting. She stated the local villagers are facing difficulties in getting proper drinking water and scarcity of water in day to day activities. She insisted District Administration to provide drinking water facility to the villagers.


9. Sri Rohit Prasad, Village-Jamunanaki:

He supported the proposed Sand Quarry. He requested to make the village road concrete for better movement of vehicles.

10. Sri Sahadev Ray, Village-Jamunanaki:

He greeted & welcomed the members, gathered public and all other participants in the meeting. He supported the proposed Sand Quarry. He requested to construct an amusement park for children in the village.

During the public hearing, all have been given an opportunity to express their views freely on the proposed project. The video recording of the entire proceedings of the public hearing was done and is annexed herewith. 10nos. of persons had delivered their views. After the deliberations were made by the public, Regional Officer, State Pollution Control Board, Odisha, Rourkela summarized on the issues raised by the public and invited the project proponent to submit their response & commitments on the issues raised by the public. The summary of the views and opinions of the public and the commitments made by the project proponent are annexed in Odia language and English language as Annexure A & B respectively which were read before the audience in Odia language in public hearing meeting. Finally, the meeting ended with vote of thanks to the chair, public and other participants.


