PROCEEDINGS OF THE PUBLIC HEARING OF M/S BHUBANESWARI GRANITES OVER AN AREA OF 10.522 HA AND M/S KPK GRANITES OVER AN AREA OF 14.016 HA (TOTAL CLUSTER AREA OF 24.538 HA) IN VILLAGE MAJHIGUDA NO. 57 UNDER KHAIRAPUT TAHASIL OF MALKANGIRI DISTRICT HELD ON 23.08.2023 AT 11:00 A.M. IN MAJHIGUDA VILLAGE (KHATA NO. 62 PLOT NO. 23, KISSAM- BAGAYAT) OF MALKANGIRI DISTRICT

The public hearing in respect of the above project was held on 23.08.2023 as per the schedule time and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in villages coming under Khairaput Gram Panchayat of Khairaput Tahasil area of proposed project site and also published in Daily News Paper. Due process was followed during public hearing.

Er D. K. Biswal, Regional Officer, State Pollution Control Board, Koraput welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Trinath Majhi, OAS (S), Additional District Magistrate (General), Malkangiri presided over and supervised the public hearing. He briefed about the importance of such hearing and invited the project proponent to highlight on the proposed project.

Sri Chinmaya Das, Partner of M/S Bhubaneswari Granites has explained about the proposed project and briefed about the Environment Management Plan and socio-economic development of proposed plan.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Koraput.

1. Smt. Susmita Badam, Majhiguda, Khairaput

Smt. Badam introduced herself as resident of Majhiguda village. She welcomed the project and said that by the commencement of this project they don't need to go to other states in search of work and can stay with family in their own village. She added that they will get many facilities due to the project.

2. Smt. Kamala Guta, Majhiguda, Khairaput

Smt. Guta introduced herself as ward member of Majhiguda. She welcomed the project by stating that with the help of the project females of their village will get many facilities.

3. Smt. Subarna Khilla, Majhiguda, Khairaput

Smt. Khilla welcomed the project and appealed others present during the hearing to support the project.

4. Smt. Padma Badam, Majhiguda, Khairaput

Smt. Badam informed that she is a native of Majhiguda village. She supported the project and was hopeful that they and their children will get many facilities from the project.

5. Sri Guru Gutha, Majhiguda, Khairaput

Sri Gutha introduced himself as native of Majhiguda village. He extended his support for the project. He said that earlier they used to leave family in search of work. Now he wished that they could get employment in their own village because of the project.

6. Sri Bighnaraj Kirsyani, Majhiguda, Khairaput

Sri Kirsyani informed that he is the Block Chairman of Khairaput and hailed from Majhgiguda village. He stated that many villagers were benefitted due to operation of stone mines in places like Semiliguda, Damanjodi, in the district of Koraput. So he was hopeful that the villagers won't have to go in search of work to places like Andhra Pradesh, Tamil Nadu etc. He was optimistic that the company will fulfil all its promises explained by the project proponent.

7. Sri Manoj Kumar Sahu, Khairaput

Sri Sahu introduced himself as resident of Khairaput GP. He expressed his happiness for the project stating that they will get employment, can stay with family avoiding going to other states and earn for their livelihood. He was hopeful that their future generation will also get employment if the project sustains for a longer period of time.

8. Smt. Daimati Golpeda, Khairaput

Smt. Golpeda introduced herself as the Sarpanch of Khairaput GP. She said that by the operation of this mine people of the Gram panchayat will get employment, educational facilities, medical facilities, water, roads for better communication etc. She welcomed the project.

9. Sri Budu Khila, Majhiguda, Khairaput

Sri Khila introduced himself as resident of Majhiguda village. He expressed his sadness over the unavailability of jobs in his village, due to which even educated children of their village are going to Andhra Pradesh as labour to earn money and are facing various challenges there. So, he said that villagers are eagerly waiting for the mine to come into operation so that they will not remain jobless anymore. He concluded by supporting the project.

10. Smt. Padmini Jala, Majhiguda, Khairaput

Smt. Jala welcomed the project. She wished that the farming land of her father will not get affected by the operation of this project. She added that villagers will get employment in the mine which will lead to overall development of their village.

11. Sri Pitabas Patra, Kumbharput, Khairaput

Sri Patra introduced himself as the resident of Kumbharput village. He wished that no land will get harmed due to the operation of the mine. He said that if ever any damages occur, provisions shall be made to give them compensation by the project proponent. He was hopeful that his son will be employed in the project. He concluded by supporting the project.

12. Sri Chandra Sekhar Majhi, Majhiguda, Khairaput

Sri. Majhi informed that he is a resident of Majhiguda village. He expected that the problems that the villagers are facing due to shortage of water will be resolved due to this project. He wisned that all the 90 families of the village will get employment as per their individual capabilities. He insisted the project proposent to fulfil all the promises made.

13. Sri Sanjaya Kumar Sahu, Khairaput

Sri. Sahu requested the company to engage drivers of the village for the transportation activities of the mine. He welcomed the project.

14. Sri Giri Prasad Raju, Khairaput

Sri Raju introduced himself as resident of Khairaput village. He suggested the company to engage drivers of local village rather than from outside sources. He advised the company to provide proper salary as per the Govt regulations. He wished the improvement of the village in the field of education and health care facilities. He supported the project.

15. Sri Sadan Khara, Bisoiguda Khairaput

Sri. Khara introduced himself as resident of Bisoiguda village. He wished that the farming land of his father will not get effected by this project.

16. Sri Tapan Samarath, Khairaput

Sri. Samarath informed that he belongs to Khairaput village. He showed his concern about the old trees present in the village that provide ample oxygen. He insisted company to plant more number of trees for better oxygen supply.

The Regional Officer, SPCB, Koraput read over the issues raised by the public in the hearing and Sri Chinmaya Das, Partner of M/S Bhubaneswari Granites responded to the issues raised for mining project.

Shri Trinath Majhi, OAS (S), Additional District Magistrate (General), Malkangiri has given concluding remarks on the hearing and elaborated the process to be followed for submission of the proceeding to the SEIAA, Bhubaneswar for further action. He extended thanks to the public especially to the females participated in the hearing and for offering their valuable views and suggestions.

The issues raised by the public and corresponding comments of the applicant are prepared in Odia and English language and are annexed with the proceedings as Annexure-I & II respectively. List of the oral deliberators and participants in the hearing is annexed as Annexure-III & IV respectively. The videography of proceedings are recorded and submitted as DVD.


