

**PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF KUSHABHADRA RIVER SAND QUARRY OVER AN AREA OF 16.25 Ha AT MOUZA KESURA UNDER BHUBANESWAR TAHASIL HELD AT ANTARJAMI HIGH SCHOOL AT BANKUA, KESURA UNDER BHUBANESWAR TEHSILOF KHORDHA DISTRICT**

The Public Hearing meeting in respect of environmental impact assessment of Kushabhadra River Sand Quarry of the Tahasildar, Bhubaneswar over an area of 16.25 hectare or 40.16 Acre at mouza Kesura under Bhubaneswar tahasil was held on 09.07.2023 at 11.00 am at Antarjami High School under Bhubaneswar tahasil of Khordha district, Odisha with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

At the outset, Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Bhubaneswar Regional Office on behalf of State Pollution Control Board, Odisha welcomed the guests, dignitaries, public and other members present in the meeting. The meeting was presided over by the Sub-Collector, Bhubaneswar on behalf the District Administration, Khordha.

Dr. Sohan Giri, being the Representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing as has been cited in the EIA Notification, 2006 and interim operational guidelines till date, along with Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III Dated. 09/06/2021 and the modalities to be followed for conducting the public hearing meeting in respect to sand mine project proposed by Tahasildar, Bhubaneswar.



Welcoming the public, the Regional Officer, State Pollution Control Board, Odisha, Bhubaneswar, highlighted about the aim and objective of the public hearing and invited the views, comments/opinions from the local public w.r.t the environmental clearance of the project. Then the Regional Officer requested to Sri Debabrata Sahoo, Sub-Collector, Bhubaneswar to preside over the public hearing meeting.

In his presentation Sri Sri Debabrata Sahoo, OAS(1)SB, Sub-Collector, Bhubaneswar presided over the meeting, highlighted the purpose of the meeting and the procedure to be maintained by the gatherings till completion of the public hearing.

Then, the Regional Officer invited the project proponent to put forth the details of the proposed project i.e. areas to be mined out, mining procedure to be followed, environment impact, restoration, peripheral development to be taken up for the benefit of local public.

The environmental consultant of the project proponent/Lessee of the aforesaid quarry M/s Kalyani Laboratories Pvt Ltd on behalf of the proponent i.e Tahasildar Bhubaneswar addressed the committee members and assembled public and gave a brief description about the proposed project (Sand Quarry). He also briefed about for Kushabhadra River Sand Quarry over Kushabhadra river, about an area of 16.25Ha. At/Mouza- Kesura village under Bhubaneswar Tehsil of Khordha District. He also briefed about the peripheral development work that had been taken up in this area, and made a presentation about the environmental management, pollution control measures, solid waste-management of the related project. He also explained about the various aspects to be covered up during of the operation of proposed project i.e. benefits to be provided to the local daily labourers, peripheral development activities to be taken up etc. He had also invited the opinion and objection of the public present in the public hearing and had sought their co-operation for smooth implementation of the project.

Then Shri. Pradeep Kumar Sahoo, OAS, Tahasildar, Bhubaneswar in his speech had put forth his view about the proposed land mining project that :-

For Khushabhadra River Sand Quarry, the proposed mining activities will be carried out over an area of 16.25 ha in the village Kesura under Bhubaneswar Tahasil . He



had appraised off that to obtain Environment Clearance from SEIAA, Odisha this public hearing is being conducted for which also EIA & Environment Management plan has also been prepared by NABL and empanelled consultant of MoEF. Also, Tahasildar, Bhubaneswar appraised to the public that lease of Khusabhadra River Sand Quarry has been granted in favour of Sri Sikhar Chandra Jena (Successful Bidder) and is authorised to operate the said mining project for 5 years after receiving all statutory clearances from different authorities. He requested the public present in the hearing to present their opinion & view regarding Environmental Impact that will be created during the mining period.

After the completion of deliberations, Dr. Sohan Giri requested the public present at the meeting of the area to put forth their views, comments, objections, and opinions etc. about the commencement of the proposed sand mining project.

**The following speakers gave their views on the above said project, which are stated as follows:-**

<b>01</b>	<b>Sri Gautam Pattanaik (Koradakanta Village)</b>
	Sri Gautam Pattanaik had enquired to know whether the lease and the Tender process has been finalized and on which date. Then he had emphasized on the road condition of their village which may impact due to running of sand carrying vehicles and also stated about probability of accidents which would occur due to plying of heavy vehicles. He also stated that due to sand transportation previously fugitive dust emission occurred which created problems for villagers. He suggested to widen the roads.
<b>02</b>	<b>Sri Mitun Nayak (Koradakanta Village)</b>
	Sri Mitun Nayak stated that in their locality there are five schools existing and students generally play outdoor games at a playground which is located near to the road side, so he disagreed with the upcoming sand quarry project and requested to stop the further process for grant of lease.
<b>03</b>	<b>Sri Kalandri Maharana (Koradakanta Village)</b>
	Sri Kalandra Maharana had put forth his views that during operation of the sand mining the transportation of sand will be done many numbers of Hywas(Tippers) from morning to evening which will create air pollution, eco system will be

	affected , day by day the water level will be lower down, the roads would be damaged and on the whole the total environment will be deteriorated.
04	<b>Riyazuddin Khan (Jharpada)</b>
	Sri Riyazuddin Khan had opined that the people are procuring the sand from Cuttack river side for which the people this area are paying more money for construction their houses. He supported this project and stated it should be approved and the sand mining should operate immediately.
05	<b>Dharani Dhara Jena (Jharapada)</b>
	Sri Dharani Dhara Jena in his views had highlighted in favour the project and stated that with the operation of the quarry, all the local people will be benefited by getting the sand in cheap rate and presumed that during the operation of the project no villagers face any difficulties and loss in their area.
06	<b>Shri Ananta Behera (Koradakanta)</b>
	Sri Ananta Behera put forth that in their area nearby to the mining source there are five schools. He enquired that who will be responsible for any untoward incident happening with lives of children during the transportation of the sand laden trucks. He further stated that the transportation of sand by the trucks should not be operated through their village road.
07	<b>Sri Manoranjan Swain (Kesura)</b>
	Sri Manoranjan Swain had focused on some of the issues and asked the lessee of the sand quarry if he can give guarantee to look after the safety of their children then this source may be operated and transportation of sand can be carried out. He suggested that the transportation of sand carrying vehicle should not be operated during night time. If the source will be operated the nearby vegetations will be completely perished. So, the domestic animals i.e. cows, goats etc will not get their daily food requirement.
08	<b>Sri Sanyasi Sahoo, (Bankual)</b>
	Sri Sanyasi Sahoo expressed in favour of the project that if the source will be operated the local people will get the requirement of sand in cheap rate and support the project.




09	<b>Shri. Bikram Kumar Sethy (Kesuras – Sarapanch, Basuaghai)</b>
	Sri Bikram Kumar Sethy had placed his views in favour of the project i.e. the mining source should be operated so that the local people can get the demand of sand in chief rate, all the local people will get their benefit, the development will be done in their areas, Govt. will get the revenue, the water level during mining will not be affected.

After the deliberation by the local people present in the public hearing, Dr. Sohan Giri, Regional Officer, State pollution Control Board, Bhubaneswar had invited the Tahsildar, Bhubaneswar to highlight about the action to be taken w.r.t Environmental Protection to the nearby areas during the operation of the sand mining source. After the completion of deliberation by local villagers, the Tahsildar, Bhubaneswar assured that all the rules and guideline will be followed by the lessee during transportation of vehicle from the source through their village road. With his reply Tahsildar Bhubaneswar then instructed the consultant of the project i.e. M/s. Kalyani Laboratory Pvt. Ltd, Bhubaneswar who has prepared the executive summary of the proposed project to highlight about the issues raised by the public and how those issues will be addressed as follows :-

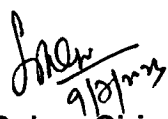
- 1) The local people will get employment by transportation through engagement of the trucks, tractor and hywa etc. and it was assured that sand laden trucks would be covered by the tarpaulin. The speed of the sand laden vehicle would be capped to 10 kmph within the village road.
- 2) During operation of the source the lessee will look after the protection of environment i.e. air, water, soil and there will no impact on the water level of the river bed within the source area.
- 3) There will be regular health checkup of the people those who will work during the source operation.
- 4) During transportation of vehicle from the river embankment through the village road water sprinkling will be done at regular interval throughout the day to suppress the fugitive dust.
- 5) All the vehicles will be provided with necessary permit for their movement from the main road to the source side.
- 6) After proper discussion with the local representative all the developmental will be done in the local areas.
- 7) During the sand mining operation the lessee of the project will follow all the guidelines.

Then Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Bhubaneswar invited and requested the Sub-Collector, Bhubaneswar to highlight about the project and to give the concluding remark about the public hearing. Then Sub-Collector thanked all the participants present in the public hearing and informed to the public

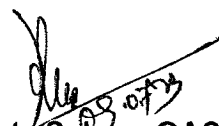



that the lessee has been finalized that who will operate the source for coming five years. The deliberation given by the speaker will be surely addressed by the lessee during the mining period all the guidelines will be followed as per the norms of the SEIAA otherwise heavy penalty will be imposed on the lessee by the Govt. The entire deliberation of the public hearing has been video recorded and finalization of the proceedings that will be communicated to SEIAA, to the Ministry of Environment Forest and Climate Change, Govt. of Odisha for necessary action at their end. At last the meeting ended with vote of thanks to the chair and to the participants present by Dr. Sohan Giri. Regional Officer, state pollution Control Board, Odisha, Bhubaneswar.

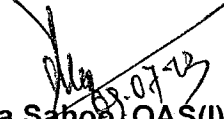

<p>Following issues are raised by the public hearing meeting are as follows relating to peripheral development, local Employment, Environment related factors:-</p> <ol style="list-style-type: none"> <li>a) Development of road condition from river embankment to village road and finally upto main road for easy movement of vehicle.</li> <li>b) Suppression of fugitive dust during transportation of sand carrying vehicle</li> <li>c) Declaration of sand extraction with death for restoration of ground water level.</li> <li>d) Prohibition of transportation of sand loaded vehicle during night time.</li> <li>e) Safe driving of loaded vehicle near by the School area within village road and providing safety to the life of School going children i.e. lease to keep vigilant on the vehicle movement.</li> <li>f) Preference to be provided for employment facility to the local labour class people during mining period.</li> <li>g) Playground of the village children to be protected near river side.</li> <li>h) Road from embankment upto main road via village road should be widen.</li> </ol>	<p>In reply to the issues raised by the public, the Tahasildar Bhubaneswar had invited the consultant of the said mining excavation project i.e. to Sri Mrityunjay Das of M/s. Kalyani Lab. Pvt. Ltd., Bhubaneswar to place the proposal cited in the project summary those will be carried out during the entire mining period are as follows:-</p> <p>In his reply Mr. Das appraised off before the public present in the meeting that :-</p> <ol style="list-style-type: none"> <li>a) Preference will be given to local people employment during loading and unloading of sand in the vehicle.</li> <li>b) Transportation road condition within village area from river side will be developed.</li> <li>c) Speed of the vehicle carrying sand will be regulated i.e. 10 Kmph.</li> <li>d) Efforts/attention will be put forth for protection of water, air &amp; soil quality around the periphery of the nearby mining area.</li> <li>e) There will no impact on ground water level due to excavation of sand from riverbed.</li> <li>f) Regular health checkup of the daily labor.</li> <li>g) Regular water sprinkling on the transportation road to suppress the fugitive dust.</li> </ol>
