PROCEEDINGS OF THE PUBLIC HEARINGFOR DEOGAON SAND QUARRY, DEOGAON OF SRI PRAVAT SAHOO OVER AN AREA OF 7.138 HA. AT VILLAGE DEOGAON UNDER PATNA TAHASIL OF KEONJHAR DISTRICT HELD ON 10.05.2023 AT 11.0 AM AT VILLAGE DEOGAON KHATA NO. 47(AIA), PLOT NO. 261, KISSAM-BIALI, PROPOSED AREA- AC.920 IN THE KEONJHAR DISTRICT.

The public hearing in respect of the above project was held on 10.05.2023 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Ghasiram Murmu, O.A.S (SAG), Project Director, District Urban Development Agency, Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Pravat Sahoo, Lessee of the sand bed explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

# 1. Sri Janardan Panigrahi, Deogaon, Rajnagar

Sri Panigrahi while supporting the public hearing stated that Government has auctioned the sand bed which is beneficial for the Deogaon villagers. This is certainly a welcome step by the Government but there is no road for transportation of sand. The existing road is unfinished. So, he requested the administration to identify an alternate rout for transportation of sand, so that the owner of sand bed can earn some profit out of this project. At the same time, he requested to carry out river side plantation and water sprinkling on the haul road to control pollution.

# 2. Sri Ugrasen Matia, Rajnagar

Sri Matia while opposing the proposed project informed that there is one religious Temple (PrabhunathJi Matha) accredited by tourism department. This Matha is situated at riverside and due to extraction of sand from the riverbed, there is possibility that Matha will collapse. So, he requested administration to inspect the site and subsequently take appropriate decision.

# 3. Sri Sudhansu Naik, Sarpanch, Rajnagar GP

Sri Naik while supporting the public hearing stated that they are fortunate that Government has decided to award extraction of sand. He requested to provide sand to PM Awas beneficiaries at reasonable rate for construction of their houses. He requested to complete the unfinished road and give importance for water sprinkling to control dust. Lastly, he requested administration to give attention for all the issues of the villagers.

#### 4. Sri Manoj Kumar Naik, Deogaon

Sri Manoj while supporting the public hearing requested for do riverside plantation, water sprinkling on the haul road, provide sand to PM Awas beneficiaries in reasonable price.

## 5. Sri Mohan Naik, Rajnagar

Sri Naik while supporting the public hearing demanded for construction of 2 Nos. of bridge and repair the road & to look after the issues of the villagers.

# 6. Sri Somra Naik, Deogaon

Sri Naik while supporting the public hearing informed about the bad road condition. There are potholes all over the roads. He said that till now concreting of the road has not been done.

# 7. Smt. Namita Naik, Deogaon

Smt. Naik while supporting the public hearing informed that Sri Prabhat Sahoo who has been awarded the lease has done a lot for them. He has been doing water sprinkling on the road to control dust which the local Panchyat is not at all giving attention. She requested to complete the unfinished road.

#### 8. Sri Laxmindhar Naik

Sri Naik claimed that he has land at the sand bed mining site & losses his land. He will show the land record. Every where there is corruption. Nobody has given a single rupee to him.

# 9. Ms. Smrutirekha Naik, Deogaon

Ms. Naik while supporting the public hearing requested all the women present to control their children from chasing the sand loaded trucks. Any time accident can occur, and their parents will be responsible for any untoward incidents. Lastly, she informed that there is no road from Deogaon village to River, hence she requested to resolve this issue.

## 10. Sri Daitari Naik, Deogaon

Sri Naik requested administration to identify the land for construction of road because Deogaon Committee members are capable to do the road construction job.

#### 11. Sri Anup Naik, Deogaon

Sri Naik while supporting the public hearing informed that the residents of Rajnagar are opposing but they have nothing to do with this project. He also informed that excavation is not being done on the dike, so there is no possibilities of damage to the temple.

#### 12. Sri Biswanath Naik, Deogaon

Sri Biswanath while supporting the public hearing requested to provide road upto River side so that residents of Rajnagar will not oppose. He requested for water sprinkling on the haul road and plantation alongside the dike so that the dike will remain intact. He rejected the apprehension of damage to the structures adjacent to the riverbed.

# 13. Smt. Rebati Panda, Ward No.7, Rajnagar

Smt. Rebati while supporting the public hearing requested to water sprinkling on the haul road to control dust. Secondly, she requested to alert everybody to restrain from creating disturbance and throwing stone to the vehicles.

#### 14. Sri Pahala Naik, Deogaon

Sri Naik expressed that he is not getting any share out of this excavation job even though he has land property in this village. He demanded for construction of the road.
