PROCEEDINGS OF THE PUBLIC HEARING FOR SOMAKOI SAND QUARRY, DOBALAPAL OF SRI KUNA SAHU OVER ML AREA OF 5.147 HA. AT VILLAGE DOBALAPALUNDER TELKOI TAHASIL OF KEONJHAR DISTRICT HELD ON 06.05.2023 AT 11.0 AM AT VILLAGE DOBALAPAL KHATA NO. 213, PLOT NO. 1038, KISAM- PATITA, PROPOSED AREA- AC. 1.59 IN THE KEONJHAR DISTRICT.

The public hearing in respect of the above project was held on 06.05.2023 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Ghasiram Murmu, O.A.S (SAG), Project Director, District Urban Development Agency, Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Pabitra Kumar Swain, Representative of the Project Proponent explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

1. Sri Nirakar Sahoo, Dobalapal

Sri Sahoo expressed his consent for the proposed sand bed mining on the condition that the owner of the sand bed mine would do mining activities according to the Government guidelines. He on behalf of the villagers demanded that due to mining activities nobody should be adversely affected and there should not be dust generation from the road. Further, he demanded for avenue plantation & employment.

2. Sri Bikram Nayak, Block Chairman, Telkoi Block

Sri Nayak in his address informed that due to Government initiative they could be aware of this auction of sand bed in their area. He informed that the sand extraction has been going on since long and as such they have not faced any inconvenience owing to these extraction activities. According to him everybody will be benefitted through this proposed project and there should absolutely no inconvenience for the residents of this area if this proposed sand bed mining is done as per the Government guidelines.

3. Sri Babuli Charan Sahoo, Dobalapal

Sri Sahoo while supporting the public hearing expressed that the proposed sand bed mining should commence as per the Government given guidelines. At the same time, he requested for avenue plantation on the haul road, some development works for village, water sprinkling on the road for dust suppression. He expects Govt. will also get benefitted from collection of revenue by this proposed project.

4. Sri Suresh Kumar Sahoo, Dobalapal

Sri Suresh Kumar in his address wanted to know from the administration that is there any grant for their village development from the revenue which government will get from the proposed

sand mining. He stated that Government will get revenue from the proposed sand hed mining & he enquired that what benefits their village will get from this project.

The Regional Officer, SPCB, Keonjhar read over the issues raised by the public in the hearing. Sri Pabitra Swain Representative of the Project Proponentresponded to the issues rose. Sri Ghasiram Murmu, O.A.S (SAG), Project Director, District Urban Development Agency, Keonjhargave concluding remarks of the Hearing.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure I & II respectively, list of the oral deliberators and participants in the hearing is annexed as Annexure III& IV respectively. Issues raised at the public hearing and the reply given by Sri Pabitra Kumar Swain (Consultant), Representative of the Project Proponent are as follows:

SI No.	Issues raised	Response of Project Proponent		
Environmental Issues:				
1.	To adopt mining method as per Govt. guidelines	Mining will be carried out as per the terms and conditions of Environmental Clearance, Consent to Establish, Consent to operate and the Approved Mining Plan.		
2.	Plantation	Plantation will be done as proposed in the mining plan and according to the lease area granted. There is a proposal to carry out plantation in the approach road to the sand bed and at the nearest school.		
Peripheral Issues:				
1.	Maintenance of approach road	It is the responsibility of the Lessee to maintain the approach road to the sand bed for the use of villagers as well as for transportation of sand. Further, water sprinkling will be done at approach roads of sand bed & nearby school for dust suppression purpose.		
2.	Employment	Mining operation requires engagement of people as well as support from the people for which locals of Dobalapal village will be taken into account.		
3.	Development of peripheral village	As per the conditions that will be given in Environment Clearance (EC) and as per Govt. guidelines a budget will be fixed for peripheral development work. In consultation with the District Administration, Tahsildar, Regional Officer, State Pollution Control Board and local Representatives peripheral development work will be carried out abiding with all the Rules & Regulations of the Govt.
