PROCEEDINGS OF THE PUBLIC HEARING OF BAMEBARI IRON AND MANGANESE MINE FOR ENHANCEMENT OF PRODUCTION OF MANGANESE ORE FROM 0.832 LTPA[0.978 LTPA (ROM) TO 5.756 LTPA (ROM) AND PRODUCTION OF IRON ORE (NEW PRODUCT) FOR 3.0 LTPA (ROM) WITH OVERBURDEN GENERATION OF 44.18 LTPA (PEAK) & TOTAL EXCAVATION OF 49.94 LTPA (PEAK IN THE MINE LEASE AREA OF 464.0 HA LOCATED AT VILLAGE PALASA (KA), KUNDAPOSI, JARIBAHL, JAJANG, KHANDBANDH UNDER TEHSIL BARBIL OF KEONJHAR DISTRICT HELD ON 04.08.2023 AT 11.00 AM AT MOUZA PALASA ((KA) (KHATA NO. 106 (ABADA JOGYA ANABADI), PLOT NO. 598, PROPOSED AREA AC. 7.40, KISSAM- PATHARABANI UNDER BARBIL TEHSIL OF KEONJHAR DISTRICT.

The public hearing in respect of the above project was held on 04.08.2023 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Bishnu Prasad Acharya, OAS (S), CDO cum EO, Zilla Parishad, Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Sabyasachi Mishra, Head Mine & Production Planning (FAMD) of M/s. Tata Steel Ltdexplained about the proposed project and briefed about the Pollution Control measures to be adopted in the mine.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

# 1. Sri Santosh Kumar Barik, Nambira, Secretary Palasa Development Co-operative Society

Sri Barik whole heartedly supported the public hearing because he loves the company M/s. Tata Steel Ltd very much. It is the only company who always try to put their efforts for development of their area in every field be it education, health care, environment protection, supply of drinking water etc. He stated that it would not be wrong to say that the officers and employees of M/s. Tata Steel Ltd are always with them in their well and woes. He recollected that when he was a small boy. people used to bring water from a distance of 3 to 4 KM but when Tata Steel Ltd started providing water by bucket, villagers became relieved which brought them peace in their life. The company has established one U.G.U.P school at Bamebari through which students are benefitted.One computer education centre has also been established at Bamebari where educated youths are getting computer training. Tata Steel Ltd has provided one bore well at Bamebari High School to meet water scarcity, as a result residents of 2 villages and hutting are using this water. He further stated that previously they did not have any medical facility but presently people are fortunate to have got free medical treatment at Tata Steel Hospital, Jodaby producing Aadhar Card only. Tata Company has created a jungle in a vacant place by planting trees at just 100 meters away from the U.P school and at every vacant patch of land at the nearby Bamebari office and has also built a beautiful Jagganath temple in that area. Tata Steel Ltd has taken a great step by distributing net to the farmers to protect vegetable from stray cattle so that every household are able to do vegetable cultivation. The villagers themselves consume the vegetables and earning money by selling the surplus vegetables at market too. Thus, they could manage livelihood of their families. He said that the company always gives utmost attention on safety at their mines so that there is no accident. He asserted that many youths have got employment from every panchayat like Palsa, Jalahari, Jajang etc according to their qualifications. So, he requested everybody to cooperate M/s. Tata Steel Ltd for their development.

#### 2. Sri Biswajeet Barik, Belda

Sri Biswajeet whole heartedly supported the public hearing because M/s. Tata Steel Ltd has developed the area where it has worked be it education, drinking water, electricity, road etc.

# 3. Smt Hemangini Patra, Bamebari

Smt. Patra while supporting the public hearing stated this is a matter of pride for her that M/s. Tata Steel Ltd is present in their village. She also said that villages as well as the nearby areas will get developed which will result in direct or indirect profit of the villagers.

# 4. Ms Ranjita Naik, Jajang

Ms Ranjita supported the public hearing. She stated that M/s. Tata Steel Ltd has provided lots of facilities to them. She supported the views of her previous speaker Sri Santosh Kumar Barik, Nambira. The details given by him are absolutely true. Through "RISTHA" Project Tata Steel Foundation (TSF) works for all youths. TSF creates awareness about legal implications of marriage of girls below the age of 18 years. It also helped SHGs for enhancing their employability. Lastly, she requested the company to provide one football academy so that everybody will march forward and develop their hidden talent.

# 5. Ms Maya Machhua, Khandbandh

Ms Maya supported the public hearing. They have got lots of facilities from Tata Steel Ltd like medical facilities, campus selection facilities to move outside, solar lights etc. She thanked TSRDS (now named as Tata Steel Foundation) lady employees for their heartiest support. She expects the similar support in future too.

#### 6. Smt Sarada Ratha, Bamebari

Smt. Ratha fully supported the public hearing. At the same time, she requested everybody present to support the public hearing wholeheartedly because mines are the rice bowl of every family. Everybody are dependent upon mines directly or indirectly. Therefore, everybody needs money for their livelihood, thus people from distant places come to these areas to get some job and manage livelihood. She asserted that M/s. Tata Steel Ltd has always been trying to maintain ecological balance by planting trees. It distributed saplings to the schoolchildren and persuaded the schoolchildren to plant trees. The company has also distributed fruit bearing trees and other trees to every village. She requested everybody to take care of everything on their own that has been provided by the company without leaving everything in the hand of Tata Steel Ltd only.

# 7. Sri Bisikeshan Barik, Nambira, Palasa GP

Sri Barik fully supported the public hearing because whatever facilities M/s. Tata Steel Ltd has provided for development of this area since its inception no other company has done so far.

#### 8. Sri Chittaranjan Naik, Jajang

Sri Naik whole heartedly supported the public hearing because it has done many developmental jobs like education, health etc in their area and the surrounding areas. He requested State Pollution Control Board, Keonjhar, Odisha for granting permission to the company for its expansion.

#### 9. Smt. Mamata Mahatao, Jagang GP

Smt. Bhanumati while supporting the public hearing stated the avenue for development will open with the expansion of mines. M/s. Tata Steel Ltd has been doing so many developmental jobs since many years for them and for their area. She again asserted that after expansion of mines employment opportunity will be created for many people. Employment is being provided by Tata Steel Ltd according to the qualifications. She is hopeful for many more employment opportunity for the locals in future also. She requested to establish one football academy with residential facility, so that many football lovers will get opportunity to get training. Lastly, she requested to provide some help like quarter facility etc to the football coach Mr. Dhyan Sir who is a national level coach so that he can impart vibrant training, thus everybody will be benefitted. With regard to environmental protection and maintaining ecological balance, company is distributing plants and preparing orchards for the landowners who has their own land. Finally she requested everyone to lend full support to the company which will lead to enormous development in different sector.

# 11. Smt. Basanti Barik, Nambira, Palasa GP

Smt. Barik while supporting the public hearing demanded for more developmental work and employment to the unemployed mass.

# 12. Smt. Sashibala Munda, Guruda

Smt. Munda supported the public hearing because M/s. Tata Steel Ltd has provided many facilities in their area. Training is being imparted to SHG women and youths for increasing their employability, sending locals outside the state for training free of cost, providing mushroom seed for mushroom cultivation, facilities for duck farming, provided net &Jhara (hand held water sprinklers) for vegetable farming etc.

# 13. Sri Raghunath Mahakud, Belda, Palasa GP

Sri Mahakud strongly supported the public hearing for expansion programme of M/s. Tata Steel Ltd. In his address, he stated that in their area 70% people are dependent on mines and rest 30% are doing cultivation. So it is very much essential that mines should run because people will manage livelihood of their family, afford expenditure of education of their children and many other expenses. He requested M/s. Tata Steel Ltd to resume mobile medical van facility and distribute medicines because now diseases like dengue, malaria has spread in their area. He informed that in their Belda village there is a club house named Bhagyaban Jawan Club, which is now in dilapidated condition for which he requested the company to renovate the club and provide items of different sports so that people of the villages can be benefitted. He quoted one article from Times of India that in future, the atmospheric temperature will increase upto 56°Cby 2026 worldwide and to reduce the effect of heat at least 500 crores plants need to be planted. Therefore, he requested M/s. Tata Steel Ltd to look into improving the spread of green belt. Lastly, he requested to provide employment according to the qualifications.

#### 14. Sri Goura Chandra Barik, Nambira, Palasa GP

Sri Barik whole heartedly supported the proposed expansion of Tata Steel Mines. He informed that the living condition of the people of their area has become very pathetic after Rungta Mines and Essel Mining left the area. People has no option to manage their livelihood except to depend upon Tata Steel Ltd. He stated that Tata Steel Manganese Mines always does manual sorting and sizing of the ores. So, if the company is given the permission to expand, certainly people of their area will be further benefitted. Most of the people of their area are illiterate. So, these illiterate people will be engaged in manual sorting and sizing and thus can manage their livelihood. He requested to give priority to the local people around 7 KM radius for employment with proposed enhanced production. He informed that Government allocates Rs.1,30,000/- to each BPL category family for construction of their house through Biju Pucca Ghara or PM Awas Yojona which he feels sufficient for them but they are unable to complete their houses on their own as they are illiterate and

dependent upon contractor. It was informed that few years back as a development drive of their area Rungta Mines has constructed houses for them. So he requested M/s. Tata Steel Ltd to give attention in this regard so that the poor will not get deprived from a dwelling house. He is hopeful that plantation will be done for reduction of pollution. Lastly, he requested the Govt.authorities to give permission for expansion of Tata Steel Mines because in past they have done blunder by opposing the proposal of Nayagarh Plant. Due to which the proposed plant was shifted to Gopalpur area and now that area got developed and prospered. So he promised to cooperate with M/s. Tata Steel Ltd.

# 15. Smt. Sanju Hembram, Lepa Hutting, Guruda

Smt. Hembram while supporting the public hearing requested to provide employment to all.

## 16. Smt. Padmabati Patra, Khandbandh

Smt. Patra while supporting the public hearing informed that her son is a sickle cell patient. His haemoglobin level suddenly drops down due to which he fell critically ill at any moment and needs immediate blood transfusion for his survival. He needs blood transfusion at 15 days interval now. She was denied for availing Govt. ambulance services for bringing her son to Keonjhar. However, with the help of TSF her son could be admitted at M/s. Tata Steel Hospital, Joda and life of her son was saved. She thanked TSF for their support. She went on to request M/s. Tata Steel Ltd to provide ambulance as an when required for treatment at Tata Steel Hospital, Joda for saving life of her son because his condition is very critical.

## 17. Sri Ramchandra Majhi, Palasa (Kha)

Sri Majhi supported the public hearing because M/s. Tata Steel Ltd has done so many great jobsspecially for daily poor wage earner. Through "ASPIRE" project since 2015 till date Tata Steel Ltd has been providing free education, community awareness for social development through meetings, rallies etc. No other company has done such great job. M/s. Tata Steel Ltd has been doing plantation programme every year to protect environment and maintain ecological balance.

## 18. Ms. Sita Naik, Palasa (Kha)

Ms Naik supported the public hearing.

#### 19. Mrs. Jayena Parween, Kundaposi Panchayat

Mrs Parween while supporting the public hearing requested the company to provide school, electricity, drinking water etc.

#### 20. Smt. Jayanti Lohar, Guruda

Smt. Lohar while supporting the public hearing requested for employment.

#### 21. Sri Sukra Munda, Nambira

Sri Munda whole heartedly supported the public hearing and gave his opinion for opening of closed/discontinued manual mining activities. He informed that he has learned a lot through the efforts of Tata Steel Ltd and developed himself and travelled so many places like Jamshedpur, Panchgani etc. The company has done so much for him. Lastly, he requested M/s. Tata Steel Ltd to give attention on environment and provide job to them as per their education.

#### 22. Sri Durjya Munda, Nambira, Palsa GP

Sri Munda whole heartedly supported the public hearing. Due to proposed expansion by M/s. Tata Steel Ltd, they will be able to develop their education, lifestyle and generate some income. He stated that time freedom and money freedom are the two advantages if mines, continues. Through money

& time freedom they will be able to spend money for education of their children in good schools etc. He stated due to no job they are deprived of providing education to their children. He urged everybody to grab the opportunity for supporting Tata Steel Ltd for this expansion project so that everybody will get employment directly or indirectly. He asserted that many years ago due to some selfish people with vested interest the proposed Nayagarh Plant was opposed and subsequently it was shifted to Gopalpur. Now Gopalpur area has become developed and prosperous. Had this plant opened in their place, this area would have developed as a town and everybody would have got a job. He requested to plant one tree each for maintaining ecological balance. He went on to add that Tata Steel has done so many work in their areas like provision of solar lights, roads, computer trainings, education, health facilities etc.

#### 23. Smt. Reena Pattanaik, Bamebari

Smt. Reena while supporting the public hearing persuaded everyone present there to cooperate in the health camps being organised by Tata Steel Foundation at every village and get medical check-up/treatment and free medical treatment at Tata Steel Hospital, Joda. He requested M/s. Tata Steel Ltd to extend their helping hands for the development of unskilled uneducated person. He added that Tata Steel Ltd has been providing all possible help to the ST/SC youths for their education.

# 24. Smt. Jasumati Lohar, Guruda

Smt. Lohar while supporting the public hearing stated that Tata Steel Ltd has so many things for their development and she is hopeful for many more developmental jobs in future also. He urged for expansion of mines so that the unemployed youths will earn their livelihood.

## 25. Smt. Maina Munda, Kundaposi

Smt. Munda while supporting the public hearing requested everybody to support Tata Steel Ltd so that with the expansion of mines their children will get employment irrespective of their educational qualifications.

# 26. Sri Shyam Sundar Purty, Ex-Zilla Parishad Member, Zone No. 27, Jurudi

Sri Shyam Sunder initially went down the memory lane and said during his childhood, he remembered that long back there was a tin shed hutting where manganese ore were produced. His grandfather was working in that mine. They were living there happily. During his 50 years of age, he has seen many areas of in the country, but he had a sadness inside his mind that when will the day come when Tata Steel Ltd a world class company will take steps to enhance its production capacity at Bamebari Mines. He was waiting for this day so that the sadness of people of their area will get eliminated. He thanked M/s. Tata Steel Ltd for their proposed expansion project. Further he stated that now a day's existence of tin shed hutting could not be found out because Tata Steel has planted trees over that place by back filling of soil and created a green belt and shifted them to a better place. Tata Steel has always been trying to protect the environment by creating green belt. The company has dug out approximately 200 numbers big pondsin the peripheral area, which helped them for maintaining ground water level and soil conservation. More over the beneficiaries can earn their livelihood through these ponds by vegetable cultivation and fisheries. M/s. Tata Steel Ltd has provided solar lights and water through solar deep bore wells to some villages also. The company has been doing so many developmental jobs through "ASPIRE", "DISHA", "RISHTA" and "MANSHI" projects for human development. With regard to the promotion of education, Tata Steel has awarded scholarship to more than 5000 children for their education through their "IYOTI" Fellowship programme. He stated that with the proposed enhanced production, many people will come here and requirement of the people would increase. So, he demanded for a football academy, a dispensary and one skill development institute in the area. He pointed out even though Tata Steel Ltd will install wheel-washing system at the entrance of the mine nevertheless air pollution will not reduce. So, he demanded for one vacuum dust sucker machine to reduce air pollution. He requested manual sorting and sizing activity to continue so that more and more people will get employment and the area will prosper. He requested M/s. Tata Steel Ltd to apply their influence in DMF meetings for development of road from Bamebari to Kalimati, Bamebari to Sundergarh etc. through

He requested the company to provide employment as per the education as far as possible. Further requested for a dispensary and mobile ambulance for distribution of medicines.

# 56. Sri Bulu Charan Barik, President, Forest Committee, Nambira

Sri Barik while supporting the public hearing told that transportation of raw materials through belt and pipe line will not be allowed there because many people will not get job and most of the people depends upon the Truck business. He further raised his concern about the medical facility at Joda that after the introduction of contractual doctor and staff, the medical facilities are not upto the standard though medicines are provided free of cost. In past, the said medical was very good. Hence, he requested to keep good specialist doctors in Joda Medical. Further he demanded for a good medical and a school in their locality like DAV school at Joda.

#### 57. Sri Prasanna Ghana, Kamalpur

Sri Ghana while supporting the public hearing raised his concern that the mines owners are only expanding their mines and increasing production capacity to 4-10 times of the existing production capacity due to which mining will be finished within 10 years. He further informed that before 10 years, this area was full of dense forest, but now around 50% of the forest has been destroyed due to mining activities. In all the previous public hearings and Grama Sabhas, commitment has been made by all Lessees for massive plantation, but if this has happened he questioned where the jungle is. He expressed his anguish that even though there is plantation but due to poor management and maintenance the survival rate of plants is zero. Their ancestor had left this place with dense forest, stream, water, waterfalls etc. but the present generation could not protect the same. At present, due to fast depletion of forest, the elephants are marching towards the village, eating their food, destroying the houses and killing the people. It indicates that elephant is taking revenge for destroying their natural habitat because the natural habitat of animals is day by day reducing. The people of this area are falling ill due to dust and mud. So nothing can be done by ignoring environment. He stated all the lessees says that they have given so much employment etc. but then why so much of unemployment still prevails in that area. Further, he stated that Tata Steel is not providing contractual job to the locals for raising, transporting, civil etc. whereas they are providing the same work constantly to their 2 to 3 permanent contractors only keeping the locals hopeful that someday they will get the opportunity but all goes vain. Further, he alleged that Tata Steel declared there is no tourism spot in that locality whereas Pillow Lava Geo point is only at 800 metres distance from the mine, near Nambira village and the District Administration &Archaeological Survey of India shall declare it to be a tourist spot and let Tata Steel Ltd develop the place as a tourist destination. One more important thing is blasting carried by mines. Due to blasting in the mines, the houses are getting damaged and cracked. Wild animals and reptiles are leaving the jungle out of fear and moving towards human habitants. Most of the villagers of their locality are below the poverty line and they are sleeping on the ground due to which snake bite cases are also getting rampant and many people are dying. He further stated that while increasing the production level the mines owners are getting higher profits, but the cost of transportation of minerals is getting decreased for which the livelihood of the truck owners is hampered as most of the people depends upon transportation business, which is a matter of concern. He demanded for the following:-

- a) Employment to the affected people on priority.
- b) Massive plantation to protect the environment.

c) Priority for providing all types of contract jobs to the local people.

Smt. Mundray while supporting the public hearing told that she got her eye treatment at Company's medical free of cost.

# 59. Sri Deepak Ku Mahanta, Jamunaposi, Palasa GP

Sri Deepak while supporting the public hearing raised his concern that earlier the people of their area had done a mistake by opposing for setting a Steel Plant at Nayagarh. Had it been established no youth would have left jobless now. Everybody would have been independent as of now. He told that now a days the market situation is very bad in their area as people are not able to sell the vegetables. One can't even get bag full of vegetables due to high rate. Regarding pollution he informed that around 4000 plantationshas been done by TSL &an Orchard of 40 decimal area has been planned out of which around 12 decimal area has been covered under orchard. He went on to add, for every work to get successful needs cooperation from both the sides. Company has requested the villagers to provide 100 acres land for plantation purpose, but no such land was provided by the villagers due to some ill intention people. With regard to blasting operation, he stated that TSL has always conducted blasting in scientific way which is not harmful to the villagers.

#### 60. Ms. Saraswati Hemram, Bamebari

Ms Saraswati while supporting the public hearing stated that so many companies are operating there, but TSL is the only company who is involved in all round development of their area. Tata Steel Foundation employees are approaching door to door of the nearby villages and counselling people for tree plantation. Even asking the villagers for open land so that tree plantation can be done there.

# 61. Smt. Menaka Patra, Jajang GP

Smt. Patra while supporting the public hearing expressed that all previous speakers have already told, and it is not required to repeat again.

#### 62. Smt. Lily Karwa, Cretch Hutting

Smt. Karwa supported the public hearing.

## 63. Smt. Chandrabati Barik, Palasa (Kha)

Smt. Barik while supporting the public hearing expressed that it is required to maintain clean environment for all to live a healthy life. Hence, requested the company for plantation, dust suppression measures. Further, she requested for employment to the uneducated youths as per their qualifications and alternative means to earn income for the illiterates.

Smt. Kabita fully supported the public hearing.

He further informed that in 1973 his father was also working in Bamebari and getting Rs.300/salary per month. Since his father was working, he was able to read in Mahatab High School, Champua. Since long, TSL is working here for the development of this area on priority. He further informed that they have an Anchalika Janakalyan Association which regularly interacts with TSRDS (now TSF) for development of this area and has carried many developmental works along with the support of youths of their locality. Earlier there was a dense forest of Sal tree from Joda to Bamebari. New jungles have been created by Tata Steel Ltd. Tata Steel is the only company who is implementing the new technologies regarding environment protection so there is nothing more to say. Tata Steel has provided two buildings in Jhadeshwar High school at Bholadia and constructed concrete road in Bholadia village. He said there is no playground in four nos. of villages i.e. Belda,
