PROCEEDINGS OF THE PUBLIC HEARINGFOR SOMAKOI SAND QUARRY, TELKOI OF SRI KUNA SAHU OVER ML AREA OF 15.56 HA. AT VILLAGE TELKOI UNDER TELKOI TAHASIL OF KEONJHAR DISTRICT HELD ON 04.05.2023 AT 11.0 AM AT VILLAGE TELKOI KHATA NO. 329, PLOT NO. 212, KISAM- PATITA, PROPOSED AREA- AC. 1.33 IN THE KEONJHAR DISTRICT.

The public hearing in respect of the above project was held on 04.05.2023 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Jadumani Mahala, OAS (SAG), Additional District Magistrate (Revenue), Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Pabitra Kumar Swain, Representative of the Project Proponent explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

1. Sri Chaitanya Charan Naik, Telkoi

Sri Naik while supporting the public hearing demanded for separate haul road for transportation of sand. He said that the sand transport vehicle should not ply through their village road. Secondly, he demanded to utilize the revenue which will be generated from this proposed sand mining for development of the Panchayat.

2. Sri Lakhindar Pradhan, Telkoi GP, Halipuri

Sri Pradhan stated that government is collecting high royalty, as a result the common people are facing difficulties and unable to purchase sand. So, he requested the Lessee to mention the auction rate of sand for the public and to provide sand at reasonable rate for benefits of the common people for construction of their houses under PM Awas Yojona.

3. Sri Prasanna Kumar Pradhan, TalasaiTelkoi

Sri Prasanna Kumar requested administration to remove the bushes and small weeds from the pathway from cremation ground to riverbank because people are unable to go to river for taking bath. He urged that after completing cleaning work the sand bed may operate.

4. Sri Prafulla Kumar Sahu, Oriya GP, Katrabali

Sri Sahu in his address stated that for construction of houses sand is sold @ Rs.2000/- a trip in their village, as a result people are unable to construct their houses. Hence, he requested Administration to look into this issue for benefit of the common people.

5. Sri Krushak Bandhu Sahu, Telkoi

Sri Sahu informed that in the nearby sand bed named Kumuda, sand is being extracted with the help of machines at nighttime. He apprehend that due to mechanized mining and movement of big tippers there will be more pollution and no employment opportunity from the proposed sand bed operations. So he requested to do manual mining and transportation of material through small vehicles. Due to mining by machines huge pit is being made and domestic animals falls into the pit and dies. He also informed that an old lady while crossing the river for collection of wood fell in the river pit and died and her dead body was found after 2 days.

6. Sri Jitendra Pradhan, Telkoi

Sri Pradhan while supporting the public hearing appreciated the Govt. decision for awarding lease for the proposed sand bed. Earlier revenue was not coming due to sand theft. Now after awarding this lease theft cases can be stopped, and considerable amount of revenue will be generated which will be spent for the development of common people of their area like BSS Medical Card. He also said that he would like to know from administration does the Government has any provision for providing sand in low price for the beneficiaries of Biju Pucca Ghara or PM Awas Yoyona etc. because due to their contribution and sacrifice Government will be able to earn a lot of revenue. Secondly, he informed that elephant often come to the river for drinking water, as a result there is thereat to the lives of the villagers. So, he requested to remove the bushes and small weeds from the river side so that people will not face any difficulties.

The Regional Officer, SPCB, Keonjhar read over the issues raised by the public in the hearing. Sri Pabitra Swain Representative of the Project Proponent responded to the issues raised. Sri Jadumani Mahala, OAS (SAG), Additional District Magistrate (Revenue), Keonjhar gave concluding remarks of the Hearing.





Further, mining will be carried out as per the terms and conditions of Environmental Clearance.		
2.	Plantation	Plantation will be done as proposed in the mining plan. Earlier Lessee used to do plantation but currently as per Govt. circular, Lessee will deposit money to forest department for plantation purpose and with the help of local Forest Department plantation will be done.		
Peripheral Issues:				
1.	Repair of local roads	After the approval of mining plan, Environment clearance is under progress, for commencement of mining operations, Government has some rules and regulation and as per mining plan local roads will be repaired, Approach road near the mining operation site will be repaired on a regular basis and utmost attention will be given on the movement of the tippers and water sprinkling will be carried out for control of pollution.		
2.	Removal of bushes and weeds on the pathway from cremation ground to river bank.	The lessee after obtaining the Environment Clearance (EC), with the instructions of the local Tahsildar and as per guidelines of EC, and along with the support of Local representatives, District Administration & concerned Departments, they will work abiding the Rules and Regulations of the Govt.		
3.	Special concession towards the beneficiaries of PM Awas Yojna and Biju Pucca Ghar regarding purchase of sand for construction of house.	Since the year 2015 bidding process has been started by the Govt. for auction of sand bed. Depending upon the bidding price royalty is given to the Govt. and accordingly price of sand is being fixed for sale. However, considering the local people for construction of house under Indira Awas, PM Awas Yojna and Biju Pucca Ghar the Lessee will provide support as per Govt. guidelines.
