

**PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR M/S S. M. JEMADEIPUR STONE QUARRY OVER THE MINING LEASE AREA OF 7.343 HA BEARING KHATA NO. 332, PLOT NO. 165 & 27 FOR PRODUCTION CAPACITY OF 10,692 CUM/ANNUM AT- S. M. JEMADEIPUR VILLAGE, KABISURYANAGAR TAHASIL OF DISTRICT GANJAM, HELD ON 29.08.2023 AT 11.00 AM ADJACENT TO RADHA KRUSHNA TEMPLE OF JARADA VILLAGE OVER PLOT NO. 3412, KHATA NO. 1260 UNDER KABISURYANAGAR TAHASIL OF GANJAM DISTRICT**

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that the project proponent has proposed to have Environmental Impact Assessment for mining lease area of 7.343 ha. for production of Stone @ 10,692 cum/Annum at- S. M. Jemadeipur village, Kabisuryanagar Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily “The Dharitri” dated 27.07.2023 and an English Daily “The Times of India” dated 27.07.2023 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the Office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur and Department of Forest, Environment & Climate Change Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar ([www.ospcboard.org](http://www.ospcboard.org)).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Jarada Gram Panchayat, Gudialli Gram Panchayat and Block Development Office, Kabisuryanagar in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur, Ganjam to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Chatrapur, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. Then he asked Project Proponent to brief about the project.

The representative of project proponent presented the salient features of the proposed M/s S. M. Jemadeipur Stone Quarry, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Sub-Collector-cum- Sub-Divisional Magistrate, Chatrapur, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 50 persons were present in the public hearing meeting, only 34 nos. of persons signed in the attendance sheet, out of which 06 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

**The statements recorded are as follows:**

**1. Sri Jay Nahak, At - S. M. Jemadeipur, Ganjam**

He has highlighted/ demanded the followings:

- a) Damage of nearby houses due to blasting in the stone quarry.
- b) Traffic congestion and road damage due to movement of transporting vehicle.

**2. Sri Sunil Kumar Acharya, At- Tiadipalli, Ganjam**

He has highlighted/ demanded the followings:

- a) Dusts and stones due to blasting in the stone quarry got deposited over their vegetative lands, their homes etc.
- b) Stones coming from illegal blasting causes harm to their homes and villagers.
- c) Lessee is not taking any measures to mitigate the environmental pollution arising due to operation of the quarry.
- d) Opposed this project.

**3. Sri Soura Nahak, At- S. M. Jemadeipur, Ganjam**

He has highlighted/ demanded the followings:

- a) Stones coming from the blasting activities in the quarry, causes harm to his family members.
- b) Lessee shall take responsibility of any harm to villagers due to blasting activities in the quarry.

**4. Sri Balaji Nahak, At - Tiadipalli, Ganjam.**

He has highlighted/ demanded the followings:

- a) Damage of house due to blasting.
- b) Various problems face by the villagers due to operation of this quarry.
- c) Opposed this project and requested to stop the operation of this quarry.

**5. Sri Sanjay Behera, At- S. M. Jemadeipur, Ganjam.**


He has highlighted/ demanded the followings:

- a) Stones arising from blasting in the quarry fall on local people and people are getting injured.
- b) Opposed this project and requested to stop the operation of this quarry.

**6. Sri Padmeswar Nahak, Sarpanch, At- Jarada G.P., Ganjam.**

He has highlighted/ demanded the followings:

- a) 70 – 80 % villagers are opposing the operation of this stone quarry.
- b) There shall be fixed timing for blasting in the quarry.
- c) Excavation activity in the quarry leads to entry of wild animals into their villages.
- d) Vegetative lands are getting destroyed due to deposition of dust arising from the operation of the quarry.






