

PROCEEDINGS OF THE PUBLIC HEARING MEETING FOR ENVIRONMENTAL CLEARANCE FOR PROPOSED EXPANSION OF STEEL PLANT OF M/s. BEEKAY STEEL INDUSTRIES LIMITED, AT RAMPEI VILLAGE UNDER ATHAGARH TAHASIL OF CUTTACK DISTRICT IN ODISHA.

The Public Hearing meeting of M/s. Beekay Steel Industries Limited for proposed expansion of Steel Plant – DRI Kilns (Sponge Iron From 1,20,000TPA to 4,50,000TPA), Induction Furnaces along with CCM & LRF (Hot Billets / MS Ingots / Billets from 65,000 TPA to 3,96,000 TPA), Ferro Alloys: 1x9MVA (FeCr 12,500 TPA / FeMn 18,000 TPA) to 3x9MVA (FeCr 45,000 TPA / SiMn 43,200 TPA / FeMn 75,600 TPA / FeSi 21,000 TPA / Pig Iron 75,600 TPA), WHRB (DRI) based Power Plant from 5 MW to 24 MW, AFBC based Power Plant from 14MW to 44MW, new WHRB (BF Gases) 5MW, New Sinter Plant (4,27,680 TPA), New 8,00,000 TPA of Pellet Plant along with Producer Gasifier 24,000 Nm³/Hr., new Briquetting Plant: 300kg/Hr. & new Brick Manufacturing Unit (68,100 Bricks/Day) was held on 27.09.2023 at 11.00 AM in front of the main gate of M/s. Beekay Steel Industries Limited, Mouza: Rampei under Athagarh Tahasil of Cuttack district, Odisha with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

The Panel consists of the following members:

At the outset, welcoming the members participated in the meeting presided over by the Sub Collector, Athagarh, the representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Beekay Steel Industries Limited.

Welcoming the public, Er. Rashmita Priyadarshini, the Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. She informed that the date, time and venue for conducting this public hearing was duly advertised in Odia daily newspaper "The Sambad" on dtd. 25.08.2023 and in English daily newspaper "The New Indian Express" on dtd. 25.08.2023 for intimation to the public.

Rashmita

Sri Prasanta Kumar Tarai, Sub Collector, Athagarh welcomed the public and asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

On behalf of the project proponent, Sri Sandeep Behera Sr. General Manager (HR & Admin) of the industry addressed the committee members and the assembled public. He informed the public about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Sub Collector, Athagarh requested the public to give their views, opinion and objections on the proposed project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sri Manoj Kumar Mishra, President of Khuntuni Rampei Village Committee:

Addressing to all he said that they have no objection if the industry will operate and raised the following demands;

- i. For Employment, priority to be given to the youths of Khuntuni, Rampei village according to their qualification and next opportunity to be provided to the nearest villagers of Radhakishorepur and Radhakrushnapur.
- ii. In future if the industry wants to connect road to National Highway then it will take the land of Rampei and Khuntuni Gram Panchayat only.
- iii. He further emphasized that ground water should be utilized as per the government guidelines.
- iv. Industry is required to give their support in the cultural activity and peripheral development of the village.
- v. Industry should implement the pollution control measures as stated in the public hearing meeting.

2. Sri Ranjan Acharya, Ex- Block Chairman, Athagarh:

He welcomed all and placed the following demands;

- 1) Importance and preference to be given to the local villagers Rampei, Khuntuni Gram Panchayat, Radhakishorepur and Radhakrushnapur Gram Panchayat for each work of the company.
- 2) He said school and hospital are located near the existing road connected to the industry and it is always having heavy traffic. Therefore, he emphasized to make an alternative approach road from factory to National Highway.



- 3) He presented that both our hon'ble Chief minister and Minister of Agriculture and Farmers Empowerment, Odisha have always given priority on employment to strengthen the livelihood of the local people and they have taken several steps for establishment of different industries in this area.
- 4) He told not to use ground water and river water to be used for the production purpose.

3. Sri Kailash Chandra Das, Sarpanch, Khuntuni Gram Panchayat:

He welcomed all and said due to closedown of M/s. Maheswari Ispat Ltd. the economical condition of the locality gets affected. He expressed his gratitude to the hon'ble MLA who is the Minister of Agriculture and Farmers Empowerment, Odisha for his continuous effort for which today Beekay Steel Industries Ltd. is going to be established in place of M/s. Maheswari Ispat Ltd. He placed the following demands;

- i. He said the commitment made by the industry should be followed whole heartedly. If the commitments are fulfilled people will appreciate and welcome the industry. Further he opposed the employment of outsiders in the company.
- ii. He told that Rampei & Khuntuni people have given their measure chunk of land for establishment of the industry. Hence preference should be given to the villagers of Rampei, Khuntuni Gram Panchayat, Radhakishorepur and Radhakrushnapur Gram Panchayat during employment and in different activity of the industry.
- iii. He emphasized after establishment of the plant, if employment is given to the outsiders instead of the villagers there will be dissatisfaction among them.
- iv. He also expressed that by the operation of the industry people will get employment directly or indirectly in terms of house rent, other business opportunities and market developments etc.
- v. He emphasized that M/s. Beekay Steel Industries Limited management should provide their support in the local festivals and cultural programme of the village and district administration should also look into the matter.
- vi. While addressing about the existing road, he said the existing road may not cater the traffic load and possibility of accident will increase. He mentioned that while M/s. Maheswari Ispat Ltd. was operating there was a proposal to make an alternative road on the land of Rampei & Khuntuni village and not on other area. He categorically requested the management for taking decision to execute the earlier proposal.
- vii. He appealed before the management to give preference to local youth in employment as per their skill and experience. However, in case they are not so suitable for the position then management may engage outsiders. He further said if employment will be given to outsiders neglecting the local people, then there will be strong agitation.
- viii. He said that industry should take water from Mahanadi River for its production.
- ix. He expressed his views to look into the peripheral development and concluded his speech by requesting the management to provide street lights on the existing road.

4. Sri Nrusingh Charan Sahoo, Khuntuni:

He said they are welcoming the industry and placed the following public demands;

- i. He emphasized on employment of local people and continuous operation of the pollution control measures during operation of the industry.
- ii. He focused on peripheral development and requested to provide street light on the road connected from factory premises to Khuntuni at the earliest.
- iii. He said the industry should implement the action point as read in the meeting.

5. Sri Bipin Bihari Pradhan, Khuntuni:

He said all people are expecting to get employment directly or indirectly when the industry will operate and hence, they are supporting the industry. Every year when labour day was celebrated by the hon'ble MLA in front of the closed factory gate, demands were raised by the youth to resume operation of M/s. Maheswari Ispat Ltd. He told several efforts were taken by the hon'ble MLA for operation of the industry so that local people will get employment and emphasized that there should not be any deviation in employment of local people. He said village committee is submitting a memorandum mentioning all the issues as stated by the previous speakers. He further said, as the industry stated to use solar power, not to use ground water, continuous operation of ESP, carry out different peripheral activity etc. The industry should adhere to its statement.

6. Sri Gagan Bihari Parida, Khuntuni:

He said in 2010 when M/s. Maheswari Ispat Ltd. closed down many local people lost their jobs and did not get their outstanding salary and provident fund. He welcomed the industry and said business opportunity will increase by operation of the industry. He stated they have no objection for the industry to operate but they want support from the industry in different activities. Following demands were placed by him in the meeting;

- i. Efforts should be taken by the industry towards Re-employment of the ex-employees of M/s. Maheswari Ispat Ltd.
- ii. Efforts should be given towards payment of outstanding salary of the ex-employees of M/s. Maheswari Ispat Ltd. as far as possible by M/s. Beekay Steel Industries Ltd.
- iii. Employment for local people.
- iv. Peripheral development like street light provision to be made.
- v. Restoring of water bodies.
- vi. Support to be given for developmental of schools, hospitals and temples of this area and provision to scholarship to be made for poor brilliant students, ambulance provision for hospital, development of playground, contribution to be provided during different festivals, yatra and cultural programme, support for the farmers etc.

7. Sri Binod Kumar Majhi, Sarapanch, Radhakishorepur:

He addressed the gathering and put the following demands;

- i. Employment of the local people to be prioritize.
- ii. Interest of the farmer's to be protected by implementation of adequate pollution measures in the industry.
- iii. Industry should give efforts on re-employment of the ex-employees of M/s. Maheswari Ispat Ltd.

8. Sri Bidhan Swain, P.S. Member, Radhakishorepur Gram Panchayat:

He addressed the gathering and placed the following demands;

- i. Company should give employment to ex-employees and priority should be given to the local people of Khuntuni and Radhakishorepur.
- ii. The industry should develop alternate road as there is heavy traffic on the existing road due to running of school and hospital.
- iii. He welcomed the industry.

9. Alok Sahoo, Khuntuni:

He welcomed the industry and said the hon'ble Minister Agriculture and Farmers Empowerment, Odisha always wants farmers' agriculture land should not be damaged by the establishment of the industry. He also appreciated industrialization and its benefits. Following public demands were put by him;

- i. Employment should be given to the local people on priority basis and to the women candidates also.
- ii. Efforts should be given towards settling of Pending dues of the ex-employees as far as possible by M/s. Beekay Steel Industries Limited.
- iii. Pollution control measures are to be implemented wholeheartedly without interruption.

10. Paresh Sahoo, Khuntuni:

He presented the following demands;

- i. He insisted much about the operation of pollution control measures. He said the manufacturing process of DRI produces a lot of pollution and requested the management to continuously operate the ESP without any interruption
- ii. He further expressed his heartfelt obligation to the hon'ble Minister Agriculture and Farmers Empowerment, Odisha for his effort for operation of M/s. Beekay Steel Industries Ltd., and not allowed for selling the industry as scrap.
- iii. He welcomed the industry and emphasized on employment of the local villagers.

- 11. Sanjib Behera, Khuntuni:** He welcomed the industry and emphasized on medical facility. He requested to facilitate adequate numbers of doctors and provision of ambulance for the Khuntuni hospital to provide better treatment facility during emergency.

12. Suresh Dalei, Khuntuni:

He said after closed down of M/s. Maheswari Ispat Ltd. in 2010 the people of this area went to outside industries for employment and houses which were engaged for rent became vacant. He presented the following public demands;


- i. He requested the management to provide employment opportunity to the local people including the women candidates.
- ii. The company should implement adequate pollution control measures.
- iii. Concludingly, he put emphasis on installation of street lights on the village road.

Total 12 Nos. of people had registered their names to express their views, demands etc. and deliberated their views accordingly. About 244 Nos. of people were attended the public hearing meeting have signed the attendance sheet.

After all the speakers completed giving their respective opinion the Regional Officer, Cuttack compiled and categorically repeated the demands placed by the villagers and recorded the same. Sub Collector, Athagarh asked the project proponent to give reply to the issues raised by the public. On behalf of the project proponent, Sri Sandeep Behera Sr. General Manager (HR & Admin) put reply on the issues raised by the public.


The issues raised by the public and the reply of the project proponent has been prepared in English & Odia is annexed with the proceedings as Annexure-I & II respectively, list of oral deliberators and participants in the hearing is annexed as Annexure- III & IV respectively. 8 Nos. of written representations received during the public hearing is annexed as Annexure-V.

Finally, the Sub Collector, Athagarh ended the meeting with vote of thanks.

He said it is known to everyone that they have taken all necessary steps to restore the existing water pipeline from Mahanadi to plant site for production process and the same is under repair. 4) Regarding peripheral development he stated management has extended the hand of cooperation to some issues of the village. He said the villages cover under the project area will be taken into consideration. He said the proposals put by the villagers will be undertaken in consultation with villagers and the same will be conveyed to the Management. He requested for cooperation of the villagers. 5) He informed regarding the provision of street lights that proposal will be submitted to the management to initiate action.
