At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that the project proponent has proposed to have Environmental Impact Assessment for mining lease area of 12.161 Ha. for Maximum Excavation of Rock Mass @ 21,000 Cum/Annum (11,550 Cum/Annum of Decorative Stone) at Gada Govindapur village, Digapahandi Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study:

Publicity regarding public hearing was made in the following manner -

- Advertisements through an Odia Daily "The Samaya" dated 30.09.2023 and an English Daily "The New Indian Express" dated 30.09.2023 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the Office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur and Department of Forest, Environment & Climate Change Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Gada Govindapur Gram Panchayat, Chandapur Gram Panchayat, Lalmenta Laxmi Narayanpur Gram Panchayat, Nuapada Gram Panchayat and Block Development Office, Digapahandi in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur, Ganjam to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. Then he asked Project Proponent to brief about the project.

Or Who 23

Sri Jagabandhu Bisoi of Kalyani Laboratories Pvt. Ltd, presented the salient features of the proposed Gada Govindapur Decorative Stone Mines of M/s Excellent Granites, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Sub-Collector-cum- Sub-Divisional Magistrate, Berhampur, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 70 persons were present in the public hearing meeting, only 49 nos. of persons signed in the attendance sheet, out of which 07 persons participated in the oral deliberation and signed in the oral deliberator's sheet. Two written representations were also received during the hearing. The attendance sheets, deliberator sheet and written representations are enclosed as **Annexure-II**, **Annexure-III** respectively.

The statements recorded are as follows:

1. Sri Ranjan Kumar Sahu, Sarpanch, Gada Govindapur G.P., Ganjam

He has highlighted/ demanded the followings:

- a) Mining shall be carried out without creating any problems for localities.
- b) Mining shall be carried out away from the age old temple located at the hill top and lessee shall also protect it.
- c) Repair and maintenance of village panchayat roads. The District Administration shall expedite repair and maintenance work.
- d) According to proponent, local people will get benefited. However, general body meetings will be conducted in G.P. after public hearing to get opinion of villagers.

2. Sri Karamani Sahoo, At-Gada Govindapur, Ganjam

He has highlighted/ demanded the followings:

- a) Due to blasting during mining activities various problems will arise such as cracks in the houses and in the nearby temple etc.
- b) Local environment and vegetation will be degraded due to mining.
- c) Interconnecting roads are getting damaged because of plying of heavy transporting vehicles.
- d) Problems of villagers are not being properly addressed.
- e) He has requested, not to allow mining of stones from this hill.

3. Sri Trilochana Behera, At- Gada Govindapur, Ganjam

He has highlighted/ demanded the followings:

- a) The Project Proponent has assured that they will undertake mining without hampering environment.
- b) Due to mining local villages will be developed and villagers will get employment opportunities.

4. Smt. M Sali, At- Dhanarasi, Ganjam.

a) She has stated that they are yet to receive their wages from Government though they have completed the work assign to them under MGNREGA Scheme.



5. Sri Mantu Pradhan, At - Dhanarasi, Ganjam.

He has highlighted/ demanded the followings:

- a) Their houses were getting damaged due to blasting in the mine.
- b) The mine will generate employment for villagers.

6. Sri Pradeep Pradhan, At-Dhanarasi, Ganjam.

He has highlighted/demanded the followings:

- a) The lessee has assured that Mining will be carried out using diamond wire saw cutting machines and without blasting.
- b) The proponent shall develop greenbelt.
- c) Excavation activity in the quarry shall not harm domestic animals.

7. Sri D. Kamaraju, At- Gada Govindapur, Ganjam.

He has highlighted/demanded the followings:

- a) Due to mining, there will be development of villages & schools.
- b) Local people will get employment in the mine.
 - c) Problems of villagers shall be addressed.

Further the Sub- Collector-cum- Sub-Divisional Magistrate, Berhampur, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Gada Govindapur Decorative Stone Mines of M/s Excellent Granites to address the issues raised by the local public. Sri Jagabandhu Bisoi, representative of M/s Excellent Granites addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by the Sub-Collector-cum-Sub-Divisional Magistrate, Berhampur, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponent, prepared in Odia and English Language are annexed as Annexure-IV and Annexure-V separately.
