The public hearing in respect of the project proposed by M/s Ferro Alloys Corporation Ltd. for expansion of Chrome Ore production from 0.24 million TPA (opencast) to 1.5 million TPA (opencast and underground) with maximum excavation of 2.5 million TPA (opencast and underground) along with installation of a new crusher and cob plant to enhance the beneficiated chrome ore from 0.1 MTPA (open cast) to 0.8 MTPA (open cast and underground) and a backfilling plant in Ostapal Chromite Mines (72.843 ha) located village gurujanga, under sukinda tehsil of jajpur district, odisha with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13th September 2007 in respect of applications made under EIA-1994

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the

light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s Ferro Alloys Corporation Ltd.

Welcoming the public, Sri N. K. Jena, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

On behalf of the Project Proponent, Sri Susant Kumar Biswal, Head - Environment addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed project on development of Opencast as well as Underground Mining with installation of different plants like COB Plant, Washing Plant, Backfill Plant & Batch Plant etc., Environmental management, Pollution Control Measures, Waste Management, Afforestation programme and Various other peripheral development activities envisaged in the proposed project.

Then Sri Naba Krishna Jena, Additional District Magistrate, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The issues raised at the public hearing meeting are as follows: 1. Education	Mr. Ajaya Kumar Patra, Head- Logistic of M/s Ferro Alloys Corporation Ltd. who was present at the public hearing meeting committed to certain issues raised by the public are as follows:
 Peripheral development/ CSR Health Infrastructure 	Mr. Patra greeted the Chairpersons & other guests and gathering. He clarified the M/s. FACOR Ltd. has renovated the condition of the Sriram U.P School and also providing free education and amenities including, free coaching from class 7 th to 10 th student through tutors and provided college bus facility for conveyance of local students.
5. Environmental issues	Mr. Patra told that M/s. FACOR Ltd. has provided one Masala making unit and also Chappal manufacturing unit for the livelihood support of the nearby people including Kansa Panchayat for the above purpose. Further he mentioned that under HARIYALI project, 100 Self Help Group (SHG) women have been trained & provided plant seeds in free of cost to develop vegetable
	garden and imparted regular training to SHG women for their empowerment. Mr. Patra informed that mobile health camp is being provided on regular basis along with free medicine to the nearby locality. M/s FACOR Ltd. also provides ambulance service for shifting of patients for better treatment at Cuttack /Bhubaneswar as per requirement and different Health awareness camp is being conducted on regular interval. On Infrastructure, M/s. FACOR Ltd. has renovated the existing School building at Ostapal and also provided

solar streetlight and he assured that if requirement of solar streetlight will be more in future then M/s. FACOR Ltd. will provide the same.

Mr. Patra told that community toilet along with solar water facility have been provided at Ostapal & Gurujanga village. He also assured that if any problem facing by any villagers regarding drinking water facility then M/s FACOR Ltd. would resolve the issue. Villagers will get water through pipeline which is under final stage of construction at Ostapal village. Permanent water supply facility has been provided at Bhimtangar village. Further he told that M/s FACOR Ltd. has Mobile Water tanker to provide water to the local people. He informed that cultural activities as per demand of the locals is being promoted and also supported by the company.

He mentioned that dump materials generated from mining operation would be used as backfilling material as per requirement and it would also be used at outside for land development purpose after getting required permission from the concerned authority.

Mr. Patra told that proper drainage system would be provided for better management of water by the unit. M/s FACOR Ltd. will try to provide the ETP treated mine water into the nearby agricultural land for development of farmers.
