PROCEEDINGS OF THE PUBLIC HEARING FOR GANDHALPADA IRON ORE MINE OF M/S TATA STEEL MINING LTD FOR PRODUCTION OF CAPACITY OF 10 MTPA (ROM) WITH TOTAL EXCAVATION OF 18 MTPA OVER AN AREA OF 241.10 HA AT VILLAGE GANDHALPADA, GUALI AND BARPADA HELD ON 10.01.2024 AT 11.00 AM AT VILLAGE GANDHALPADA, KHATA NO. 48, PLOT NO. 194, KISSAM-TAILA(AJA), PROPOSED AREA 1.150 UNDER BARBIL TAHASIL IN KEONJHAR DISTRICT.

The public hearing in respect of the above project was held on 10.01.2024 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Keonjhar welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Ghasiram Murmu, OAS- (SAG), PD, DUDA, Keonjhar presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Subhranshu Shekhar Mishra, Head of mine explained about the proposed project and briefed about the Pollution Control measures to be adopted in the mine.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Keonjhar.

1. Smt. Basmati Munda, Gandhalpada

Smt. Basmati while supporting the public hearing requested employment for both educated and uneducated according to their qualifications and skill level. In her address, she expressed that M/s. Tata Steel Ltd has done many welfare jobs before it came to their locality. She told that in past they needed to travel Joda and Barbil for attending the computer learning classes. But now company has facilitated computer classes in their area. The jobs like construction of changing room, construction of club house, construction of a big meeting hall, construction of school building, imparting training through "Disha" Project etc. has also been done by the Company. She demanded teachers for class VI, VII and VIII as there are no teachers. She also expressed her gratitude to the company for providing ambulance and free medical treatment facility for them. She demanded compensatory afforestation of 10 times more of the trees which will be cut/destroyed for mining operations. She said that company has provided teachers for Adivasi language & culture to the Adivasi Ho Samaj. She requested Tata Steel Foundation for one statue of Dupuk Dastra & Lako Bhodra near Puja Pandal for the Adivasi Ho Samaj. She requested employment and houses for the land losers. Lastly, she said though arrangements have been made for supply of water but they are facing water scarcity since long and there are half-finished roads left for repairing. She requested the company to look after these matters.

2. Smt. Parbati Munda, Gandhalpada

Smt. Munda while supporting the public hearing stated that M/s. Tata Steel Ltd has done many welfare jobs before coming to this place for mining activities. The company has facilitated employability to the SHG ladies by providing paper plate making machine, baadi making machine and so many other facilities to their Panchayat group. So, she is optimistic for more and more such welfare activities by the company in coming future.

3. **Smt. Pritty Barla, Gandhalpada**

Smt. Barla while supporting the public hearing stated that M/s. Tata Steel Ltd has facilitated and helped them for promoting education, agriculture, providing emergency ambulance facility, construction of roads, solar lights. She demanded rehabilitation for those who will lose their land for the said mining operations.

4. **Smt. Moti Munda, Gandhalpada**

Smt. Munda while supporting the public hearing demanded employment for the unemployed youths. In her address she stated that company has done so many things like solar lights, drinking water etc. before it started its mining activities in their locality. She requested for boring of well at Paramsahi, Gandhalpada as there is scarcity of water. She expressed her joy for providing net, water sprinkler cans (Jhara), seeds by Tata Company for vegetable cultivation. The company is also constructing a club house in their area. She requested to place one stone sculpted statue of Birsha Munda near Basanti Puja Pandal for Adivasi Ho Samaj & Ho Munda.

5. **Smt. Sumitra Munda, Gandhalpada**

Smt. Sumitra while supporting the public hearing stated that M/s. Tata Steel Ltd has done many welfare jobs like providing drinking water, solar lights, emergency ambulance facility and club house for SHG ladies before coming to this place for mining activities. She thanked M/s. Tata Steel Ltd for providing the aforesaid facilities.

6. **Smt. Surmani Champia, Gandhalpada**

Smt. Suramani while supporting the public hearing expressed that M/s. Tata Steel Ltd has provided solar lights & medical facilities. She demanded for construction of road near the school and help to SHG ladies.

7. **Smt. Gurubari Munda, Gandhalpada**

Smt. Munda while supporting the public hearing informed that before commencement of mining operations in their area M/s. Tata Steel Ltd has provided bore well for drinking water & solar lights. It has also provided seeds, net and water sprinkler cans (Jhara) for kitchen garden.

8. **Smt. Phulamani Munda, Gandhalpada**

Smt. Phulamani supported the public hearing.

9. **Sri Padan Patra, Ex-Member GP, Guali**

Sri Patra while supporting the public hearing praised Tata Steel Foundation for their welfare activities which have been undertaken much before starting of the mining activities by M/s. Tata Steel Ltd in their locality. He supported the views of his previous speakers about the job done by Tata Steel Ltd like providing ambulance, hospital, roads, communication facilities to school and college going students etc. Thus, he is optimistic and convinced that in future also the company will do many bigger developmental activities in their area. He requested Tata Steel Foundation to

provide employment to the unemployed youths, training to those who have not been imparted training and give priority to the technical skilled youths for employment.

10. **Smt. Sukurmani Munda, Gandhalpada**

Smt. Sukurmani supported the public hearing and stated that in past Tata Steel have done so many jobs in their area, so she has faith that company will extend their help in future too. She regretted that lots of mines has opened in their locality and nobody is providing employment to the village people. As a result, they are compelled to migrate to distant places for earning their livelihood. So, she requested to provide employment to all the poor people of their locality. She said that they have supported various public hearings but in return not getting any job and when approaching their offices they are not heeding them. So she expect both the villagers and the company shall have faith on each other.

11. **Sri Sambhunath Barik, Gandhalpada**

Sri Barik while supporting the public hearing stated that whatever the Authority of M/s. Tata Steel Ltd narrated at the starting of the hearing if they will really follow those things then there will be no sufferings of common people in their village. He submitted a written document.

12. **Smt. Purnima Behera, Gandhalpada**

Smt. Behera while supporting the public hearing expressed that M/s. Tata Steel Ltd has done so many jobs before start of mining operations like providing club house, dug a pond which can be used for any purpose like pisciculture, vegetable farming or duck farming. Company has also started computer classes at Guali Panchayat so that students need not go to Barbil or Joda for computer classes and certificates are being awarded them. Company is also facilitating driving training at Bhubaneswar and HMV license are provided after training at low price. Lastly, she requested Tata Company to provide employment to the local youths, do compensatory afforestation, coaching classes for higher education, provision of scholarship, bus facility for communication, welfare programme for handicapped person, construction of one English medium school and one hospital. She said she is optimistic that company will provide all above said facilities so that they would not face any harassment.

13. **Smt. Gita Patra, Ward No. 7, Guali**

Smt. Patra while supporting the public hearing stated that the company has done so many development jobs before it has come to their area like inauguration of ambulance on 9th January, 2024, provision of solar lights, drinking water and many more. She said they have full faith on Tata Company and requested to conduct Health Camps quarterly once, provide employment to all as per the educational qualifications, construction of road and drains. Lastly, she requested to construct one Laxmi Temple at Ward No.7 in consultation with residents of their Panchayat and provide employment to all of Guali Panchayat spreading happiness among them. Further, requested for compensatory afforestation in 1:10 ratio.

14. **Smt. Sabita Barik, Ward No. 6, Guali**

Smt. Barik while supporting the public hearing requested to repair the road of Ward No. 6 from Baba Sapaneswar Temple to its back side because movement of vehicle and pedestrians becomes very difficult during rainy seasons. Lastly, she requested for streetlights.

15. **Smt. Uma Rani Das, Ward No.7,Guali,**

Smt. Uma Rani while supporting the public hearing but regretted that the married daughters of their village who have returned back to their parents' houses after being harassed/tortured at their in-laws house are deprived of getting a job for maintaining their livelihood due to instigation of certain people of their area. She said they have every right to get a job and maintain their livelihood. She requested Tata Steel to look into this.

16. **Ms. Pallavi Rani Das, Ward No.7, Guali**

Ms. Pallavi Rani while supporting the public hearing demanded employment for the local youths as per their qualifications. She suggested the company shall conduct a survey about dependency of a family on a person for livelihood and accordingly jobs shall be provided to everybody.

17. **Smt. Sasmita Naik, Kendudihi**

Smt. Naik while supporting the public hearing demanded employment for the local youths as per qualifications, construction of toilet and changing room.

18. **Sri Ambika Nandan Patra, , Panduliposhi, Guali**

Sri Patra said he is supporting the public hearing because everybody of their area has got employment in M/s. Tata Steel Ltd and they are able to manage their livelihood, education of their children and living happily. He stated that Tata Steel has also facilitated driving training to him and others of his area to get driving training and HMV license.

19. **Smt. Sasmita Naik, Barpada**

Smt. Sasmita while supporting the public hearing expressed that M/s. Tata Steel Ltd has done many developmental works like providing solar lights, water and has also provided net, water sprinkler cans (Jhara), seeds etc. for SHG ladies in their area before it stepped into this place for mining activities. She is hopeful in future also it will do many such developmental jobs. Lastly, she requested to provide employment as per the qualifications after commencement of mining operations.

20. **Smt. Manju Laguri, Gandhalpada**

Smt. Manju supported the public hearing.

21. **Smt. Biswasi Munda, Gandhalpada**

Smt. Munda while supporting the public hearing stated that M/s. Tata Steel Ltd has provided many facilities and lends help before coming to their place. When her son met with an accident Tata Steel has admitted him at their hospital, provided treatment to her son and took his responsibility till he fully recovered.

22. **Smt. Minati Patra, Guali**

Smt. Patra while supporting the public hearing said that Tata Steel has provided bore well and solar light facilities. She requested for construction of road at their village because they are facing trouble for movement during rain.

23. **Smt. Deepa Barik, Gandhalpada**

Smt. Barik while supporting the public hearing stated that earlier their village was in dark but due to Tata Steel their village could get light. The company has done lot many works and she is hopeful that the company will do many more works in future which is still pending.

24. **Sri Jagabandhu Das, Guali**

Sri Das supported the public hearing because Tata Steel has carried out many developmental works in their village like providing solar lights, bore well, constructed office room in two nos. of schools and has provided ambulance. Further, the company is sending the aspirants for OLC & MRI training. He knows that in future also Tata Steel will give them more chance.

25. **Smt. Binapani Barik, Gandhalpada**

Smt. Barik while supporting the public hearing stated that Tata Steel has done many jobs at their place. She requested to provide employment to all unemployed youths as they will lose lands. She submitted a written document.

26. **Ms. Amulya Naik, Kendudihi**

Ms. Amulya while supporting the public hearing stated that many companies are operating in their Panchayat but Tata Steel has helped them to reduce mother and child mortality rate through Mansi Project which was previously at very higher side in their Panchayat.

27. **Smt. Rinu Naik, Bhuyan Barpada**

Smt. Naik while supporting the public hearing stated that Tata Steel has done many developmental works before it has come to this place. There was no pond in their village but the company has dug two numbers of ponds.

28. **Smt. Sita Naik, Bhuyan Barpada**

Smt. Naik while supporting the public hearing expressed that as per the commitment done during Gram Sabha the company has dug two numbers of ponds. She demanded for tailoring training. She requested to repair the tube well make the water odor free and drinkable and shall modify it to operate it through solar current. She is hopeful and requested for more development jobs in future.

29. **Smt. Nibedita Nag, Kendudihi**

Smt. Nag supported the public hearing because though Tata Steel has not started mining operation in their area but has already provided solar lights, solar borewell, mushroom seeds to the SHG ladies for mushroom cultivation. She requested to provide employment to all unemployed youths as per their qualifications and construct latrine in every house.

30. **Sri Jamadar Munda, Katasahi**

Sri Munda while supporting the public hearing stated that Tata Steel has done many developmental jobs before & after coming to their area. He requested the company to give attention towards

education, health& communication. He demanded for one hospital at Guali Panchayat and a DAV school. He praised Tata Steel for facilitating skill training to drivers and training and other so many developmental jobs. He is hopeful that Tata Steel will do many developmental jobs at both Loidapida and Guali village.

31. Smt. Sambari Purty, Gandhalpada

Smt. Purty while supporting the public hearing stated that Tata Steel has done many works in their area prior to coming to that area like opening a computer center at Guali panchayat so that they need not have to travel to Joda and Barbil for the same. She requested Tata Steel to arrange for coaching classes in their area.

32. Smt. Laxmi Karua, Guali

Smt. Karua while supporting the public hearing stated that before coming to their area Tata Steel has provided mushroom seeds for mushroom cultivation and for developing kitchen garden they have provided net, water sprinkler cans (Jhara), seeds of different vegetables etc. Earlier they were facing acute shortage of water and were dependent upon portable water but now the company has arranged water for them for which she thanked Tata Steel. Lastly, he demanded employment for ladies and gents & compensatory afforestation in the ratio of 1:10.

33. Smt. Jyotshna Karua, Guali

Smt. Jyotshna supported the public hearing because Tata Steel has done many developmental jobs in their area like providing drinking water, solar streetlight, for developing kitchen garden, they have provided net, water sprinkler cans (Jhara), seeds of different vegetables etc. Lastly, she demanded employment for local unemployed youths.

34. Smt. Sukurumani Machua, Guali

Smt. Machua while supporting the public hearing stated that they are facing water scarcity and there is no solar facility. So, she requested to arrange water supply.

35. Smt. Radha Purty, Gandhalpada

Smt. Purty while supporting the public hearing stated Tata Steel has done many things before coming such as education and medical facilities. They have arranged many trainings programme like MRI, OLC etc. in their area. Earlier they need to travel Barbil and Joda for attending a computer coaching class which was very tough for them but after opening of one computer center at Guali Panchayat by Tata Steel they are able to get training locally at low fees. Lastly, she requested to provide employment to the unemployed youths and allowance to elderly people.

36. Sri Dhabaleswar Naik, Bhuyan Rodkolha

Sri Dhabaleswar while supporting the public hearing thanked Tata Steel authority for their contribution towards developmental work for Guali and Loidapada Panchayat. At the same time he requested to sort out water supply issues through solar power system.

37. Smt. Mani Munda, Ward No.2, Kendudihi

Smt. Munda supported Tata Steel because Tata Steel has arranged for education of HO language at their village. She requested to carry forward this initiative effectively so that everybody can get

educated as there is nothing without education. She informed that they have enough land but due to water crisis they are unable to do cultivation because the water storing capacity in the syntax tank is not adequate for their drinking purpose. So, she requested to provide water supply from the nearby river so that then can-do cultivation and earn money.

38. Ms. Magjali Bodra, Gandhalpada

Ms. Bodra supported the public hearing and said that Tata Steel has arranged coaching classes for Class-X students of their village so that they can secure good marks. Tata Steel has arranged for driving training and has provided driving license at low cost. She requested to arrange driving training for ladies too and to provide the license.

39. Smt. Laibani Naik, Barpada

Smt. Naik supported the public hearing because Tata Steel has provided them bore well and dug pond in their village without even any demand from the villagers. She requested for levelling around the pond with provision of pucca bathing ghat. She requested for construction of a bathroom near the bore well at road side, replace the damaged solar lights and provide ambulance for serious patients.

40. Ms. Deepa Naik, Bhuyan Barpada

Ms. Deepa while supporting the public hearing requested to arrange training classes for students and girls. She was happy that youths are getting computer training through computer classes at their Panchayat.

41. Smt. Rahil Purty, Gandhalpada

Smt. Purty while supporting the public hearing requested to provide employment to the local people, repair their dwelling houses and damaged roads.

42. Sri Suren Munda, Gandhalpada

Sri Munda while supporting the public hearing said that Tata Steel has already provided all sorts of facilities but only request is to help his children getting education so that they can have a better future.

43. Ms. Susmita Purty, Gandhalpada Hutting

Ms. Purty while supporting the public hearing stated that Tata Steel has made provision for education and rehabilitation for the poor and destitute children at RPC School at Joda. All sorts of facilities are being provided to them, but people are unable to understand and not allowing their children grab the opportunity even after repeated counselling.

44. Smt. Sumitra Munda, Gandhalpada Hutting

Smt. Munda while supporting the public hearing stated that Tata Steel has been helping them before coming to their place and requested the same after commencement of the mine also. She requested to replace the damage solar lights of Gandhalpada Hutting.

45. **Smt. Sarojini Naik, Barpada**

Smt. Sarojini supported the public hearing because Tata Steel has arranged MRI training at Jamshedpur for girls where they learned many things. Driving training was also organized for girls at Noamundi where the teachers who were in charge of training imparted very good training about driving and shared their story to them too. Girls are doing driving job at Noamundi. So, she requested for sending another batch for similar training from their Panchayat.

46. **Smt. Suru Munda, Gandhalpada**

Smt. Munda supported the public hearing because Tata Steel has been helping them before coming to this place. She requested to develop their village also after starting of the mine. Various training programmes like "Disha" etc. has been organized by Tata Steel.

47. **Smt. Ranjita Naik, Panduliposhi**

Smt. Naik supported the public hearing because before coming to their place for mining operations Tata Steel has started "Mansi" Project for pregnant ladies and newborn babies for which mother and child mortality rate has reduced. She thanked Tata Steel for providing ambulance services to Guali GP. She requested to provide 24 hours medical facility at their Guali healthcare center because they are facing difficulties for travelling to Joda and Barbil for treatment.

48. **Sri Shyama Sundar Das, Katasahi**

Sri Shyama supported the public hearing because not only Tata Steel there are around six to seven mines operating in and around their area but still, he is unemployed. Tata Steel being a very old and reputed company he is hopeful to get a job. Wherever, the company enters the area gets developed. It provides good education facility and make the children educated. He is optimistic that it will bring development and changes in their village with presence of the company. Tata Steel treats equally irrespective of their age. Even though Tata Steel has not started its operation still it has done many things for their place. He is presently 27 years old and he came to know that company has got 50 years lease validity so he hoped that after joining Tata Steel he will give 32 years of services and after that even the company will exist.

49. **Smt. Sisilia Munda, Nuagaon**

Smt. Munda supported the public hearing and stated that company has dug out 2 Nos. of ponds and helping their children for getting education, health care van is also coming weekly once. Physically handicapped people are getting treatment from that and getting recovered. She demanded employment for the unemployed youths, help to the widows and to do pending developmental jobs.

50. **Sri Sunil Champia, Gandhalpada**

Sri Sunil supported the public hearing because three persons of their village has got new life three months before. His brother was one among them. Company had spent around Rs.10 Lakhs for their treatment. He did not spend a single penny for that. He stated that they are Adivasis and depend upon jungle & mountains for their livelihood. They will lose land for this project. So, he requested company to pay fair price to all the land losers. They may be Patta holder or Encroachers. He requested to give transporting and contract jobs to the local Adivasis.

51. **Smt. Deepa Lohar, Guali**

Smt. Deepa while supporting the public hearing stated that Tata Steel has provided many facilities before its presence here. Company has provided facilities like education, health care, water supply, ambulance services etc. She requested for compensatory afforestation in massive way and employment to the unemployed youths.

52. **Smt. Mita Rani Naik, Kendudihi**

Smt. Mita Rani wholeheartedly supported the public hearing because Tata Steel has helped them a lot before coming to their place be it in the field of education, health, drinking water or communication facilities. She requested to provide employment to local unemployed youths as per their skill and qualifications, one bus stand in Guali area and employment of teachers at their schools with respect to strength of students.

53. **Smt. Binapani Mohanta, Katasahi**

Smt. Mohanta while supporting the public hearing expressed that Tata Steel is very good and a big company. It does every task with great responsibility from grass root level to the top level. Many companies deviate from their commitments, but Tata Steel is such a company which keeps its commitment and turn it to reality. She said there is a Government Primary School at Katasahi. The classrooms has got totally damaged and the strength of students is 70. It is very challenging to teach the students in this condition. It has been brought to notice to many of the companies and Govt authorities but of no use. So, she requested the company for immediate repairing of damaged classrooms of the School.

54. **Smt. Pooja Munda, Gandhalpada**

Smt. Munda while supporting the public hearing requested to provide drinking water in their area.

55. **Smt. Sushma Sandil, Gandhalpada**

Smt. Sushma's kept her views in the regional language which was not understood.

56. **Smt. Padmini Mohapatra, Panduliposhi**

Smt. Mohapatra while supporting the public hearing requested for providing teachers as they have only two teachers in the school having classes from Std-I to Std-VIII.

57. **Sri Bajiram Munda, Gandhalpada**

Sri Munda said everybody has said everything, he has nothing to say more. He supported the public hearing.

58. **Sri Binay Munda, Gandhalpada**

Sri Munda kept his views in the regional language which was not understood.

59. **Sri Issac Munda, Gandhalpadha**

Sri Issac while supporting the public hearing said that Tata Steel is providing all the facilities to the village and the Panchayat. He requested the company to overcome his difficulties what he is

personally facing. Further, he requested employment for local unemployed youths as per their qualifications. He submitted an written document.

60. Sri Bikram Champia, Gandhalpada

Sri Bikram said that the drivers and other persons of the village who possess the Heavy vehicle License has not been given any chance of engagement till date.

61. Sri Babulu Munda, Gandhalpada

Sri Munda while supporting the public hearing stated that Tata Steel has done many developmental jobs before it came to their place like providing water supply, construction of changing room, vegetable seeds, net, Jhara etc. He requested to provide more bore well or increase the capacity of syntax tank so that they can water their kitchen garden and to construct pucca bathing ghat at the pond. He also requested to arrange driving training for the left-out aspirants of Gandhalpada.

62. Sri Suren Munda, Gandhalpada

Sri Suren while supporting the public hearing requested to set up one hospital in their area for which he requested the Govt. authority to provide NOC for the aforesaid purpose.

63. Sri Chandan Champia, Gandhalpada

Sri Champia while supporting the public hearing stated that Tata Steel has done many developmental jobs before it came to their place like providing facilities for water supply, solar lights, road, etc. He requested to construct the incomplete roads and provide employment to all after commencement of mining operation.

64. Sri Bhanja Tamudia, Gandhalpada

Sri Tamudia while supporting the public hearing requested to provide employment to the unemployed youth as per their qualifications.

65. Sri Bahadur Soren, Barpada, Mudasahi

Sri Bahadur while supporting the public hearing requested Tata Steel to finish the incomplete works and he hoped the company will carry more and more developmental jobs ahead.

66. Sri Balabhadra Tanti, Guali

Sri Balabhadra while supporting the public hearing stated that people have seen the development of Joda-Barbil area. So, he wishes that their area also needs development at per with Joda-Barbil. He regretted that many company has come to Guali Panchayat area and earned profits, but no development has so far been done in that Panchayat. But he is optimistic that Tata will definitely develop their area in coming days. He told Tata Steel has provided streetlights making the movement ease from one place to another, has provided 4 - 5 bore well in a single ward for water supply through solar system etc. He said education system is very poor over there and it has to be looked after. Those have surplus money could send their child outside for higher education but the poor can't afford it. One income depends totally on the level of education which is very important.

He requested the company to provide employment to one person from every family as per the qualifications.

67. **Sri Kishore Tamudia, Gandhalpada**

Sri Kishore while supporting the public hearing requested to provide employment to the unemployed.

68. **Sri Gora Munda, Gandhalpada**

Sri Munda supported the public hearing.

69. **Master Samura Munda, Gandhalpada**

Master Samura supported the public hearing. He said Tata Steel will provide employment to him after completion of his study and requested to concrete the road leading towards his school as they are facing difficulties to go due to muddy road.

70. **Sri Krushi Munda, Kolharodkala**

Sri Krushi while supporting the public hearing is hopeful for more developmental work from Tata Steel in coming days.

71. **Sri Bajju Munda, Bhuyan Barpada**

Sri Munda kept his views in his regional language which was not understood.

72. **Sri Sunaram Munda, Gandhalpada**

Sri Sunaram while supporting the public hearing requested Tata Steel to start the mine at the earliest so that they can get employment.

73. **Sri Manglu Munda, Gandhalpada**

Sri Munda supported the public hearing because Tata Steel provided them light solar facility etc. and requested to complete the pending jobs like construction of road and supply of water as they are facing water scarcity.

74. **Sri Nanda Munda, Gandhalpada**

Sri Nanda while supporting the Public Hearing requested the company to provide employment to the persons who possess driving license and also employment to the unemployed youths of their locality.

75. **Sri Basanta Kumar Naik, Ward Member, Kendudihi**

Sri Naik while supporting the Public Hearing thanked Tata Steel for taking up many developmental jobs in this area be it education, drinking water, ambulance etc. Classrooms are being constructed as per the requirement and teachers have been provided through "ASPIRE". Drinking water have been supplied to all families living there and Ambulance facility also have been provided. He

demanding one Medical as of like Joda to be set up in their area so that the poor people can avail the treatment. He further requested to provide employment to the unemployed youth as per their qualifications.

76. Sri Chakra Munda, Ward Member, Ward No. 2, Kendudihi

Sri Chakra while supporting the public hearing expressed that Tata Steel is doing many developmental job and he hoped TSL will continue in future also. He demanded for employment and requested to provide solar electricity for the two numbers of Tube well in the Kendudihi village.

77. Sri Siba Lohar, Gandhalpada

Sri Lohar while supporting the public hearing expressed that Tata Steel has provided all facilities to the villagers. He requested for water supply in Hudisahi where they are residing.

78. Sri Samra Munda, Gandhalpada

Sri Munda while supporting the public hearing requested Tata Steel to look after the villagers for employment and livelihood. He further requested the Company to give attention regarding Patta/Jungle land of the villagers which are situated within the leasehold area.

79. Sri Dilip Munda, Gandalpada

Sri Dillip while supporting the public hearing expressed his happiness for this public hearing being conducted for operating of mines by Tata Steel Limited and he hoped that definitely people of this locality will be benefited. He further told that their ancestors were managing their livelihood from the forest product and medicinal plants from this forest area. But now we are handing over this forest to the Company for their Mining and business, in turn, the company has come forward to look after their livelihood and provide employment to them and eradicate poverty in their locality.

80. Smt. Sabhabati Ghana, Guali

Smt. Ghana while supporting the public hearing expressed that the previous speakers have already raised their opinion, and we believe that Tata Steel will keep their faith and will comply to all their issues and requested for employment.

81. Smt. Reenushree Palei, Guali

Smt. Reenshree supported the public hearing and expressed that she hoped that Tata Steel will look after the issues of Education, health and unemployment. Further she told that Tata Steel should arrange for employability of SHG members.

82. Ms. Suchitra Barik, Guali

Ms. Suchitra while supporting the public hearing expressed that earlier there was no facility of computer education in the locality. But now, Tata Steel has provided Computer education center, arranged for MRI training for the students. She requested for employment as per the qualifications and for construction of road from Puja mandap to Golokbihari which is very muddy.

83. Sri Roshan Munda, Gandhalpada

Sri Roshan while supporting the public hearing requested that Tata Steel should give attention to those who have lost their lands for mining purpose. He demanded for employment, massive plantation and fair price in return of their land coming within lease area.

84. Sri Gomeya Munda, Gandhalpada

Sri Munda while supporting the public hearing raised his concern that they are now at a very old age and at this stage where they will go after acquisition of their landed property. Hence, requested the company to provide employment to their son and daughter for their livelihood then to look after the elderly people who have lost their land to the company for mining purpose.

85. Smt. Upashi Naik, Bhuyan Barpada

Smt. Upashi while supporting the public hearing requested for construction of a temple at Bhuyan Barpada.

86. Sri Malay Munda, Gandhalpada

Sri Munda while supporting the public hearing requested Tata Steel to look after the persons who will lose their landed property due to mining operation and provide employment to the youths of their locality.

87. Sri Jata Soren, Bhuyan Barpada

Sri Soren while supporting the public hearing requested for a playground in their village and for construction of road from Ratna Nayak to KJS Ahluwalia Plant route.

88. Sri Ashok Naik, Bhuyan Rodkola, Loidapada GP

Sri Ashok while supporting the public hearing informed that Tata Steel has included Guali and Loidapada Panchayat in the public hearing to give their opinion for which they are grateful to the company. This indicates Tata Steel always act as per the Rules & Regulations of the Govt. He hopes in future Tata Steel will take up many developmental jobs in their area and will provide employment to the youths.

89. Smt. Parbati Naik, Kendudihi

Smt. Naik while supporting the public hearing raised her concern that in the previous hearing she has said that their village is an elephant prone area and to provide streetlight in the road from Panduliposi jungle to Kendudihi River which remains dark during night time. But, no such provision has been done till date. Hence, she requested for streetlight on that road and for employment to the unemployed.

90. Ms. Tapaswini Patra, Guali

Ms. Patra supported the public hearing.

91. Smt. Sushila Naik, Kendudihi

Smt. Naik while supporting the public hearing requested for a Kothighar in their village.

92. **Smt. Hirabati Naik, Kendudihi**

Smt. Hirabati while supporting the public hearing said that there are total eight numbers of SHG in their village and requested for eight numbers of individual halls for them. Further, she demanded for Dharanidhar statue for Bhuyan Samaj and also demanded for employment.

93. **Smt. Sulabhi Munda, Barpada**

Smt. Sulabhi while supporting the public hearing expressed her concern that the students from Mundasahi are not able to go to school due to non-availability of bus. One only one bus is going on that route which is not sufficient for the students. Hence requested for a school bus to be provided by the Company and also demanded to arrange for water supply by providing boring or syntax tank. Further, she demanded employment for the youths so that they can lead better livelihood.

94. **Smt. Binapani Naik, Barpada**

Smt. Binapani while supporting the public hearing requested for construction of drain and changing room.

95. **Smt. Sunita Munda, Kendudihi**

Smt. Munda while supporting the public hearing expressed that there is no water supply and proper road in their village. They are facing difficulties due to muddy road.

96. **Smt. Masuri Munda, Kendudihi**

Smt. Munda supported the public hearing.

97. **Smt. Gita Munda, Gandhalpada**

Smt. Gita supported the public hearing.

98. **Smt. Sukumuti Munda, Gandhalpada**

Smt. Sukumuti supported the public hearing and requested for engagement to drivers and allowance to elderly person.

99. **Smt. Kamali Tuty, Gandhalpada**

Smt. Kamli supported the public hearing.

100. **Smt. Sambari Munda, Gandhalpada**

Smt. Sambari supported the public hearing.

101. **Ms. Sumati Naik, Topadihi**

Ms. Sumati while supporting the public hearing expressed that many people have given their views in the public hearing. As they are Adivasis normally companies easily mould them during the

hearing and then after its completion they don't give any priority to the issues of the villagers. But, Tata Steel has done so many developmental jobs like, road, education etc. As Tata Steel has developed Joda & Bileipada, she hopes for the same in their area. Students are not getting proper higher education after +2 classes due to non-availability of institute for higher education. She requested the company to look after all issues.

102. Smt. Manju Munda, Bhuyan Barpada

Smt. Munda while supporting the public hearing requested for repairing of bore well and Solar system which was provided by the company. Further she requested for employment after commencement of operation of the mine.

103. Smt. Sunei Ghana ,Guali

Smt. Sunei while supporting the public hearing demanded for employment of his grandson and granddaughters and old age allowance to her.

104. Smt. Kanaklata Barik, Guali

Smt. Kanaklata while supporting the public hearing demanded for employment.

105. Smt. Subashini Barik, Guali

Smt. Subhasini while supporting the public hearing demanded for development of their area and for employment to both educated and uneducated youths.

106. Smt. Sabita Barik, Guali

Smt. Sabita while supporting the public hearing was very happy to inform that Tata Steel has been taking up many developmental jobs prior to coming to their place like providing paper machine, baadi making machine to the SHG members, providing training on OLC, Disha etc. Roads, water supply and streetlight has already been provided by the company. She requested for providing additional teachers to their Ashram School wherein Classes from I to VIII are there because at present only two teachers are there.

107. Smt. Gurubari Nag, Kendudihi

Smt. Nag supported the public hearing and requested for electricity connection to their village as they are facing lot of difficulties and their children are unable to study for this.

108. Smt. Binita Gupta, Nuagaon

Smt. Gupta supported the public hearing.

109. Smt. Gurubari Munda, Nuagaon

Smt. Munda said everybody shall study well.

110. Smt. Nandini Patra, Guali

Smt. Nandini while supporting the public hearing requested for employment to all the youths.

111. Smt. Susmita Patra, Guali

Smt. Susmita while supporting the public hearing stated that Tata Steel is has taken good initiatives for development of their area and most appreciable is the arrangement of computer classes for the housewives. Earlier they were not able to come out of house but now they are doing computer classes for which she thanked Tata Steel. She requested for a boring near JSW Mines entry gate which will benefit the villagers.

112. Smt. Geetanjali Patra, Guali

Smt. Geetanjali supported the public hearing.

113. Smt. Ruku Behera, Guali

Smt. Ruku while supporting the public hearing demanded for employment for both educated and uneducated youths irrespective of rich and poor.

114. Sri Juria Munda, Gandhalpada

Sri Munda while supporting the public hearing raised his concern about one existing perennial stream at Nuagaon. The water flow of the stream is getting less day by day due to deposition of silt from mining operation. Tata Steel has already planned how to take care of that perennial stream. He requested the Government to rejuvenate the same. He further appreciated Tata Steel for taking up so many developmental jobs in their area. He told that some people of their area have obtained training for HMT at Chatia and requested TSL to impart further training which will help them to get employment in the mine.

115. Sri Maheshwar Ghana, Katasahi

Sri Ghana while supporting the public hearing requested for a DAV School, One Medical and employment to the youths of their area coming within 8-10 KM distance as per their qualifications. Further, he said that everybody demanded for employment but behavioral improvement is most important. People should avoid taking duplicate alcohol. If they take alcohol then they may not get medical fitness certificate which will deprive them from getting job. He emphasized that everybody should change their attitude and focus on their work. Whatever job they get as per their qualification should do it wholeheartedly.

116. Smt. Manjulata Barik, Nuagaon

Smt. Barik registered her name in the next no. but spoke before. While supporting the public hearing she raised her concern many companies have failed to keep their commitment and village Nuagaon is still kept neglected. Be it healthcare, water supply or electricity. She said many companies are harassing the candidates and requested Tata Steel should not repeat it and shall take care of it. Further, she demanded that employment should be provided to the youths of their area as per qualifications who have freshly completed their education.

117. Sri Mansingh Munda, Nuagaon

Sri Munda said he is not denying to support Tata Steel and he has always supported the company. But he raised his concern about environment. He questioned the Govt. Authorities what is

important for sustainability of mankind, jungle or mines. If mining will be carried out by deforestation then pollution level will increase or decrease was the question raised by him to the Authority of SPCB, Odisha.

118. Sri Bidyadhar Naik, Sarpanch, Guali GP

Sri Naik while supporting the public hearing expressed his happiness and express that Tata Steel has fulfilled all the commitments and hoped in future also the Company will continue its developmental jobs. The company is constructing roads for them. He requested for employment as per the qualification and eligibility as unemployment is a great problem in their area.

119. Sri Gajendra Barik, Gandhalpada

Sri Barik while supporting the public hearing appreciated that the way Tata Steel is doing developmental jobs here, till now no Company has done such jobs. He said since his childhood he is seeing Tata Steel taking initiatives to do new things, introduce new technology etc and Tata is well known to everybody for its developmental work. He told the company has not started operation yet so it will not be justified to say to fulfill all the demands and to give employment. He further informed that all their demands cannot be fulfilled at a time. It is a 50-year project and phase wise definitely company will fulfil their demands. Any question for employment etc, should not be raised right now. In future it will be seen. He said that they will be homeless once mining will start and they don't not where they will settle. He left the decision in the hand of Tata Steel. He requested for part manual mining so that the uneducated youths can also be engaged.

120. Sri Tusharkanta Naik, Naib Sarpanch, Loidapada GP

Sri Naik regretted that even though lots of mines & industries has opened in their area but so far, no such exemplary CSR activities or peripheral development has been observed in Bhuyan Rohkola. He said that as Tata is known to everybody for its developmental work so he is supporting the public hearing only with a condition that if they will fail they will protest against the company.

121. Ms. Bilasini Oram, Sarpanch, Loidapada

Ms. Oram while supporting the public hearing requested Tata Steel to give more attention towards education, healthcare and all kinds of CSR jobs. She requested to open an English Medium School and extend 24X7 medical facilities. She also requested to take adequate measures to control pollution and to give right attention toward aspiration and expectation of their people.

122. Smt. Bimala Naik, PS Member, Guali GP

Smt. Naik while supporting the public hearing stated that Tata Steel has done many jobs before coming to this area and she is hopeful in future also it will carry on similar activities. She requested to give attention toward aspiration and expectation of their people. Lastly, she requested for employment as per the qualification and eligibility.

123. Smt. Padmabati Naik, Ex-Sarpanch, Guali GP

Smt. Padmabati while supporting the public hearing stated that Tata Steel has many jobs before coming to this area. Company has constructed one new primary school at Gandhalpada and thanked for providing one life support ambulance to their Panchayat. She requested for

employment to youths as per the qualification and eligibility and provide manual mining job to the unemployed people.

124. Smt. Sunita Naik, Loidapada GP

Smt. Naik while supporting the public hearing informed that company has awarded Jyoti Fellowship stipend to 130 students of Katasahi area. Company is also giving more attention for developing agriculture at Kulho Rodkola. As part of this activities Tata Steel has arranged training on greenhouse i.e. Krishi Bigyan programme on agriculture to Sri Jairam Munda and given advice for their progress. Plants were also distributed by the company in Kulho Rodkola. Tata Steel is supporting SHG ladies of Katasahi for mushroom cultivation for maintaining their livelihood.

125. Ms. Dasmita Patra, Guali

Ms. Dasmita while supporting the public hearing stated that Tata Steel has many jobs before coming to this area and she hoped in future also company will carry on such activities.

126. Smt. Rangabati Palei, Nuagaon

Smt. Palei while supporting the public hearing regretted that many young boys are under the influence of alcohol and harassing their SHG ladies. So, she requested to give employment to ladies so that selling of rice wine can be controlled and the young boys will not remain unemployed which will bring peace in Guali area. Ideas to be given to SHG ladies to become independent and maintain livelihood. She requested for coaching classes & teacher so that their children can get educated. She said they don't need a company like JSW who tortured their people and did not heed to any of their issues. She requested the company to provide facilities as the ladies are willing to do cultivation be it crop or vegetables. She demanded Tata Steel should take full responsibility for education of the children as they are very poor to afford the expenditure required for education. She requested for some remuneration to the destitute elderly people for purchase of medicines. She requested to arrange a Tungi where Bhagwad Gita and other educative things will be discussed to make people educated. She said Tata Steel has done many developmental works before coming to their area and compared Tata Steel with God 'Ram' and said that now God Ram has come in the form of Tata company to spread happiness on each and everybody face.

127. Ms. Suman Munda, Guali

Ms. Suman while supporting the public hearing informed that many people has kept their opinions. Regarding education Tata Steel has done many things like providing financial support in education through Jyoti Fellowship to the low caste and poor students. Regarding pollution control measures to be adopted by the company she said the company is always taking measures to minimize pollution and suggested everybody to work hand in hand with Tata Steel to take measures for controlling environmental pollution. And regarding help to SHG ladies she advised all to be always supportive to the company and to try for implementation so that every work can be easily carried out and their life style can be changed.

128. Sri Tapan Kumar Naik, Bhuyan Rodkola

Sri Tapan supported the public hearing and stated that as Tata Steel has developed other areas likewise it should develop their areas. He requested for strengthening education system, provide medical facilities and jobs to everybody.

129. **Sri Prasant Palei, Guali**

Sri Prasant while supporting the public hearing expressed that before manual mining was carried out and slowly everything is getting upgraded and now mining has been mechanized. The company is going to get clearance for 18.0 Million Ton so there will certainly have impact on environment due to movement of heavy vehicles when mining operation will start which need to be controlled. He said definitely people will lose job due to mechanized method of mining. So, he emphasized on skill development workshop and training for the local youths as per their skill, qualifications and strength to do various jobs in the mining machineries.


130. **Sri Rabindra Kumar Naik, Panduliposhi, Guali GP**
