At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Sri Santosh Kumar Pattanaik has proposed to have Environmental Impact Assessment for mining lease area of 12.2099 ha. for production of Construction Stone @ 20,025 cum/Annum at Laxmipur village, Sheragada Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner -

- Advertisements through an Odia Daily "The Sambad" dated 09.12.2023 and an English Daily "The New Indian Express" dated 09.12.2023 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur and Department of Forest, Environment & Climate Change Govt. of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Alarigada Gram Panchayat, Dayanidhipur Gram Panchayat, Kurula Gram Panchayat, Block Development Office, Sheragada in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar to kindly preside and supervise in the public hearing.

The Sub-Collector-cum-Sub-Divisional Magistrate, Bhanjanagar welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects.

The Regional Officer, State Pollution Control Board, Berhampur asked the project proponent give brief about the project along with its impact on environment and its mitigation. Sri Santosh Kumar Pattanaik, Project Proponent & Sri Samir Kumar Sahu representative of project proponent presented the salient features of the proposed Laximipur-B-Stone Quarry, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing.
