OFFICE ORDER

The Government of India vide its Taxation Laws Amendment Act.2017, has abolished the water (Prevention & Control of Pollution) Cess Act 1977, effective from date of implementation of GST i.e 1st JULY 2017. Therefore in view of abolishment, the Water Cess shall not be assessed and collected for period 1st JULY 2017 onwards.

However it is clarified that the water cess dues of the period prior to abolition of water (PCP) cess Act 1977, i.e 30th June 2017 is to be collected and all the Regional Officers shall verify the return of water cess for the entire pending period up to June 2017 and also furnish reports immediately to ensure the collection of water cess dues up to 30.06.2017 from all qualifying assesses.
