KIND ATTENTION OF ALL MUNICIPAL AUTHORITIES

This is brought to the notice of all municipal authorities that as per sub Rule-6 (c) (vii) of **Plastic Waste (Management and Handling) (Amendment) Rules, 2011**, the municipal authority shall be inter-alia responsible to ensure that open burning of Plastic waste is not permitted.

It may be mentioned that open burning of plastic releases toxic fumes and causes severe air pollution and therefore cannot be accepted as a means of disposal.

Instances of open burning of plastic waste in violation to the provisions of aforesaid Rules has come to the notice of this Board.

It may be noted that violation of the provisions of Plastic Waste (Management and Handling) (Amendment) Rules will entail criminal action under Section-15 of the Environment (Protection) Act, 1986.

The Municipal authorities, may therefore ensure that compliance to the above provision of Law is strictly adhered to.
