ATTENTION: ALL SOLID WASTE GENERATORS, URBAN LOCAL AUTHROITIES, VILLAGE PANCHAYATS OF CENSUS TOWNS AND URBAN AGGLOMERATIONS AND GENERAL PUBLIC

This is to bring to the notice of all concerned including general public that Hon'ble National Green Tribunal, Principal Bench, New Delhi in their order dt. 22.12.2016 in the matter of OA. NO. 199 of 2014, Almitra H. Patel Vs. Union of India & Others issued comprehensive direction for effective implementation of Solid Waste Management Rules, 2016 by all concerned and further specifically directed for complete prohibition on open burning of waste on lands, including at landfill sites. For each such incident or default, violators shall be liable to pay environmental compensation of Rs. 5, 000/- (Rs. Five Thousand only) in case of simple burning, while Rs. 25, 000/- (Rs. Twenty Five Thousand only) in case of bulk waste burning. Environmental compensation shall be recovered as arrears of land revenue by the competent authority in accordance with law.
