## PUBLIC NOTICE

## KIND ATTENTION: ALL HEALTH CARE ESTABLISHMENTS (HCEs) OF THE STATE OF ODISHA

Attention of all the Occupiers of Bedded Health Care Establishments (HCEs) in the State of Odisha is drawn to the provision under Section- 10 of the Bio-Medical Waste Management Rules, 2016 and amended thereafter which stipulates that "Every occupier or operator handling bio-medical waste, irrespective of the quantity shall make an application in Form II to the prescribed authority i.e. State Pollution Control Board and Pollution Control Committee, as the case may be, for grant of authorization and the prescribed authority shall grant the provisional authorization in Form III and the validity of such authorization for bedded health care facility and operator of a common facility shall be synchronized with the validity of the consents".

Hence all the bedded HCEs are required to apply to the State Pollution Control Board, Odisha for grant of consent to operate under Section-25/26 of Water (Prevention and Control of Pollution) Act, 1974 through online system within one month time from the date of publication of the notice. The application for consent to operate online can be made by accessing to Board's website (www.odocmms.nic.in).

It may be noted that failure to comply with the above shall amount to violation of the provisions under Water (PCP) Act, 1974 and punishable under the said Act.
