RE-CONSTITUTION OF TECHNICAL COMMITTEE FOR ISSUE OF "NO INCREASE IN POLLUTION LOAD CERTIFICATE" FOR CHANGES IN PLANT CONFIGURATION AND PRODUCT MIX FOR THE PROJECT OR FOR THE CHANGE IN RAW MATERIAL-MIX OR PRODUCT MIX, CHANGE IN QUANTITIES WITHIN PRODUCTS OR NO. OF PRODUCTS ON THE SAME CATEGORY ETC. UPTO 50% INCREASE IN CUMULATIVE PRODUCTION.

In pursuance of decision taken in 121st Board meeting held on 15.10.2020 and in supersession of Office Memorandum No. 10320 dtd. 2.8.2017, the Technical Committee with the following members is hereby re-constituted to examine the application and make recommendations for issue of "No Increase in Pollution Load Certificate" for changes in plant configuration and product mix for the project as per MoEF&CC, Govt. of India Notification vide SO 3518(E) dated 23.11.2016 and for the change in raw material-mix or product-mix, change in quantities within products or no. of products in the same category etc. upto 50% increase in cumulative production as per MoEF&CC, Govt. of India Notification S.O. 236(E) dated 16.1.2020.

Terms of Reference:

- The proceedings of the committee will be approved by the Chairman and to be issued by the Member Secretary. "No Increase in Pollution Load" certificate will be issued by the Member Secretary.
- 2) The Technical Committee shall examine the applications and reports regarding "No Increase in Pollution Load" for changes in plant configuration and product mix for the project and for the change in raw material-mix or product-mix, change in quantities within products or no. of products in the same category etc. upto 50% increase in cumulative production.
- 3) The Technical Committee after proper appraisal of the application shall submit its report along with recommendation to the SPC Board for consideration of certificate regarding "No Increase in Pollution Load" as required under MoEF&CC, Govt. of India Notification No. S.O. 3518(E) dated 23.11.2016 and Notification No. S.O. 236(E), dated 16.1.2020.
- 4) The Members nominated by F&E Department will be paid sitting fees of ₹ 3,000/- per day for attending the meeting.
- 5) The Members nominated by F&E Department during their stay at Bhubaneswar will be paid ₹ 4,000/- per day towards their boarding, lodging and local transport expenses.
- 6) The Members nominated by F&E Department are eligible to reimburse actual travelling expenses on production of tickets and also get DA as per rule. Those who travel by taxi will be paid on production of bills or as per the rate approved by Govt. in Tourism Department whichever is less.
- 7) In case if it is decided to have a site visit before making recommendation, the members nominated by F&E Department will be paid travel expenses including D.A. as per rule. SPC Board shall arrange local conveyance, accommodation including fooding. Further, they will be paid a sum of ₹ 1000/- per day as a part of sitting fee for technical inspection / evaluation of the site.
- 8) Member Convenor shall ensure the copy of the information is made available to all the members sufficiently in advance.
- 9) The Technical Committee shall make recommendation based on the deliberation.
