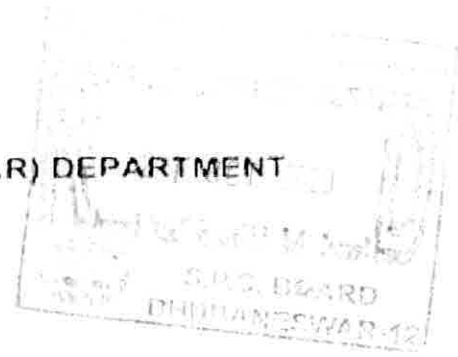

## OFFICE ORDER

### TIME LINE FOR DISPOSAL OF APPLICATION FOR AUTHORIZATION / RENEWAL UNDER "E - WASTE MANAGEMENT RULES, 2016"

E - Waste Management Rules, 2016 was notified by MoEF & CC, Govt. of India vide G.S.R. 338 (E), dated 23.03.2016 in supersession of E - Waste (Management and Handling) Rules, 2011. This Rule stipulates that authorization / renewal shall be granted by the Board within a period of 120 days with effect from the date of receipt of application, complete in all respect.

The Industries Department, Govt. of Odisha has taken initiatives to facilitate the industries and also to substantial contribute towards Business Improvement Rank of the State. Under the "State Reforms Action Plan", a number of reform areas have been identified. One of the area is authorization / renewal under E - Waste Management Rules, 2016.

Considering the necessity of faster disposal of authorization / renewal application in order to regulate the management of E-Waste in the State, the time limit for disposal of application for authorization / renewal under E - Waste Management Rules, 2016 is hereby fixed as 90 days with effect from the date of receipt of online applications complete in all respect against the statutory period of 120 days.


