OFFICE ORDER

A. In pursuance of decision taken in 121st Board meeting held on 15.10.2020 and in supersession of office order no. 12547, dated 20.07.2015 and office order No. 355, dated 08.01.2019, the Consent Committee is hereby reconstituted with following members:

3.	External expert members to be nominated by the Chairman of the Consent Committee in specific cases, if required.	Member
4.	Secretary, Industries Department, Govt. of Odisha or his representative not below the rank of Deputy Secretary.	Member

B. Terms of Reference:

- Industrial / Mining projects as indicated in the office order for delegation of power issued vide no. 2347/IND-II-NOC-Misc-170, dated 06.03.2019 and as amended time to time will be placed before the Consent Committee before grant / refusal of Consent to Establish.
- The proceedings of the Consent Committee will be approved by the Chairman and to be issued by Member Secretary. Consent to Establish will be issued by the Member Secretary.
- The Chairman of the Consent Committee may nominate external expert members from the sectoral experts of the respective Technical Committee in specific cases, if required.
- 4. The project having an investment of Rs. 1000 crore or more and mining projects with lease hold area of 1000 ha. or more shall be evaluated by the Consent Committee along with the sectoral expert of the Concerned Technical Committee. The provision of separate evaluation by the Technical Committee has been dispensed with.
- The sectoral expert members coming from outside the States are eligible to reimburse actual traveling expenses on production of tickets and the DA as per rule. In case of journey by Air, the expert members shall be made for economy class fare.
- 6. The sectoral expert members coming from inside the State are eligible to reimburse actual traveling expenses on production of tickets and also get DA as per rule. In case of journey by Air by the sectoral expert members payment shall be made for economy class fare. Those who travel by Taxi will be paid on production of bill or as per the rate approved by Govt, in Tourism Deptt. whichever is less.
- 7. The Board will arrange conveyance for the sectoral expert members of Bhubaneswar for attending the meeting and back.
- 8. The sectoral expert members will be paid sitting fees of Rs.3000/- per day for attending the meeting.
- The sectoral expert members during their stay at Bhubaneswar will be paid Rs. 4000/per day. No other allowance / reimbursement is admissible.
- 10. In case it is decided to have a site visit of the project before making recommendation they will be paid travel expenses including DA as per rule. Board shall arrange local conveyance, accommodation including fooding at or near the project site. Further the members will be paid a sum of Rs. 1000/- as a part of sitting fee for technical inspection / evaluation of the site.
