#### B. Terms of Reference:


1. The project having an investment of ₹ 1000 crore or more and mining projects with lease hold area of-1000 ha. or more shall be, evaluated by the Consent Committee along with sectoral expert of the concerned Technical Committee.
2. The sectoral expert of the concerned Technical Committee shall make an environmental appraisal of the proposed project at the initial stage on the basis of the Project report (in case of the industrial project), Mining Plan (in case of mining project) and Environmental Impact Assessment (EIA) / Environment Management Plan (EMP) submitted by the project proponent.
3. The project proponent shall make a presentation on their project including the Environmental Impact Assessment (EIA) / Environment Management Plan (EMP) before the sectoral expert of the concerned Technical Committee at the time of Consent Committee meeting.
4. The sectoral expert of the concerned Technical Committee after going through the reports and the presentation by the project proponent, shall recommend best management practice, appropriate technology for pollution control and make suggestions regarding stipulations of standards for the proposed project, so that the environmental quality of the area around the proposed project is protected.
5. Member convenor of the Consent Committee shall ensure that copy of Project report / Mining Plan and Environmental Impact Assessment (EIA) / Environment Management Plan (EMP) (either soft copy / hard copy) is made available to sectoral expert of the concerned Technical Committee sufficiently in advance.


