OFFICE ORDER

TIME LINE FOR DISPOSAL OF APPLICATION FOR AUTHORISATION UNDER SOLID WASTE MANAGEMENT RULES, 2016

Municipal Solid Waste (Management) Rules, 2016 stipulates that authorization, renewal authorization shall be granted by the Board within a period of 60 days with effect from the date of receipt of application, complete in all respect.

The Industries Department, Govt., of Odisha has taken initiatives to facilitate the industries and also to substantial contribute towards Business Improvement Rank of the State. Under the "State Reforms Action Plan", a number of reform areas have been identified. One of the area is authorization / renewal under Solid Waste Management Rules, 2016.

Considering the necessity of faster disposal of authorization / renewal application in order to regulate the management of Solid Waste in the State, the time limit for disposal of application for authorization / renewal under Solid Waste Management Rules, 2016 is hereby fixed as 45 days with effect from the date of receipt of online applications complete in all respect against the statutory period of 60 days.






