## **OFFICE ORDER**

## PROCESSING OF CONSENT APPLICATIONS IN RESPECT OF CLARIFICATIONS RAISED IN OCMMS PORTAL OF THE BOARD

State Pollution Control Board is processing the Applications for Consent (Consent to Establish and Consent to Operate) and Authorizations (Hazardous Waste; Bio-Medical Waste; E-Waste; Plastics; Municipal Solid Waste; Lead Acid Battery) under Online Consent Management System (<a href="https://www.odocmms.nic.in">www.odocmms.nic.in</a>) developed and maintained by NIC.

The Consent and Authorizations are being disposed of in a definite timeline as per ORTPS Act 2012. The timeline, as stipulated under ORTPS Act is calculated from the date of the application duly made by the proponent and complete. The application accompanied with adequate fee and necessary documents are considered as duly made. Thereafter, the applications are examined for completeness of information. In case of incomplete information, clarifications are sought from the proponents to make the application complete. The ORTPS Act timeline starts from the date of the application is duly made and complete.

The checklist of the documents, which would be required by the State Pollution Control Board for consideration of the application as "Duly made" is available on the website of the Board (<a href="www.odocmms.nic.in">www.odocmms.nic.in</a>). The information required to make the application complete shall be raised through queries/clarifications.

It is observed that some of the proponents are making considerable delay in submitting clarifications to the queries resulting in increase of number of pending applications in OCMMS Portal of the Board. The long pending list of applications on account of delay in submission of clarifications by some of the proponents are hampering the processing of genuine applications and displaying a wrong picture of applications pending with the Board. It is anticipated that, some of the proponents might not be further interested in the applications submitted by them.

In order to streamline the applications submitted in OCMMS Portal, and provide due weightage to the genuine applications made with due diligence, it is hereby decided that in case the reply to queries are not received on Online Consent Management System (OCMMS) within 60 days from the date of raising queries to the proponents, the proposal will be delisted from the pendency list of the OCMMS Portal.



However, the project proponents can relist the proposal by requesting the State Pollution Control Board, Odisha through their respective login provisions, as and when they want to submit the reply. The date of submission of reply to the satisfaction of the Board will be treated as date of complete application.

This order will come into force with immediate effect.
